Mr. Wenzel recalled Ordinance No. 1341 was pulled and not enacted and further stated Mr. Baggot was incorrect that Ordinance No. 1341 or No. 1452 were in violation of any law. Mr. Wenzel clarified that his name was on the purchase of two properties as an attorney for the Township of Little Falls. Mr. Baggot discussed the removal of trees on Paterson Ave.

<u>Peggy Olivi-</u> On behalf of the Little Falls Historical Society, commented on the time capsule on the cornerstone near the PNC property. The Historical Society acquired the rights to the time capsule and on Sunday, April 23, 2023 the time capsule will be unsealed at 2pm at the Civic Center.

<u>Andrew Baggot</u> – Requested a full reading and explanation of Ordinance No. 1450. Council President SGOBBA stated Mr. Baggot will have the opportunity to be heard during the public hearing portion of the Meeting.

The Mayor discussed that as time has passed and the Township has been able to monitor neighboring communities that allow the Class 5 license, he proposed future discussion to determine if the Council wanted to entertain the Class 5 license along Route 46 zone. Council President SGOBBA encouraged Councilmembers to research the topic.

Andrew Baggot- In response to Mr. Baggot, Mr. Wenzel explained the way the Ordinance is written, if an individual is moving items in and out of the location, they would be in compliance with the Ordinance. Council President SGOBBA noted the space was designated in response to business owner complaints. Mr. Wenzel reiterated the purpose of a normal loading zone is meant for the activity undertaken by that vehicle onloading or offloading goods. Mr. Baggot expressed concern regarding parking for his tenants to which Councilmember VANCHERI responded. Mayor Damiano explained why a parking spot could not be placed in front of the bus stop. Mr. Kobylarz confirmed that with the new alignment parking would not be allowed on the southerly side.

Marianne Baggot – commented on her concerns about losing parking spaces in front of her building. Council President SGOBBA discussed the widening of the sidewalk and the supply of a municipal parking lot where tenants can park. Councilmember MURPHY stated that he and Councilmember Patel had requested a public safety report going back five years in that area, noting one bus accident had occurred in that time, which did not indicate a public safety hazard in that intersection. Mayor Damiano summarized the factors that went into the development of the Ordinance and that it was not an easy decision. There are two lanes of travel with one side parking and in order to maximize parking, in consultation with the Engineer, the decision was made to have parking on the north side as the only real option to accomplish that goal.

COUNCIL TOPICS FOR DISCUSSION

Councilmember HABLITZ thanked the Library for hosting START, an animal rescue and adoption weekend. Upcoming Library events included voting for your favorite Peeps diorama through April 22nd, National Library Week, the Cookbook Club on April 24th, and the celebration of Earth Day on April 22nd with plant propagation with Master Gardener Pete Tomasi. On April 22nd, the Earth Day shredding and electronic recycling event will be held at Town Hall, along with the DEA National Take Back safety disposal of unused medications hosted by the Police Department. Lastly, Councilmember HABLITZ provided details of the First Annual Bike Rodeo scheduled for May 6th.

Councilmember MURPHY highlighted Domestic Violence Prevention Committee potential fundraising events including a Dine and Donate at local restaurants, partnering with local salons, and a potential corn hole or pickleball tournament. On April 29th Passaic County Domestic and Sexual Violence Walk will take place at Garret Mountain. He discussed the introduction of Ordinance No. 1458, advertisement for the Township calendar, and encouraged business to participate. Lastly, Councilmember MURPHY questioned whether it would be possible to host Planning Board meetings in a hybrid format similar to Council Meetings. Council President suggested a discussion with the Planning Board President.

Councilmember VANCHERI announced Heroes in Training has commenced, a track and field program run by Passaic Valley High School for 3rd to 8th grades. Additionally, baseball and softball teams will hold their opening day parade this Saturday and PVHS will hold their Annual Autism Awareness Walk on April 23rd. Councilmember VANCHERI then provided an update on events planned for Memorial Day weekend. Councilmember VANCHERI highlighted recent responses to resident issues brought forth and addressed by Mr. Campbell and Mr. DiMaria, Chief Prall and Officer Pinnola, Commission Bartlett, and the Historical Society. Councilmember VANCHERI also discussed a resident who had reached out about the 9-11 Survivor Tree Seedling Program. Regarding a Transportation Committee update, discussion occurred regarding speed humps on Houston Road and addressing the speed limit on County roads to be consistent with a 25 mph speed limit. Lastly, Council President SGOBBA invited resident Tom Barone to provide details of the World Series of Birding event his will be participating in on May 13th.

Council President SGOBBA requested chairpersons of the various Township Committees who would like to have new members on their committees, to please submit names to the Council President who will vet them, and then place them on the Agenda. Council President then announced the Senior Advisory's Spring Fling will be held on April 22nd.

Mayor Damiano discussed concerns of traffic, specifically near the Route 23 and Main Street intersection. After two years, significant timing changes were made to the traffic controller, which he hoped would result in significant traffic flow through that area. The Mayor noted Union Avenue and Stevens Avenue will continue to be monitored, while the DOT continues to monitor Route 23 and will tweak the timing if needed.
