REGULAR MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, August 10, 2015

Council President Louis Fontana called the meeting to order at 10:17 p.m. with the following members present: James Damiano, William Liess, Joseph Maceri and Pamela Porter. Also present were Mayor Darlene Conti, Township Attorney Leslie London, Township Engineer Dennis Lindsay, Municipal Clerk Cynthia Kraus and Township Administrator Charles Cuccia.

Absent: None

Township Employees absent: DPW Superintendent Phillip Simone, Deputy Registrar Marlene Simone

Following the Salute to the Flag, the Statement of Public Notice was read.

REMARKS FROM CHAIR

Council President FONTANA encouraged everyone to come out for the Labor Day Picnic at American Legion Post #108 in Singac.

COUNCIL MEMBER REPORTS

Councilmember DAMIANO reported the Grant Committee convened and recommended hiring a grant writer on contingency for those grants outside the purview of our professionals. Discussion of this is to be placed on next Workshop agenda. The Committee also requested the Council's judgment on the addition of a wet park, such as that in Woodland Park, which could be funded by county and municipal open space funds. The Committee also obtained a list of items requested by Mr. Pace for parks and recreation such as handicap accessible bleachers. Councilmember DAMIANO stated the Transportation Committee convened and the status of the bus shelters is now under NJ Transit. He will provide updates as information becomes available. The Committee also touched upon partnering with MSU to enhance pedestrian safety and enrolling in the Street Smart program. Finally, the Committee proposed the institution of a truck size ordinance to prohibit larger trucks from using Little Falls streets as through streets, except for deliveries.

Councilmember MACERI responded that several items discussed at the Grant Committee meeting fall under open space grants, which Mr. Lindsay has had experience in obtaining. He expressed the expense of hiring an outside grant company may be more costly. Councilmember DAMIANO added the Grant Committee intends to acquire priority lists from Department Heads. In response to Councilmember MACERI, he explained that while Mr. Lindsay is proficient in writing grants, some may not fall within the realm of his experience. Mr. Lindsay agreed and highlighted those areas of which he has had experience. Additionally, Councilmember DAMIANO stated the potential to secure more grants should outweigh the cost.

Councilmember MACERI proclaimed the Little Falls traveling softball league was a great success. He thanked the Recreation, DPW, Police and Fire departments for all of their help and representation. He relayed that Police Chief Dmuchowski has announced his retirement and wishes him the best.

Councilmember PORTER announced the Enterprise Picnic will be held at St. George's Church this week. ABC Farmers Markets and concerts are successful. She thanked Mr. Pace for the summer camp program. The Passaic County Fair at Garrett Mountain Park includes a Passaic County Baseball History Bus Tour on Saturday, 8/15 and on Sunday, 8/16, there will be a working tour of the Paterson Court House and Historic District.

Councilmember LIESS reported the Regional Flood Board will not convene until September.
