#### SALUTE TO THE FLAG

Following the Salute to the Flag, Council President SGOBBA requested a moment of silence for the passing of Senator John McCain.

#### REMARKS FROM CHAIR

Council President SGOBBA thanked all the Township employees, Councilmembers, and the Mayor, who provided assistance during the recent flooding incident.

#### **COUNCIL MEMBER REPORTS**

Councilmember VANCHERI remarked on the life and recent passing of John McCain.

Councilmember LIESS reported the Senior Advisory Board is working on ideas for seniors in the upcoming months.

Councilmember CORDONNIER thanked Sargeant Gianduso, OEM Coordinator, and members of the Office for Emergency Management for their coordinated efforts in helping those affected by the flood. She also thanked Bob Dombrowksi for representing St. Agnes outreach efforts to help those in need.

Councilmember SEBER expressed her gratitude and pride for those who helped individuals and the community at large.

### MAYOR'S REPORT

Mayor Damiano thanked the We Love You Foundation for all of their assistance during the past few weeks following the flood. The Mayor invited representatives of the Foundation to the podium and extended a heartfelt thank you on behalf of the Council and residents to the membership for their hard work and hours of assistance provided to residents in need.

Mayor Damiano remarked on the passing of Senator John McCain and announced the flag will be placed at half-staff. The Mayor thanked all those in Little Falls who were instrumental in helping the residents affected by the flood, including the Police Department, Fire Department, to the DPW Department. The Fire Department was responsible for assuring the safety of 45 individuals pulled from their homes on August 11, 2018. The Police Department secured the areas that were affected. The DPW was involved in the initial evacuations and garbage removal in the aftermath. The Office of Emergency Management, headed by Sergeant Gianduso, made sure everyone had enough cleaning supplies and had somewhere to stay that was cool. The Mayor thanked the Council for taking on a task to help and assist the residents. The Mayor also thanked Mr. Cuccia, Mrs. Kraus, and Mrs. Simone for acquiring the emergency appropriations and for all their assistance on the municipal side.

#### DISCUSSION OF STOP SIGN PLACEMENT AT UNION AVENUE AND RAILROAD AVENUE

The Mayor stated there is no stop sign at the end of Railroad or Union Avenues, posing a safety concern. The Mayor recommended an ordinance be introduced to add a stop sign at the end of Railroad Avenue to allow those traversing down Union Avenue to have the right of way. The Mayor added the stop sign placement should be on Railroad Avenue as it is owned by the municipality. He also requested this issue be moved on quickly. Councilmember

#### PUBLIC COMMENT -GENERAL MATTERS

The Council President declared the motion passed.

Phyllis Dillon, 25 Riker Avenue, expressed concern regarding the repair of the rear steps to the Civic Center in time for the Harvest Moon Dance. Mayor Damiano replied that the Township applied for a Community Block Development Grant (CDBG) to enhance ADA accessibility to the entries of the Morris Canal and the Civic Center. CDBG grants are generally awarded in October at which point the Mayor described the potential timeline should an award be given. Action may not occur until the spring of 2019. In response to Council President SGOBBA's query, Mayor Damiano indicated the estimates submitted with the grant application were approximately \$250,000. In response to Councilmember Seber, Mayor Damiano indicated the deadline for the grant was March 31st.

<u>Deborah Minardi</u>, 14 Sindle Avenue, cited an issue of a neighbor renting to a MSU students and possible living conditions that may be illegal. Mayor Damiano stated he forwarded the complaint to the Building Department and an investigation has been undertaken.

<u>Dan Isku</u>, 76 William Street, stated he experienced his first flood on August 11, 2018. He would like to know what resources he could receive to restore his home and prevent future flooding. Mayor Damiano explained the municipality itself does not have funds available to help individual property owners. The Township continues to look for the federal government to declare Little Falls and the surrounding communities a disaster area, such that the federal government can then send funds to our municipality. He emphasized that the FEMA threshold is difficult to reach. While the Mayor noted he will continue to work towards this goal, he encouraged Mr. Isku to reach out to FEMA directly. The Mayor also instructed that a homeowner can always elevate his or her home, however, this is an expensive option. Mr. Wenzel then indicated his request to speak to Mr. Isku after the meeting.

<u>Bob Dombrowski</u>, 3 Garden Street, discussed the Brookside stream which flows under Main Street. Mayor Damiano recounted a prior discussion with Mr. Simone, who had indicated how much water pump stations received during the rain of August 11, 2018. Some stations took in two to four times the amount of water they were engineered to manage. The infrastructure throughout the State is not made to handle that type of rain in a short period of time.

<u>Luis Fernandez</u>, Harrison Street, requested the threshold amount for Little Falls to receive FEMA funding. Council President SGOBBA stated the formula does not only include Little Falls, adding the Township does not set the guidelines. Mr. Fernandez questioned the involvement of the Governor and Senators. Council President SGOBBA noted Senator Corrado and Assemblymen Rooney were both here. Mayor Damiano added he received calls from Senator Menendez, Senator Booker, and Congressman Pascrell, who all were willing to help the Township get funding. Mr. Fernandez complimented the DPW Department on a great job cleaning up after the recent flood, and queried how long the dumpsters will be available to residents. The Mayor responded that the dumpsters will be removed this week from all locations in the Township. However, as residents continue to clean up, debris will either be picked up with normal collection or for a larger collection, the DPW can be contacted to pickup.
