Mr. Fernandez inquired about Mr. Sweezy and questioned whether residents would be given more information once litigation is complete. Council President SGOBBA responded the Council is not able to discuss personnel matters. Mayor Damiano added no taxpayer's money has been affected at this time. #### ITEMS TO BE DISCUSSED:

MAYOR/ADMINISTRATOR: Mayor Damiano reported on a productive meeting held with the Fire Department to review the proposed Ordinance. On August 17, 2021 the Mayor announced he will hold a Town Hall with a focus on development in the Township, however, all questions are welcome.

- 1. RESOLUTION ADOPTING 2021 PERSONNEL POLICIES AND PROCEDURES MANUAL Mayor Damiano explained the Manual is updated yearly. The most major change has to do with legalization of cannabis and which employees are allowed or not permitted to use cannabis whether on or off duty in their role as a municipal employee. The document is posted on the Township website and is available in the Clerk's Office.
- 2. RESOLUTION AUTHORIZING PLACEMENT OF "DO NOT BLOCK THE BOX" SIGNAGE AND STREET MARKINGS AT VARIOUS LOCATIONS – The Mayor provided background of the statute and explained the resolution authorizes placement of signage as well as road markings. Councilmember VANCHERI thanked County representatives, the Police, and DPW Departments for their work to bring this resolution to fruition. Mayor Damiano highlighted the nine roads where "Do Not Block the Box" locations are being proposed.
- 3. RESOLUTION AUTHORIZING A CONCESSION FOR ACQUISITION AND CONSTRUCTION OF SCORE BOARDS AT THE LITTLE FALLS SPORTS AND RECREATION COMPLEX - Mayor Damiano discussed the improvements of new scoreboards in and outside of the Recreation complex. He explained the concession that will allow the Township to open the concession and ask for there to be contributions made for advertisements, which will offset the cost of the scoreboards.

### **RESOLUTION [B] 21-08-09 - #2**

RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS, IN THE COUNTY OF PASSAIC, STATE OF NEW JERSEY, TO AUTHORIZE THE PLACMENT OF "DO NOT BLOCK THE BOX" SIGNAGE AND STREET MARKINGS AT VARIOUS LOCATIONS

WHEREAS, the Municipal Council of the Township of Little Falls ("Council") has found that there are several intersections of roadways within the Township of Little Falls ("Township") that experience high levels of vehicular traffic; and

WHEREAS, due to the aforementioned traffic, vehicles remain stationary for a period of time within the intersection area which results in delays to those vehicles attempting to traverse the intersection, which effectively causes a further increase in traffic; and

WHEREAS, in accordance N.J.S.A. 39:4-67, it is violation of law for any vehicle, as defined by statute, to block, obstruct, impede or delay the regular flow of traffic through intersections; and WHEREAS, in order to effectuate the statutory goal, the Council pursuant to its general police powers now seeks the installation of such

signs and roadway markings to advise drivers against blocking or interrupting the flow of traffic through an intersection; and WHEREAS, the intersections identified below have been reviewed and identified through the Township Police Department and in

consultation with the Township Chief of Police; and NOW THEREFORE BE IT RESOLVED by the Township Council of the Township of Little Falls, as follows:

- "DO NOT BLOCK BOX" signage and roadway markings shall be placed so that drivers coming into the intersections listed herein are so advised to avoid blocking, obstructing, impeding or delaying the flow of traffic:
  - Jacobus Avenue and Long Hill Road
  - Browertown Road and East Main Street
  - Hopson Avenue, Cedar Grove Rd and East Main Street
  - Arlington/Main

- Montclair Avenue and Main Street
- Union Avenue and Main Street
- Center Avenue and Main Street
- Arlington Street and Main Street
- Van Pelt Place and Main Street
- Signage and street markings shall be in accordance with applicable laws and regulations or other guidelines promulgated by State or 2) Federal departments and/or agencies.
- The Township Administrator shall effectuate the purposes of this Resolution to procure such materials in accordance with applicable 3) law and regulation and assign such tasks as may be required.
- A copy of this Resolution shall be transmitted to the County of Passaic.
- This resolution shall take effect immediately.

# RESOLUTION OF THE TOWNSHIPSHIP OF LITTLE FALLS, COUNTY OF PASSAIC, STATE OF NEW JERSEY, AUTHORIZING A CONCESSION FOR THE ACQUSITION AND CONSTRUCTION OF SCORE BOARDS AT THE LITTLE FALLS SPORTS AND RECREATION COMPLEX

WHEREAS, the Township has a desire to provide for a proper score boards for youth and adult sports at the Little Falls Sports and

Recreation Complex as a concession; and

WHEREAS, such acquisition is currently available to be provided through a competitive quotes (in lieu of formal public bidding) under the New Jersey Local Publics Contract Law, N.J.S.A. 40A:11-4.1(j).; and

WHEREAS, the Township desires to evaluate such service offerings from Vendors within the procedures as set forth in the New Jersey Local Publics Contract Law (N.J.S.A. 40A:11-4.1 et. seq. and N.J.A.C. 5:34-4 et. seq.,) of Price and Other Factors; and

WHEREAS, the Township desires to conduct the concession selection process in order to obtain the best provider, to be awarded based upon the most advantageous price and other factors; and

WHEREAS, the estimated value of the concession in the aggregate is not expected to be in excess of the Townships bid threshold [required per N.J.S.A. 5:34-9.4(d)(2)(iv)]; and

WHEREAS, the costs to be incurred for the advertising of the concessions are minimal, related only to the competitive contracting

WHEREAS, the Township desires to enter into a year to year extension contract for up to five (5) years that will satisfy the needs of the Township renewable for an additional year to year extension contact of up to another five (5) year period; and **WHEREAS**, as per statute the process will be administered by the Qualified Purchasing Agent (N.J.S.A. 40A:11-4.5(d)); and

WHEREAS, as per statute the concession has been approved in writing as legal by the Township Attorney (N.J.A.C. 5:34-9.4(d)). NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Little Falls, County of Passaic, State of New Jersey, as follows:

- 1. That the Qualified Purchasing Agent be and herby is authorized to advertise for and receive responses for the concession of the acquisition and construction of various score boards at the Little Falls Sports and Recreation Complex.

The Passaic Valley UNICO will hold a flag raising on Monday, October 4, 2021 for Italian Heritage Month. She thanked Councilmember VANCHERI for his comments regarding social media. Lastly, the Green Fair will be at the Farmers Market on September 12, 2021.
