REGULAR MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, December 29, 2014

Council President Louis Fontana called the meeting to order at 7:31 p.m. with the following members present: John Vantuno, Pamela Porter, William Organisciak, and Joseph Maceri. Also present were Mayor Darlene Post, Township Attorney William Northgrave, Municipal Clerk Cynthia Kraus and Township Administrator Charles Cuccia

Following the Salute to the Flag, the Statement of Public Notice was read.

Councilmember PORTER agreed that Mr. Muoio was a wonderful man. She stated that two councilmembers have completed their term and thanked them for their service. She wished everyone a happy and healthy New Year.

Councilmember MACERI thanked Councilmembers Organisciak John Vantuno for their service.

Councilmember ORGANISCIAK thanked everyone present. He noted he was grateful to be able to serve the community and has become more educated in the process.

Councilmember VANTUNO declared it has been an honor and a privilege being a Councilman. He was surprised to see how big of a job it was and stated there are some great people working in the town. He thanked the Council for the opportunity to serve.

MAYOR'S REPORT

Mayor Post informed the Council the Fire Department held their annual meeting on December 11, 2014. She congratulated all voted into their respective positions. She attended a senior luncheon on December 11, 2014, in addition to attending the holiday parties and the CERT team meeting. On December 20, 2014 children from Schools 1 and 3 came to Town Hall to carol. She announced the reinstatement of the Mayor's Ad Hoc committee, which examines issues related to redevelopment and the transit committee. She expressed her condolences to the family of John Muoio, chief of Fire Company #3 and a member of The American Legion. She wished all a happy and healthy New Year and thanked the outgoing Councilmen for their service.

Kathleen Thomas, 75 Parkway, expressed concern regarding closure of the Tax Office the last two weeks of the year as it has led to disruptions in proceeding with short sales of property before December 26, 2014. A second property is slated to be closed on tomorrow, and she requested the Council resolve this issue. An email has been sent to the Council regarding the Tax Office regarding this.

WHEREAS, the Township of Little Falls (the "Township") is a municipal corporation of the State of New Jersey authorized under the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. ("Shared Services Act") to enter into an agreement with other local units to provide jointly (or through the agency of one of them on behalf of the other) any service which such entity may legally perform for itself; and

WHEREAS, in the spirit of mutual cooperation, the Township and the Borough of Totowa ("Totowa") and the Borough of Woodland Park ("Woodland Park," together with the Township and Totowa, the "Parties") seek to jointly purchase, use and maintain a 4-ton Falcon RME Asphalt Recycling Hot Patcher Dump Trailer (the "Equipment") for the purpose of reducing each Party's respective expense for the repair of local roads; and
