The Mayor then recognized Cpl. Pinnola for spearheading the Police Department's receipt of the AAA 2023 Community Traffic Safety Gold Award. Council President SGOBBA commented on the significant reduction of speeding concerns in the Township since 2016. Mayor Damiano added comments regarding how instrumental Cpl. Pinnola and the implementation of the complaint portal have been in addressing concerns.

ITEMS TO BE DISCUSSED: MAYOR/ADMINISTRATOR:

- 1. RESOLUTION INSTITUTING A MORATORIUM OF THE ISSUANCE OF CLASS 5 RETAIL CANNABIS LOCAL LICENSES IN THE TOWNSHIP Mayor Damiano explained that as there have been concerns regarding the number of licenses that would be permitted in the municipality, this resolution would limit the number of Class 5 licenses.
- RESOLUTION SUPPORTING THE DRIVE SOBER OR GET PULLED OVER 2023 YEAR END HOLIDAY CRACKDOWN - Mayor Damiano explained the Police Department's initiative and that the Township has received a grant. Chief Prall then noted in comparison to last year, the Township has had close to 60 arrests compared to 40 last year. The State will fund 100 hours of additional patrols from December 1st to January 1st. In response to Council President SGOBBA, Chief Prall commented on demographic trends.

Moratorium of Issuance of Class 5 Retail Cannabis Local Licenses

RESOLUTION [A] 23-12-04 - #1 TOWNSHIP OF LITTLE FALLS RESOLUTION INSTITUTING A MORATORIUM OF THE ISSUANCE OF CLASS 5 RETAIL CANNABIS LOCAL LICENSES IN THE TOWNSHIP OF LITTLE FALLS

WHEREAS, the Township of Little Falls has authorized and issued one (1) Class 5 Retail Cannabis Licenses in the Township of Little Falls; and

WHEREAS, the Township of Little Falls finds that this action shall now create a new business venture never before operated in the Township in compliance with the laws and regulations of the State of New Jersey and the applicable Township Code; and WHEREAS, the Township of Little Falls has determined that an appropriate amount of actual operational experience is needed to

evaluate the impact of this business on Township as a whole: **NOW, THEREFORE, BE IT RESOLVED** by the Governing Body of the Township of Little Falls that it is necessary and

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Township of Little Falls that it is necessary and appropriate to institute a moratorium for remainder of the 2023 year for the issuance of any additional Class 5 Retail Cannabis Local Licenses in the Township of Little Falls. By maintaining the status quo for issuance of such licenses, until such time as appropriate evaluation and consideration of the retail operation can be made by the Township Council to determine if amendments should be considered to the Code of the Township of Little Falls:

BE IT FURTHER RESOLVED that during the period of the moratorium, the Township shall endeavor to review, and study the impact of this retail operation on the services and security of the Township, its residents and taxpayers. In the event that the Township determines to lift this moratorium, that action will be made by formal resolution of the Governing Body, at which time all matters related to the process of issuing a Class 5 Retail Cannabis License shall be transacted in accordance with the Township Code.

BE IT FURTHER RESOLVED by the Governing Boody of the Township of Little Falls that to the extent that any law, ordinance, rule or regulation are in conflict with the provisions of the resolution, this resolution shall control.

Supporting Drive Sober or Get Pulled Over Year End Crackdown

RESOLUTION [B] 23-12-04 - #2

Resolution Supporting the Drive Sober or Get Pulled Over 2023 Year End Holiday Crackdown

WHEREAS, approximately one-third of all fatal traffic crashes in the United States involve impaired drivers; and

WHEREAS, impaired driving crashes killed 11,654 people in the United States in 2020; and

WHEREAS, impaired driving crashes cost the United States almost \$44 Billion a year; and

WHEREAS, during the past five years New Jersey's roadways experienced 33,798 crashes and 662 fatalities involving impaired drivers; and

WHEREAS

WHEREAS, an enforcement crackdown is planned to combat impaired driving; and

WHEREAS, the year-end holiday season is traditionally a time for social gatherings which include alcohol; and WHEREAS, the State of New Jersey, Division of Highway Traffic Safety, has asked law enforcement agencies throughout the state to participate in the *Drive Sober or Get Pulled Over 2023 Year End Holiday Crackdown*; and

WHEREAS, the project will involve increased impaired driving enforcement from December 1, 2023 through January 1, 2024; and **WHEREAS**, an increase in impaired driving enforcement and a reduction in impaired driving will save lives on our roadways;

THEREFORE, be it resolved that the Township of Little Falls declares it's support for the *Drive Sober or Get Pulled Over 2023 Year* End Holiday Crackdown from December 1, 2023 through January 1, 2024 and pledges to increase awareness of the dangers of drinking and driving.
