WORKSHOP MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, December 6, 2021

Council President Sgobba called the meeting to order at 7:00 p.m. with the following members present: Christine Hablitz, Albert Kahwaty, and Christopher Vancheri. Also present were Mayor James Damiano, Township Engineer Tom Lemanowicz, Township Administrator Charles Cuccia, Deputy Clerk Melissa DePiro and Township Clerk Cynthia Kraus.

Absent: Councilmember Tanya Seber and Township Attorney Joseph Wenzel.

Township Employees present: None.

The Council President declared the motion passed.

<u>Luis Fernandez</u>, 54 Harrison Street, discussed his viewpoint on the upcoming school referendum emphasizing his opposition until the flooding issues in the Township are addressed. Council President SGOBBA reminded Mr. Fernandez the referendum is under the purview of the Board of the Education. Mayor Damiano agreed with Mr. Fernandez's comments regarding the Township's flooding stigma and the importance of the flood tunnel to address flooding issues in the Township. Mayor Damiano added that on December 13, 2021 a meeting with NRCS (Natural Resources Conservation Service) will occur to discuss funding for stabilization of the Peckman River. Mr. Fernandez also made comments regarding a previous meeting pertaining to how Council President SGOBBA was addressed.

<u>Rick Mieses</u> - 79 Cedar Grove Road, thanked the Council, Mayor and DPW for efforts made to stabilize the riverbank near his home and questioned whether an inspection of the riverbanks would occur with the NCRS. Mr. Mieses also queried what preventative actions would be taken to prevent future flooding and requested the Township's assistance to obtain a response from the County regarding a drainpipe on his property that flows into County property. Mayor Damiano did not have specific information regarding an inspection but obtained Mr. Mieses' permission should an inspection occur with NCSR. Mayor Damiano discussed the Regional Flood Board and the use of the trackhoe. The Mayor indicated he will discuss the issue of the drainpipe with both the County and NCRS.

Robert Doeg – 168 Wilmore Road, commented on the successful Tree Lighting, echoed Mr. Mieses' sentiments regarding the riverbank, and thanked the Township for moving forward with flood mitigation with the NCRS. Mr. Doeg questioned the participation of Cedar Grove and Verona regarding the Regional Flood Board. Mayor

Damiano discussed previous and current positions of Cedar Grove and Verona with regard to flooding, noting both municipalities have had Salamone Brothers address their riverbanks.

RESOLUTION [E] 21-12-06 - #5

A RESOLUTION TO AFFIRM THE TOWNSHIP OF LITTLE FALLS' CIVIL RIGHTS POLICY WITH RESPECT TO ALL OFFICIALS, APPOINTEES, EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTERS, INDEPENDENT CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO CONTACT WITH MUNICIPAL EMPLOYEES, OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of the Township of Little Falls to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of the Township of Little Falls has determined that certain procedures need to be established to accomplish this policy

NOW, THEREFORE BE IT ADOPTED by the Township of Little Falls that:

Section 1: No official, employee, appointee or volunteer of the Township of Little Falls by whatever title known, or any entity that is in any way a part of the Township of Little Falls shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Township of Little Falls' business or using the facilities or property of the Township of Little Falls.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any

volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Township of Little Falls to provide services that otherwise could be performed by the Township of Little Falls.

Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions

contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

Section 4: The Mayor or Administrator shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

Section 6: The Mayor or Administrator shall establish written procedures that require all officials, employees, appointees and volunteers of the Township of Little Falls as well as all other entities subject to this resolution to periodically complete training concerning their

duties, responsibilities and rights pursuant to this resolution.

Section 7: The Mayor or Administrator shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

Section 8: At least annually, the Mayor or Administrator shall cause a summary of this resolution and the procedures established

pursuant to this resolution to be communicated within the Township. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Township's web site.

Section 9: This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Township of Little Falls in order for the public to be made aware of this policy and the Township's commitment to the implementation and enforcement of this policy.

COUNCIL TOPICS FOR DISCUSSION

Councilmember KAHWATY expressed his gratitude for everyone's condolences in memory of his late father. He extended his congratulations to the Super Bowl champions and those athletes recognized tonight. Councilmember KAWATY discussed the success of the Tree Lighting, announced the Little Falls Business Association will host a breakfast with Santa and holiday party at the library, and reminded everyone to shop local this holiday season.

Councilmember HABLITZ highlighted events occurring as part of the Little Falls Biz Holiday Party at the Library this Saturday. Commencing January 5, 2022, the Library is starting a teen advisory board for those in grades 6-12, and from December 1-22, 2021 the Food for Fines program will occur. Lastly, Councilmember HABLITZ detailed the First Annual Light Up Little Falls contest run through the Recreation Center and Farmers Market.

Councilmember VANCHERI discussed efforts of the Flood Board, and collaboration with nearby towns as well as Congresswoman Sherill and Congressman Pascrell to address flooding of the Peckman and Passaic Rivers. Councilmember VANCHERI reviewed installation of the speed humps on Van Pelt Place and Jacobus Avenue. Councilmember VANCHERI then detailed the PBA's annual Breakfast with Santa at PVHS on December 11, 2021. He provided a follow-up report on issues raised by Mr. Fernandez at a previous Meeting regarding parking and signage as well as compliance issues of a property owner.

Council President SGOBBA announced there will be a Senior Holiday Luncheon on December 8th and the Senior Advisory Board will hold their annual Holiday party on December 17, 2021. Council President SGOBBA announced the Reorganization Meeting will be held on January 4, 2022 and starting in January 2022 meetings will be on YouTube and no longer be presented in a hybrid format.
