# ORDINANCE NO. 1477 ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS IN THE COUNTY OF PASSAIC, STATE OF NEW JERSEY, AMENDING THE TOWNSHIP CODE CHAPTER 71 FEES

WHEREAS, the Township of Little Falls ("Township") is a public body corporate and politic of the State of New Jersey; and WHEREAS, the Township's Code of General Ordinances ("Code") currently provides for the regulation of its Fees in the Township; WHEREAS, the municipal council ("Municipal Council") of the Township has determined to amend Chapter 71 of the Code entitled

#### Fees; and

WHEREAS, the Municipal Council has determined to amend said Chapter of the Code as follows:

71-2 Fees Schedule Chapter 143 Parks and Recreation Facilities

#### Farmers Market Vendor Fees:

At the discretion of the CFO, annually. Full Time Vendor (All 24 Markets): \$25 - \$45 Per Market Part Time Vendor (11-23 Total Markets): \$30 - \$50 Per Market Guest Vendor (1-10 Total Markets): \$35 - \$55 Per Market

Farmers Market Tote Bag Sponsorship Fees: At the discretion of the CFO, annually

Planter: \$100 - \$500 (First 12 Markets) Harvester: \$100 - \$500 (Second 12 Markets)

# 136. XI. Consistency, Severability and Repealer

(A) If any provision or portion of a provision of this ordinance is held to be unconstitutional, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the ordinance shall not be invalidated.

(B) All ordinances or parts of ordinances, which are inconsistent with any provisions of this ordinance, are hereby repealed as to the extent of such inconsistencies.

(C) No provision of this ordinance shall be construed to impair any common law or statutory cause of action, or legal remedy there from, of any person for injury or damage arising from any violation of this ordinance or from other law. NOW, THEREFORE, BE IT ORDAINED by the Municipal Council of the Township of Little Falls, Passaic County, State of New

Jersey, as follows:

- The aforementioned recitals are incorporated herein as though fully set forth at length.
- The Municipal Council hereby amends Chapter 71 of the Code entitled Fees of the Code of the Township of Little Falls. It is the intent of the Municipal Council to incorporate the additions and/or supplements contained in this Ordinance in to the Code. All of the remaining provisions in Chapter 71 of the Code entitled Fees of the Code shall remain unchanged and 2 3. have full force and legal effect. All other ordinances enacted and inconsistent herewith are hereby modified pursuant to the terms of this Ordinance.
- If any section, paragraph, subdivision, clause, sentence, phrase or provision of this Ordinance is declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance. 4.
- A copy of this Ordinance shall be available for public inspection at the offices of the Township Clerk. 5. This Ordinance shall take effect after twenty (20) days of its final passage by the Municipal Council, upon approval by the 6 Mayor and publication as required by law.

# COUNCIL TOPICS FOR DISCUSSION

Councilmember VANCHERI expressed his condolences on the passing of Sheriff Berdnik. Councilmember VANCHERI announced the Township will host its first ever Ramadan lighting ceremony on March 9th at Wilmore Park. A food collection will also be taken up with donations to go to St. Agnes. In response to resident input, Councilmember VANCHERI discussed the possibility of re-evaluating the length of parking time allotments allowed on Main Street. Council President SGOBBA reminded to take into consideration that some business on Main Street may take longer than two hours.

Councilmember MURPHY provided a status report on the Township calendar and noted the Domestic Violence Prevention Committee Meeting will be on Zoom due to the impending storm. The Domestic Violence Prevention Committee is also considering conducting a Dine to Donate fundraiser with more information forthcoming.

Councilmember HABLITZ thanked the Council for providing the \$500 for the ROID grant. She then commented on Library events including Love Your Dog with Treats, and the presence of the Passaic County Clerk's office to provide services such as notary and Veteran IDs. Councilmember HABLITZ announced Wilmore Park demolition is slated to begin in the next two weeks and should be completed by the end of April. Lastly, Councilmember HABLITZ noted that planning has begun for this year's Farmers Market which will begin May 19<sup>th</sup>.

Councilmember PATEL reviewed upcoming events provided by the Clifton Health Department including a free dental clinic for children under the age of 18. The Clifton Health Department will also be at the Library as a resource for patrons on February 22<sup>nd</sup>. Lastly, a presentation on heart health will be held at the Library on February 20<sup>th</sup>.

Chief Prall commented on the passing of Joseph Coyle and highlighted his service to the Police Department.
