ORGANIZATION MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, January 3, 2011

Township Clerk William Wilk called the meeting to order at 7:03 p.m. with the following Council members present: Louis Fontana and Joseph Sisco. Also present were Council members-elect Mercedes Gonzalez, Darlene Post and John Vantuno. Also present was Mayor Michael DeFrancisci.

Absent: Township Attorney Joseph Trapanese, Township Engineer Dennis Lindsay and Township Administrator Matthew Kazmierczak

At this time, Councilmember FONTANA recognized Senator O'Toole, Assemblyman Rumana and William Marotta, who were all in attendance.

Following the Salute to the Flag, Deacon Joseph Sisco gave the invocation.

PRESENTATION OF EMBLEM OF AUTHORITY was presented to Council President Fontana by Donald Radcliffe of the Little Falls Republican Club.

At this time, Council President FONTANA invited Mayor DeFrancisci to join the Council at the dais.

REMARKS OF MAYOR DEFRANCISCI

Mayor DeFrancisci congratulated the new Council members and said it was an honor to preside over the meeting with the Council President.

Good evening and welcome to our 2011 reorganization meeting. I would like to especially thank Judges Ravin and Corradino for being here and assisting us in administering the oath of office to our newly elected council members and Senator Kevin O'Toole and Assemblyman Scott Rumana for being here also. I would also like to recognize and thank Randy Bush for being here to support Council President Lou Fontana.

On the heels of one of the most powerful snow storms in history, last week criticisms were heard from the many towns about their emergency response. I was very happy to see that I only received one negative comment and many thank-you's from our residents. It is a testament to our employees that work every day to make Little Falls a better place to live. Whether floods or snow we do the very best possible for our residents and I am proud to lead such a dedicated group of people. However the work has just begun. This council tonight will begin a journey that started a few years ago in this very room, on a night similar to this. When Councilman Fontana and I took our oaths of office we promised to do things differently, fairly and with one thought in mind: To fulfill our obligations to the people that put us here. We have certainly accomplished much in that short period of time. At times it wasn't easy or simple and certainly as the minority, regardless of what we asked, our requests were sometimes ignored or blocked. Well as the saying goes, the shoe is now on a different foot. That does not mean that I expect this council to sit idly by and agree with all my decisions. What I do expect of them, no, require of them, is to do what they promised they would do; work with me to make this a better municipality.

No doubt as you entered tonight you saw the progress we are making. One year from today we hopefully will be occupying a new municipal complex that will house all of the administrative functions of our Government including a new police and courts facility. We have benefited from Open Space monies that were never applied for in the past and improvements to our recreation facilities will be funded without asking our residents for any new tax revenue. An economic development committee has been meeting for well over a year and I am excited about the progress they are making. There is a movement that many do not see to help reinvigorate our town and one that has taken on a momentum all its own.

While all of these steps are positive, we will be met with unprecedented economic challenges – challenges that are long overdue at both the state and local levels. Our Governor has the fortitude and insight to stand up to the special interests. The 2% spending cap that all 566 municipalities must abide by will force us to do things differently. Well I am happy to say that

my administration began to make these changes before the cap was enacted. Several months ago I signed a cooperative agreement with eight other municipalities in Passaic County to purchase our electricity in aggregate. Our cost savings alone will be approximately \$31.000 this year. I asked Matt Kazmierczak, our administrator to initiate a study of our insurance coverage's and am happy to report that by changing our joint coverage, and returning to a provider that is more accessible, we will save approximately \$15,000 this year. I also initiated a change in our Health Department shared services contract and by joining with the City of Clifton; we will save approximately \$27,000 dollars. Personnel changes are continually being evaluated and where full time positions can be consolidated to part-time one's that has been done too. I will continue to search for ways to lessen our government and provide the services that our residents count on but we are limited in these cost savings measures.

Other changes need to be considered. Many of those that start here, but must be changed in Trenton.

With the continued assistance of Senator O'Toole and Assemblyman Rumana I will continue to challenge the status quo. Antiquated laws such as the 72 year old statute that allows counties to only pave their roadways and ignore the curbs placing the burden on the townships must change. At the same time I recently requested from the NJ League of Municipalities their support in studying the laws that mandate us to fund in our case, Passaic County, ten million dollars and growing, yearly from Little Falls. How can we be expected to provide those amounts when at the same time we run the entire town on only twelve million dollars per year? We simply can no longer sustain these mandates.

Increasing revenues are harder and harder to find and in the past we have missed the ability to be decisive and act. Progress does not always come from committees. It comes from making hard decisions and not shying away from difficult tasks. I would ask this council to finally re-zone the Rose Street property, list and post for sale one of the largest Township owned properties we own. A property worth millions of dollars in income as well as one that will provide a continuing tax ratable. At the same time I would implore you to move quickly on the Billboard Ordinance that is now at the planning board. Again, this sole piece of legislation has the ability to bring in hundreds of thousands of dollars to our Township, but needs to be done now. There is more, but none more important that the two that I have just mentioned.

Ladies and Gentleman of the council I look forward to working together with you this year and in the future. We have much to do and I have all the confidences in you to work together with me. God Bless this great Country and our Township. Thank You

REMARKS OF COUNCIL PRESIDENT FONTANA

Council President FONTANA thanked his wife, children and family. He also thanked Randall Bush for issuing him the Oath of Office. He congratulated Council members Gonzalez, Post and Vantuno. He also thanked Councilmember Sisco for serving as the Council President over the last year, adding that he has always offered a calm and level-headed voice. He thanked the new Council for selecting him to lead the Council this year. He explained that the first priority of this Council will be to work with the Mayor to make sure the Budget is as tight as it can be, and also to bring more ratables into town. He assured that they would be coming up with new ideas for ratables within the next few meetings. As with past Councils, this Council will continue to work on the flooding issues in Little Falls and our entire region; they hope to see a time when there is no more flooding. He informed that he would take on recreation as his own project, noting that this subject routinely frustrates him. However, he assured that he will continue to move forward in trying to make our parks and fields the safest and highest quality possible. Pointing out that there is a lot of good going on in town, he asked that more of those things be brought to Council Meetings.

Councilmember SISCO congratulated the new Council members, as well as Council President Fontana. He is looking forward to working with everyone this year and moving forward. He offered his support to the new Council.

Councilmember GONZALEZ thanked everyone who gave her the opportunity to serve the Township of Little Falls. She is looking forward to working with the residents to make Little Falls a better place.

Councilmember POST thanked Judge Corradino for administering her oath, and also thanked everyone else who was in attendance this evening. She is looking forward to working with everyone and getting the job done.

Councilmember VANTUNO thanked everyone for their support, and said it is a privilege and an honor to be serving the Township of Little Falls.

BE IT RESOLVED by the Township Council of the Township of Little Falls that the following policy be and is hereby established for conduct

- of the Public Portion and Public Hearings at all Regular and Special Township Council meetings:

 1. Except as provided in items 4 and 5 below, any member of the public wishing to address the Township Council during the Public Portion of a meeting shall be allotted a period of time not to exceed https://documents.org/december 2.5 minutes total for the evening, regardless of the number of subjects the speaker addresses at any one meeting.
- To simplify timekeeping, members of the public shall not leave and return to the microphone but shall include all topics they wish to cover, other
- than agenda items already listed for public hearing, in a single address to the Township Council, except as provided in items 4 and 5.

 3. Any member of the public wishing to address the Township Council during a public hearing on any scheduled agenda matter including, but not limited to, public hearings on pending Township ordinances, shall be allotted a period of time not to exceed three (3) minutes total, except as provided in items 4 and 5 below.
- Any member of the public wishing to address both unscheduled and agenda matters at a single meeting shall be heard on unscheduled matters
- during the Public Portion and on agenda items at the publicly-announced appropriate time, but shall be limited to a total of three (3) minutes on all subjects.

 5. At the discretion of the Council President, or any other Township Council member presiding in the Council President's absence, an additional two (2) minutes may be allotted to a member of the public, for a total not to exceed two (5) minutes for any one speaker during any one meeting.

WHEREAS, the Township of Little Falls is a member of the New Jersey Intergovernmental Insurance Fund ("NJIIF"); and WHEREAS, the NJIIF has determined that it is reasonable and necessary to develop a standard form and procedure by which persons are required to notify members of the NJIIF ("Members") of claims which arise under the authority of N.J.S.A. 59:1-1 et seq. ("Tort Claims Act"); and WHEREAS, the Tort Claims Act at N.J.S.A. 59:8-6 authorizes Members of the NJIIF to develop and adopt forms specifying information to be contained in claims filed against them or their employees and which forms claimants are required to complete and submit in order to perfect their notification obligations under the Tort Claims Act; and

WHEREAS, for purposes of developing a uniform system for investigating and responding to potential claims, the NJIIF is requiring that its Members adopt a standard cover letter and claim notification form to be used by the Members in matters arising under the Tort claims Act.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Council of the Township of Little Falls that the Township does hereby approve and adopt for its use the standard cover letter and notice forms prepared by the NJIIF, attached hereto as Exhibit A, which forms the Township will require all persons claiming injury or damage under the tort Claims Act to complete and return to the Township in order to perfect their notification requirements under the Act.
