ITEMS TO BE DISCUSSED:

MAYOR/ADMINISTRATOR:

- 1. RESOLUTION APPROVING EXTENSION OF 2023 1ST QUARTER TAX GRACE PERIOD As a courtesy to the taxpayers, Mayor Damiano explained the extension of the tax quarter beyond the 10th of the month to Feb 13th to make sure taxpayers can submit their tax payments in a timely manner.
- RESOLUTION SPONSORING ENTERPRISE FIRE CO. #2 FOR INSURANCE COVERAGE THROUGH SUBURBAN METRO JOINT INSURANCE FUND – As part of the ordinance with the Fire Department adopted previously by the Council which allowed each fire company to opt into the Township's joint insurance fund, Mayor Damiano explained that individuals within the Company may opt into coverage under the municipality at a nominal cost to the Township. The Mayor noted thus far Company No. 3, and now Company No. 2 have chosen to opt in.
- 3. RESOLUTION AUTHORIZING PURCHASE OF ROCK SALT UNDER THE SOMERSET COUNTY COOPERATIVE Mayor Damiano then discussed the rationale for opting in co-ops for better pricing of

various products. Mayor Damiano elaborated upon the agreement with the County regarding the storage and replenishment of rock salt at the DPW to allow for more efficient and timely salting and plowing of roads in the Township.

Mayor Damiano discussed scheduling a meeting with the Township Planner regarding the density requirements that exist pursuant to the different zoning ordinances throughout the Town. He noted the Planning Board has little guidance in regard to density in the various zones for residential units and recommended the Council provide guidance for what density should be in each zone when residential units are considered by a developer and what it should be capped at. Mayor Damiano also requested Council President SGOBBA join him in meeting with the Township Planner.

Extension of 2023 1st Quarter Tax Grace Period

RESOLUTION [A] 23-01-09 #1 COUNCIL APPROVAL FOR 2023 1ST QUARTER TAX GRACE PERIOD FROM FEBRUARY 10, 2023 EXTENDED TO FEBRUARY 13, 2023

WHEREAS, Resolution (S) 23-01-04 #2 paragraph under NOW, THEREFORE, BE IT RESOLVED." shall amend the 10-day grace period for this tax quarter from February 10, 2023 to February 13, 2023; and

WHEREAS, 1st Quarter 2023 taxes due February 1, 2023 must be received by our Tax Collector in person at the counter, mail or drop box by 3:00 p.m. on or before February 13th and online tax payments must be processed before 8:00 p.m. on Feb. 13th; any payments after these times will be subject to 8/18% interest and calculated back to the due date of February 1, 2023; and

WHEREAS, any account that has a third-party lien on it the taxpayer has priority over the lienholder with paying the 1st Quarter taxes due Feb. 1st until the grace period extension ends on February 13, 2023; and

NOW, THEREFORE BE IT RESOLVED, by the Township Council of the Township of Little Falls, County of Passaic, State of New Jersey that the 1st Quarter 2023 tax grace period is extended from February 10, 2023 to February 13, 2023 along with the above stipulations.
