WORKSHOP MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, July 10, 2017

Council President Anthony Sgobba called the meeting to order at 7:00 p.m. with the following members present: Marc Benitez, Maria Cordonnier, William Liess, and Chris Vancheri. Also present were Mayor James Damiano, Township Attorney Joe Wenzel, Township Engineer Dennis Lindsay, Township Administrator Charles Cuccia, and Municipal Clerk Cynthia Kraus.

Absent: DPW Superintendent Philip Simone and Police Chief Steve Post.

Township Employees present: None.

Following the Salute to the Flag, the Statement of Public Notice was read.

STATEMENT OF PUBLIC NOTICE: Take notice that adequate notice of this meeting was provided in accordance with N.J.S.A. 10:4-10 as follows: A notice of the meeting was prominently posted on the bulletin board at the Municipal Building, located at 225 Main Street, Little Falls, N.J. on January 3, 2017; a copy of the notice was faxed to the North Jersey Herald and News and The Record on the same date. Additionally, a copy of the notice was filed in the office of the Township Clerk on said date.

PRESENTATION BY DR. CARDILLO OF P.V.H.S. – Councilmember CORDONNIER welcomed Freeholder Director Sandra Lazara, Passaic Valley Board President Luke Damiano, Little Falls Board of Education Vice President Mike Russo, Little Falls Board of Education member Doug Jandoli, and Superintendent of Little Falls Schools, Tracey Marinelli. Councilmember CORDONNIER then introduced the Superintendent of Passaic Valley High School, Dr. JoAnn Cardillo. Dr. Cardillo provided a Powerpoint presentation on the progress of a mulitidisciplinary committee developed to focus on improving the quality of education at PV. Dr. Cardillo's presentation included review of the mission, vision, core beliefs, description of the implementation of new programs, school rankings, as well as testing data. Upon further information gathering including resident input, the Committee will adjust the mission, vision, and core beliefs and develop a five year strategic plan. Dr. Cardillo emphasized the value of public input and encouraged the public to complete a survey available on the school's website. Council President SGOBBA thanked Dr. Cardillo and invited the public to ask questions at this time.

Sandra Lazara, 12 Third Street, commended Dr. Cardillo on her accomplishments at PVHS and looked forward to collaborating with PVHS to make future improvements.

<u>Sara Goldstein</u>, 260 Main Street, raised the issue of handicapped accessibility in the Township, specifying the lack of available of handicapped parking near the Thursday concerts and Fourth of July Street Fair, and the absence of an elevator in the library.

Mayor Damiano indicated handicapped parking is allocated in the barricaded area where the Police close a section of Wilmore Road during concerts. Council President SGOBBA stated the Council will review and respond to Ms. Goldstein's comments.

<u>Renea Shapiro</u>, Little Falls ABC, added the street is closed at 6:30 p.m. to designate and area for handicapped parking. Ms. Shapiro indicated an email will be disseminated to inform residents about this accommodation. She thanked the Mayor and Council for their help and support of the Farmers Markets and concerts.

<u>Raymond Kostroski</u>, 170 Donato Drive, questioned why the Plenary Retail Consumption Licenses renewals, listed as Resolution A, contain a date that has already passed.

Mrs. Kraus explained the license period is from July 1st through June 30 and the licensee has an extension from the State at this time.

<u>Roland Day</u>, Past Post Commander, American Legion Post 108, welcomed recommendations on how to obtain names of war dead after World War II. He also appreciated any assistance to obtain the names of families of those who are currently serving our country, with the hopes of hosting a Support the Troops rally in the future.

Councilmember VANCHERI volunteered to collaborate with Mr. Dey.

County representatives will discuss bridge design and any concerns residents may have. The meeting will take place at 6:00 p.m. at the Civic Center tomorrow evening. In addition, the Mayor announced his belief that the decision as to whether the Township has been awarded any part of the Streetscape Grant is slated for tomorrow as well.
