SALUTE TO THE FLAG – Councilmember VANCHERI requested all remain standing to honor the memory of Dr. Joseph Farnese along with the four individuals who recently perished in a plane crash.

RON STELL- CLEAN COMMUNITIES REPORT - Ron Stell highlighted activities of the Clean Communities Program and also noted the 2022-2023 grant received was \$21,765.81 and the 2023 amount is \$24,413.12.

Ordinance No. 1465 - It was moved by Councilmember Hablitz, seconded by Councilmember Patel, that there be introduced and the meeting of July 24, 2023 set as the date for the public hearing of the following:

BOND ORDINANCE NO. 1465 BOND ORDINANCE TO AUTHORIZE THE CONSTRUCTION OF A NEW EMS BUILDING IN, BY AND FOR THE TOWNSHIP OF LITTLE FALLS, IN THE COUNTY OF PASSAIC, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$1,800,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

BE IT ORDAINED by the Township Council of the Township of Little Falls, in the County of Passaic, New Jersey, as follows:

Section 1. The Township of Little Falls, in the County of Passaic, New Jersey (the "Township"), is hereby authorized to construct a new Emergency Medical Services (EMS) Building on Wilmore Road in, by and for the Township. Said improvement shall include acquisition of original furnishings and equipment, site improvements and all work, materials and appurtenances necessary and suitable therefor. It is hereby determined and stated that said public building to be constructed will be of "Class B" or equivalent construction as defined in Section 22 of the Local Bond Law (Chapter 2 of Title 40A of the New Jersey Statutes Annotated, as amended; the "Local Bond Law").

Section 2. The sum of \$1,800,000 is hereby appropriated to the payment of the cost of making the improvement described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be met from the proceeds of the sale of the bonds authorized and the down payment appropriated by this ordinance. Said improvement shall be made as a general improvement and no part of the cost thereof shall be assessed against property specially benefited.

Section 3. It is hereby determined and stated that (1) said purpose is not a current expense of said Township, and (2) it is necessary to finance said purpose by the issuance of obligations of said Township pursuant to the Local Bond Law, and (3) the estimated cost of said purpose is \$1,800,000, and (4) \$90,000 of said sum is to be provided by the down payment hereinafter appropriated to finance said purpose, and (5) the estimated maximum amount of bonds or notes necessary to be issued for said purpose is \$1,710,000, and (6) the cost of such purpose, as hereinbefore stated, includes the aggregate amount of \$150,000, which is estimated to be necessary to finance the cost of such purpose, including architect's fees, accounting, engineering and inspection costs, legal expenses and other expenses, including interest on such obligations to the extent permitted by Section 20 of the Local Bond Law.

Section 4. It is hereby determined and stated that moneys exceeding \$90,000, appropriated for down payments on capital improvements or for the capital improvement fund in budgets heretofore adopted for the Township, are now available to finance said purpose. The sum of \$90,000 is hereby appropriated from such moneys to the payment of the cost of said purpose.

Section 5. To finance said purpose, bonds of the Township of an aggregate principal amount not exceeding \$1,710,000 are hereby authorized to be issued pursuant to the Local Bond Law. Said bonds shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law. All matters with respect to said bonds not determined by this ordinance shall be determined by resolutions to be hereafter adopted.

Section 6. To finance said purpose, bond anticipation notes of the Township of an aggregate principal amount not exceeding \$1,710,000 are hereby authorized to be issued pursuant to the Local Bond Law in anticipation of the issued of said bonds. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding. Section 7. Each bond anticipation note issued pursuant to this ordinance shall be dated on or about the date of its issuance, shall be

payable not more than one year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within limitations prescribed by the Local Bond Law. Each of said bond anticipation notes shall be signed by the Mayor and by a financial officer and shall be under the seal of the Township and attested by the Township Clerk or Deputy Township Clerk. Said officers are hereby authorized to execute said notes in such form as they may adopt in conformity with law. The power to determine any matters with respect to said notes not determined by this ordinance, and also the power to sell said notes, is hereby delegated to the Chief Financial Officer who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law.

Section 8. It is hereby determined and declared that the period of usefulness of said purpose, according to its reasonable life, is a period of thirty years computed from the date of said bonds.

Section 9. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Township Clerk of the Township, and that such statement so filed shows that the gross debt of the Township, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$1,710,000 and that the issuance of the bonds and notes authorized by this ordinance will be within all debt limitations prescribed by the Local Bond Law.

Section 10. Any funds received from private parties, the County of Passaic, the State of New Jersey or any of their agencies or any funds received from the United States of America or any of its agencies in aid of said purpose, shall be applied to the payment of the cost of said purpose, or, if bond anticipation notes have been issued, to the payment of the bond anticipation notes, and the amount of bonds authorized for said purpose shall be reduced accordingly.

Section 11. The Township intends to issue bonds or notes to finance the cost of the improvement described in Section 1 of this bond ordinance. If the Township incurs such costs prior to the issuance of such bonds or notes, the Township hereby states its reasonable expectation to reimburse itself for such expenditures with the proceeds of such bonds or notes in the maximum principal amount of bonds or notes authorized

by this bond ordinance. Section 12. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and interest on the obligations authorized by this ordinance. Said obligations shall be direct, unlimited and general obligations of the Township, and the Township shall levy ad valorem taxes upon all the taxable real property within the Township for the payment of the principal of and interest on such bonds and notes, without limitation as to rate or amount. Section 13. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency

therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Township Clerk and is available for public inspection. Section 14. This ordinance shall take effect twenty days after the first publication thereof.

ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS, COUNTY OF PASSAIC, STATE OF NEW JERSEY, FURTHER AMENDING THE TOWNSHIP OF LITTLE FALLS CODE CHAPTER 7, ARTICLE I, SECTION 7-40, "PARKING PROHIBITIONS ON MUNICIPAL AND BOARD OF EDUCATION PROPERTY"

WHEREAS, due to concerns regarding the health and safety of motorists and pedestrians in the Township, the municipal council of the Township (the "Municipal Council") seeks to amend the provisions of the current code section; and WHEREAS, in furtherance of the proposed amendment to the Township Code of General Ordinances (the "Code") concerning the

parking vehicles on the Township Roadways; and

WHEREAS, the Municipal Council has determined to amend Chapter 7, Article II, Section 7-40.11 Morris Canal Parking Lot of the Township Code to be amended as follows;

NOW THEREFORE, BE IT ORDINANED by the Municipal Council of the Township of Little Falls, Passaic County, State of New Jersey, as follows: 1.

The aforesaid recitals are incorporated herein as though fully set forth at length.

2. The Municipal Council hereby amends Chapter 7, Article II, Section 7-40 of the Township Code to read as follows:

7-40.11 Morris Canal Parking Lot **B. Parking Regulations**

(10) Only vehicles displaying a valid Enterprise Fire Company 2 parking decal issued by the Township of Little Falls may be parked in designated Fire Department stalls.

If any section, paragraph, subdivision, clause, sentence, phrase or provision of this Ordinance is declared unconstitutional 3. or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance

A copy of this Ordinance shall be available for public inspection at the offices of the Township Clerk. 4.

This Ordinance shall take effect after twenty (20) days of its final passage by the Municipal Council, upon approval by the 5. Mayor and publication as required by law.

It was moved by Councilmember Patel, seconded by Councilmember Hablitz, that the meeting be and it was opened to the public.

The Council President declared the motion passed.

No one having come forward to be heard, it was moved by Councilmember Patel, seconded by Councilmember Murphy, that the meeting be and it was closed to the public.

The Council President declared the motion passed.

At this time, Mr. Wenzel explained the Council would sit as the ABC Board as a local authority for liquor licenses issued within the Township. Under Township code, there is no separate ABC Board. Mr. Wenzel further elaborated that this issue has been held out separate because it is a renewal being requested through the Police Department as to special conditions to be placed on the renewal of the license. As a local ABC Board, the Council's only authority is to revoke, suspend or renew, or renew with special conditions. The Council does not have the authority to set penalties or other obligations which falls on the State Division of Alcohol and Beverage Control. Mr. Wenzel indicated the procedure would include Chief Prall's explanation of the rationale for seeking the special conditions as well as the opportunity for Mr. Callegari to make a response on behalf of his client. He clarified, although the Mayor referred to this as a hearing, it is not a hearing per se, this is resolution, a renewal with special conditions that is not being opened up for public comment.

At this time, Chief Prall highlighted incidents and investigations which occurred over the last three years as well as the special conditions be placed on the license. Chief Prall responded to Mr. Wenzel's request for clarification as to whether the special conditions would ameliorate or eliminate the issues brought forth as well presence and level of security on the site. Chief Prall further added the special conditions were brought forward because there was no corrective action taken on the part of the establishment. Chief Prall then responded to Councilmember HABLITZ's inquiry regarding presence of an off-duty officer as well as a private security. In response to Councilmember VANCHERI, Chief Prall confirmed underage patrons dining would have to vacate the premises by 9pm, that the special conditions would be for one year and would be re-evaluated.

Counsel Lawrence Callegari- 685 Broadway, Paterson, spoke on behalf of Chela's restaurant. He noted he had the opportunity to review the special conditions with his client. Mr. Callegari commented on the special conditions and the ability to maintain the business and address the concerns of the Township.

Sebastian Arboleda - 93 Market Street Paterson, owner, commented that he takes responsibility and is thinking of selling the establishment. Mr. Aboleda stated with these conditions he does not think he would be able to survive or keep the establishment going.

Mr. Caligari then summarized that it is a matter of keeping the establishment open to promote a sale. Councilmember MURPHY questioned if the special conditions would be dropped upon a sale. Mr. Wenzel believed the special conditions remain until there is an action by the ABC Board to remove them. Mr. Wenzel further elaborated on transfers.

Mr. Wenzel stated he prepared a consultation with the Police Chief based upon a review of the matters the Police Chief has raised. Mr. Wenzel then summarized Counsel's response, on behalf of his client, to the special conditions. Mr. Wenzel further directed that it is up to the Council, as the ABC Board, to determine whether to move or amend the Resolution based upon the colloquy from tonight. Councilmember VANCHERI asked the Chief for his thoughts to which Chief Prall stated that by the current calls and actions, he thinks his actions are still appropriate.

Chief Prall then reviewed the service calls per Councilmember MURPHY's inquiry and responded to Councilmember HABLITZ's request for further clarification of the breakdown of calls for service. In response to Councilmember PATEL, Chief Prall indicated the number of bar/tavern checks were a direct result of the calls that arose from calls from Chela's and some of the problems that the PD has been responding to.

At this time, Mr. Wenzel reiterated that the Council is the ABC Board and it is up to the Board to approve, amend or deny the Resolution.

It was moved by Councilmember Patel, seconded by Councilmember Hablitz to approve Resolution G.
