REGULAR MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, July 11, 2016

Council President Louis Fontana called the meeting to order at 8:20 p.m. with the following members present: James Damiano and Joseph Maceri. Also present were Mayor Darlene Conti, Township Attorney Leslie London, Township Engineer Dennis Lindsay, Township Planner Jeff Janota, Administrator Charles Cuccia, and Municipal Clerk Cynthia Kraus.

Absent: Councilmember Pamela Porter and Councilmember William Liess

Township Employees present: DPW Superintendent Phillip Simone, Deputy Registrar Marlene Simone, and Police Chief Steven Post.

Following the Salute to the Flag, the Statement of Public Notice was read.

STATEMENT OF PUBLIC NOTICE: Take notice that adequate notice of this meeting was provided in accordance with N.J.S.A. 10:4-8 and N.J.S.A. 10:4-10 as follows: A notice of the meeting was prominently posted on the bulletin board at the Municipal Building, located at 225 Main Street, Little Falls, N.J. on January 8, 2016; a copy of the notice was faxed to the North Jersey Herald and News and The Record on the same date; additionally, a copy of the notice was filed in the office of the Township Clerk on said date.

APPROVAL OF MINUTES

Councilmember DAMIANO requested the Minutes of the Workshop meeting of January 12, 2015 be moved separately. Councilmember MACERI requested advisement from Ms. London as to whether he would have to abstain from voting on the October 20, 2014 Minutes as he was not present. Ms. London stated that under the doctrine of necessity and the need to approve Minutes, Councilmember MACERI may vote on the Minutes, provided he read them.

It was moved by Councilmember Maceri, seconded by Councilmember Damiano, that the Minutes of the Regular meetings of October 20, 2014, November 24, 2014, and December 29, 2014 and the Minutes of the Workshop meetings of November 10, 2014, and December 8, 2014 be and they were approved.

REMARKS FROM CHAIR

Council President FONTANA commented he was proud to be a part of the Library's 100th birthday celebration as it was a well-organized and well attended event. He declared that Little Falls is now part of the 9-11 Registry. He announced that over 250 children are signed up for the summer camp run by the Recreation Center and commended Mr. Pace on his efforts.

COUNCIL MEMBER REPORTS

Councilmember DAMIANO commended Ms. Shapiro and the ABC on their contribution to make the Farmer's Markets and Concerts in the Park a success.

Councilmember MACERI congratulated the third and fourth grade Little Falls softball champions as well as the other Little Falls team that made the championships. He commended Mr. Pace for providing a successful and well attended summer camp, and applauded Ms. Shapiro and the ABC for creating a welcoming atmosphere to bring everyone together during the summer.

MAYOR'S REPORT

Mayor Conti reflected on the recent incidents in Texas, and requested a moment of silence. She announced that in honor of Flag Day, a ceremony for the retirement of flags was held on June 14, 2016 with the assistance of the Boy Scouts and the Fire Department. She congratulated Brian Mistrette who was honored as EMT of the Year and John Conti who was honored as Firefighter of the Year by the Knights of Columbus.

ATTORNEY'S REPORT

Ms. London had nothing to report.

At this time, Councilmember MACERI congratulated Mr. Korotkin for being recognized as the only NJ Resident to be named Everyday Hero.

PUBLIC COMMENT

It was moved by Councilmember Damiano, seconded by Councilmember Maceri, that the meeting be and it was opened to the public.

The Council President declared the motion passed.

Renea Shapiro, ABC, provided a history of permit fees with regard to the Farmer's Market and recounted discussion at a previous meeting as Council President Fontana was not present at that discussion. She notified the Council the State allows a waiver to be done at an Executive Session, and will take this into consideration when planning for next year. However, this year, vendors will be charged \$15 and the ABC will fund the remainder. Ms. Shapiro also requested a timeline for Transit Village. She requested clarification as to what constitutes a sidewalk in reference to specific area at Wilmore Park. She expressed her agreement with comments made by Ms. Cordonnier at a previous meeting regarding the necessity to submit paperwork for open space grants on a timely basis.

<u>Louis Fernandez</u>, Harrison Street, recalled a gas leak during the winter at the intersection of Harrison Street and Ryle Avenue. The leak was addressed, however, PSE&G has not come to repair the patch therefore, he requested follow-up. He also questioned whether the summer camp held by the Recreation Center was comprised of residents and non-residents.

Arnold Korotkin, 181 Long Hill Road, explained that the 9-11 Registry is affiliated with the 9-11 Museum and Memorial in Manhattan, and a directory of all memorials across the nation is being developed. He noted correspondence sent to Mr. Simone, Chief Sweezy, and Mr. Burke suggesting the memorial for Robert Cordice be included in the directory listing. He reiterated implementation of the Governor's Best Practices, their potential impact for non-compliance, and requested the Council's attention to the new amendment. He discussed the Township Minutes with specific application to the NJ Open Public Meetings Act and Governor's Best Practice Guidelines, and requested Minutes be transcribed from meetings convened more recently. Mr. Korotkin urged the Council to consider the adoption of resolutions in support of the position taken by the Passaic Valley High School Board with respect to the Passaic County Technical Institute (PCTI) STEM program expansion. He itemized several questions stemming from his review of an article in the Passaic Valley Today reporting construction of an ADA complaint ramp at the Inwood Park playground.

It was moved by Councilmember Damiano, seconded by Councilmember Maceri, that the meeting be and it was closed to the public.

The Council President declared the motion passed.

Mr. Cuccia addressed the issue of permits explaining the administration had revised the ordinances years ago and the Township is obliged to follow the ordinances set forth by the government. He referenced that Mr. Higgins had raised the issue in his previous audits that the permit fee collected was not in accordance with the ordinance. In response to Council President FONTANA's question of notification, Mr. Cuccia relayed this information to Ms. Shapiro last year.

Mr. Cuccia stated the remaining work that needs to be done regarding Transit Village pertains to planning. The Master Plan, zoning, COAH, and video marketing will be spearheaded by Mr. Janota. Mr. Janota provided a synopsis of the application, which will completed and submitted by the end of October, 2016.

Mr. Lindsay responded to Ms. Shapiro's question regarding sidewalks, referencing code. It is an area in the right of way available for the pedestrians, exclusive of parkways. He translated that it does not necessarily have to be a cement surface and its purpose is for the movement of pedestrians in the right of way. Council President FONTANA concluded the area cited by Ms. Shapiro is available for pedestrian use.

Mr. Simone will contact PSE&G to determine when the patch near Harrison Street will be repaired.

Council President FONTANA expressed his belief that the summer campers attending the Recreation Center's camp are residents of Little Falls.

Council President FONTANA stated follow-up with Fire Department will occur regarding the suggestion put forth by Mr. Korotkin pertaining to the Robert Cordice memorial.

In response to Council President FONTANA, Mr. Cuccia responded that the Best Practice Program has provisions that State aid could be held back should insufficient questions be answered. Mr. Cuccia to research the amendment to determine if the percentages held back have changed. Historically, the Township has not had any State aid eliminated from the budget. Council President FONTANA stated his agreement with Mr. Korotkin to provide recent Minutes along with older Minutes. Mr. Cuccia stated his rationale for disagreement. In order to capture the nature of flow of the resolutions and progress of the meetings, the Minutes should be done in order of the meetings to promote optimum efficiency. Mr. Cuccia stated the Minutes are being completed in an efficacious manner, and anticipates approximately six months of Minutes are to be presented at the next Meeting for approval. Council President FONTANA agreed with Mr. Cuccia to proceed as indicated.

Council President FONTANA and Mr. Cuccia to obtain more information on the resolution pertaining to PCTI.

Mr. Lindsay stated when interviewed for the newspaper article he specifically stated the ramp at the park entry at Inwood Park is not ADA complaint. He will however, develop a plan and obtain pricing for presentation to Council for consideration and direction.

CONSENT AGENDA

WHEREAS, pursuant to the March 10, 2015 New Jersey Supreme Court Order which transferred oversight of the Fair Housing Act (FHA) to the courts, many municipalities (including Little Falls) filed declaratory judgment actions to voluntarily comply with their present and prospective affordable housing requirements as established in the FHA; and

WHEREAS, the FHA and existing case law are clear that "present and prospective fair share of the housing need in a given region ... shall be computed for a 10-year period." (See N.J.S.A. 52:27D-307(c)); and

WHEREAS, in October 2015, the Middlesex County Superior Court issued a decision that included a distinct "gap period" obligation, retroactively imposing an additional municipal obligation over an additional 16 year period, separate and apart from the normal 10 year present and prospective need set forth in the FHA. Recently, the Ocean County Superior Court did the same. The Ocean County decision is currently on appeal; and

WHEREAS, this "gap period" issue arises out of COAH's inability to promulgate Third Round regulations from 1999 to the present, or make any final determination as to state and regional housing need. Despite this, the courts are not holding COAH accountable but rather are imposing additional obligations on municipalities. These retroactive obligations will have a significant and unfunded impact on municipalities, straining their already overburdened resources; and

WHEREAS, aside from other inequities and issues imposed by a so-called "gap" obligation, the households counted in the "gap period" may well be double counted when the present need is calculated. The prospect of double counting compounds this dilemma and will likely result in forcing municipalities and their property taxpayers to subsidize development or subject them to court orders allowing enormous numbers of new housing units as a result of "builder's remedy" lawsuits. Such a result will radically and irrevocably transform the character and quality of life for all New Jersey residents; and

WHEREAS, hundreds of New Jersey's municipalities have expended significant financial and other administrative resources in their attempts to voluntarily comply with their constitutional obligation for affordable housing as established by the Supreme Court and the FHA. As a direct result of the State's failure to advance viable regulations or enact overdue legislative reform, this will only continue to spiral out of control;

WHEREAS, Senate Bill S2254 and Assembly Bill A3821 are important legislative remedies designed to clarify existing law and preclude these significant, unfair impacts. Swift and decisive adoption of both is a critical step toward a more rational statewide housing policy, including reasonable and achievable obligations for municipalities

NOW THEREFORE, BE IT RESOLVED by the Township Council of the Township of Little Falls, County of Passaic, and State of New Jersey, as follows:

1. The Mayor and Township Council hereby support the adoption of Senate Bill S2254 and Assembly Bill A3821 which clarify that a

- municipality's present and prospective fair share of the housing need in a given region shall be computed for a 10-year period, and shall not include a retrospective obligation arising from any so called "gap period."

- decisively adopt both as a critical step toward a more rational statewide housing policy, including reasonable and achievable
