WORKSHOP MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, July 8, 2019

Council President Anthony Sgobba called the meeting to order at 7:00 p.m. with the following members present: Maria Cordonnier, Albert Kahwaty, Tanya Seber, and Chris Vancheri. Also present were Mayor James Damiano, Township Attorney Joe Wenzel, Township Administrator Charles Cuccia, and Municipal Clerk Cynthia Kraus.

Absent: Township Engineer and Police Chief Steve Post.

Township Employees present: DPW Superintendent Phillip Simone.

The Council President declared the motion passed.

Andrew Baggot -78 Franklin Road, Denville, 105 & 107 Main Street, commented on the posting of the Agenda, livestream for the June 24, 2019 Meeting, and content of previous Minutes. Ms. Kraus identified when the Agendas were posted. Council President SGOBBA stated the Council's awareness of issues with the livestreaming. Ms. Kraus added that there was a problem with the link, however, the video has been accessible on YouTube. Council President SGOBBA stated everything is online, nonetheless, Mr. Cuccia can furnish Mr. Baggot with the data he requested. Mr. Baggot requested updates on the PNC parking lot and payment in lieu of parking. Mr. Wenzel elaborated that this matter involves potential contract negotiations and are not subject to public discussion at this time, however, there has been a letter sent communicating interest to acquire the lot as per law. Mayor Damiano explained the wording that is required in an ordinance. With regard to payment in lieu of parking, Council President SGOBBA stated it was up for discussion and there has not been any movement.

Luis Fernandez, 54 Harrison Street, stated he will look into the issue raised regarding the Minutes, however, he has not had a problem in the past.

No one further having come forward to be heard, it was moved by Councilmember Vancheri, seconded by Councilmember Kahwaty, that the meeting be and it was closed to the public.

ITEMS TO BE DISCUSSED:

MAYOR/ADMINISTRATOR:

- 1. DUVA FIELD- Mayor Damiano provided an update on the project which is slated to be completed prior the start of fall sports. New fans have been installed in the Recreation Center prior to the start of Summer Camp and have made an improvement.
- 2. FOOD TRUCK ORDINANCE Mayor Damiano suggested the Council consider a Food Truck ordinance that restricts and regulates food trucks as to where and when they are permitted to operate to ensure the municipality remains safe and clean. The Mayor hopes to have something for the Council to review at an upcoming meeting. Councilmember VANCHERI questioned whether ice cream trucks and food trucks on private property would be considered in the Ordinance. Mayor Damiano responded they should be included though there will be some exceptions.
- 3. TAX REFUND RESOLUTION Mayor Damiano explained the standard nature of the resolution. **DPW SUPERINTENDENT:**
 - 1. ORDINANCE FOR ILLEGAL DUMPING Mr. Simone explained the need for a separate ordinance aside from Chapter 126.4 to address illegal dumping at the recycling center or on other Township properties. He recommended amending the illegal dumping definition and attaching a fine to deter it. Councilmember KAHWATY questioned whether the fine would be covered under the most recent ordinance passed by the Council. Council President SGOBBA agreed with Mr. Simone's request to distinguish dumping versus littering. Councilmember CORDONNIER expressed her opinion to have a separate ordinance from littering to be more specific. Councilmember VANCHERI queried whether signs were posted that the recycling center is for Township residents only. Councilmember SEBER questioned what the best method would be to avoid these situations. Council President SGOBBA relayed his recommendation to make the first offense at \$2500. The Council will discuss further and review Mr. Simone's recommendations.

- Discussion ensued with regard to responsibility for litter on the street, weeds on the sidewalk, enforcement, mulching schedules, and DPW staffing
- HUNTERDOWN COUNTY EDUCATIONAL SERVICES COMMISSION COOPERATIVE PRICING AGREEMENT -Mr. Simone stated this is the cooperative pricing the Township would like to use to purchase a senior citizen bus and would provide a cost savings. The Township would also not have to go out to bid which would enable procurement sooner.

NEW BUSINESS

COUNCIL TOPICS FOR DISCUSSION

Councilmember SEBER thanked everyone who attended the July 4th Street Fair and Officer Vanak and Steve Maye for their help that day. The Library Board will hold a fundraiser at the California Pizza Kitchen in July. Councilmember SEBER provided detail on the Run Little Falls 5K which will take place on October 6, 2019.

Councilmember CORDONNIER commended Councilmember SEBER on her efforts in planning the 5K. Councilmember CORDONNIER discussed plans for the First Annual Barbeque on July 18, 2019 at the American Legion sponsored by the Senior Advisory Committee. The Open Space Committee did not convene in July and will resume in August.

Councilmember VANCHERI will develop a letter in coordination with Chief Post and Lieutenant Briggs containing a list of streets where slow down speed signage is requested to alleviate speeding issues. Follow-up will occur with the County regarding the proposed traffic light on Wilmore Road, Francisco Avenue and Cedar Grove Road regarding the next steps and timing. Follow-up will also occur with the County Engineer regarding a request for a reflective mirror near Ethel Drive and Francisco Avenue in response to concerns of a blind spot. Councilmember VANCHERI provided details on plans discussed with Superintendent Marinelli for a 9-11 ceremony. Lastly, Councilmember VANCHERI provided a status report on the safety seminar suggested by the Transportation Committee which is slated for some time in August.

Councilmember KAHWATY commended the efforts of members of the Domestic Violence Prevention Committee at the July 4th Street Fair. A vigil will be held on October 10, 2019 at the Municipal Building and will include guest speakers. A fall cleanup is scheduled for September 14, 2019 and all were encouraged to attend. On August 28, 2019 there will be an outdoor movie at the Wilmore Memorial Park at 6:30 PM.

Councilmember CORDONNIER reminded everyone to attend the concerts in the Park on Thursdays.

Council President SGOBBA requested Mayor Damiano move forward with installing the Littering signs specifying the new \$250 offense.
