# REGULAR MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

#### Monday, June 9, 2014

Council President Louis Fontana called the meeting to order at 7:30 p.m. with the following members present: Joseph Maceri, William Organisciak, Pamela Porter and John Vantuno. Also present were Mayor Darlene Post, Township Attorney William Northgrave, Township Engineer Dennis Lindsay, Municipal Clerk Cynthia Kraus and Township Administrator Charles Cuccia.

Absent: None

Township Employees present: DPW Superintendent Phillip Simone and Police Chief John Dmuchowski

Following the Salute to the Flag, the Statement of Public Notice was read.

**STATEMENT OF PUBLIC NOTICE**: Take notice that adequate notice of this meeting was provided in accordance with N.J.S.A. 10:4-8 and N.J.S.A. 10:4-10 as follows: A notice of the meeting was prominently posted on the bulletin board at the Municipal Building, located at 225 Main Street, Little Falls, N.J. on January 8, 2014; a copy of the notice was faxed to the North Jersey Herald and News and The Record on the same date; additionally, a copy of the notice was filed in the office of the Township Clerk on said date.

#### **REMARKS FROM CHAIR**

Council President FONTANA informed that Clifton High School will be having an emergency preparedness drill on Saturday 6/14/14 at 9:30 a.m.

#### **COUNCIL MEMBER REPORTS**

Councilmember ORGANISCIAK had nothing to report.

Councilmember VANTUNO had nothing to report.

Councilmember MACERI thanked everyone who came out to vote during the General Election and expressed his appreciation for all who supported him. He informed that he attended Little Falls Night at the Jackals Game, which was a nice event. He also informed that the next Flood Board meeting will be held in Woodland Park at 7:00 p.m.

Councilmember PORTER said the Senior Citizen's Ice Cream Social was a nice event. She also informed that there will be a meeting of the Police Station Committee, where the County will present plans for the building.

#### MAYOR'S REPORT

Mayor Post congratulated all of the graduates of Montclair State University. She also congratulated Sip and Swirl and Tumble Zone on their grand openings. She informed that World Environment Cleanup recently held a cleanup on the Passaic River Woodcliffe Avenue river walk. She also informed that the Transit Village and the Master Plan were both discussed at the last Planning Board meeting.

Mr. Simone informed that he met with PSE&G regarding the Energy Strong Program, and explained that they will be replacing gas lines in the Singac section to improve gas pressure. The project will commence in July and is anticipated to be completed at the end of the year.

#### APPOINTMENT OF LIBRARY BOARD MEMBERS FOR A 5-YEAR TERM

Mayor Post informed that she is reappointing the following members to the Library Board for 5-year terms: Anthony Sgobba, Patricia Ross and Marianne DeLorenzo, all expiring May 1, 2019.

#### ATTORNEY'S REPORT

Mr. Northgrave had nothing to report.

#### ADMINISTRATOR'S REPORT

Mr. Cuccia said he received a request for a concert banner from the ABC for the concerts in the park. He wanted to ask for permission from the Council for this; there was an affirmative consensus from the Council to approve this. Mr. Cuccia said they are currently reviewing dates for a meeting to discuss the Transit Village. He will continue to provide updates on this moving forward. Tonight's agenda includes the public hearing and adoption of Ordinance No. 1195 for various improvements to Riker and Garrabrant Avenues. They have been discussing the overnight parking as well. He asked the Police Chief to elaborate on this at this time.

At this time, Chief Dmuchowski spoke about the issues regarding overnight parking and explained that they are still working on a new ordinance for this.

#### **PUBLIC PORTION**

It was moved by Councilmember Organisciak, seconded by Councilmember Porter, that the meeting be and it was opened to the public:

<u>Rob Zurcher</u>, 15 Oak Tree Lane, explained that there is a house on his block which is being rented to college students. He voiced his disappointment with the circumstances and asked if this is legal.

Renea Shapiro, Walnut Street, explained that the Little Falls ABC will have its Farmers Market beginning on 6/26/14 through 8/28/14 at Wilmore Road Park. Little Falls Nigh will be held on 6/26/14 at 6:30 p.m. to kick off the Farmers Market. On 7/3/14, they will have a special event to honor the veterans. She thanked the Mayor, the DPW and Mr. Simone for helping the Little Falls ABC with their event preparations this year. She also informed that the Transportation Committee recently held a meeting; Minutes have been sent out. She questioned the process and the status of the Master Plan regarding a Transit Village.

Arnold Korotkin, 181 Long Hill Road, explained that the NJ League of Municipalities is seeking nominations for great places in New Jersey. He suggested that someone send in a nomination for Memorial Park in Little Falls. He also thanked the Council for the approval of Resolution K on this evening's agenda, noting that this has been in the works for quite some time. Regarding the senior bus service in town, he suggested the idea of putting advertisements on the bus in order to cover some of the costs to run the bus. He also asked the Council to pass a resolution expressing their concern regarding the Transcontinental Gas Pipeline Company's project, which is an expansion project increasing the pressure of existing pipelines that run through 16 towns, including Little Falls. There is concern that this will increase the pressure in older pipelines in these towns, which could cause other problems. Other municipalities and fire companies have already expressed their concern about this.

<u>Bob Retzer</u>, 20 Jackson Street, said the road at the corner of Jackson Street and Paterson Avenue is a mess and now the storm sewers do not work. The Township has repaved several streets in town since this project took place on Paterson Avenue. He would like for his street to be repaved. He wants to know what can be done about this.

<u>Caren DaSilva</u>, former resident of 92 Island Avenue, said she has been waiting for her property in Little Falls to be elevated. The former Administrator has not returned any of her emails and she does not know the status of this. She would like a better line of communication with the Township.

<u>Keith Kazmark</u>, Mayor of Woodland Park, said he will be addressing Ordinance No. 1194 during the public hearing this evening. However, he was wondering if the Council could share the report from the Planning Board meeting prior to the public hearing this evening.

<u>Dorothy O'Haire</u>, Turnberry Road, gave an update regarding the recent Flood Board meeting which took place in Woodland Park with the Army Corps of Engineers. She informed that the Minutes of this meeting have been filed in the Clerk's Office at Town Hall if anyone would like to know the outcome.

<u>Louis Fernandez</u>, Harrison Street, pointed out that the Mayor of Woodland Park is here again asking for things. Referring to Ordinance No. 1195 on tonight's agenda, he said there are many other streets in town that have to be paved, including Jackson Street.

Bob Dombrowski, Parkway, asked about the status of the paid ambulance service.

<u>Jennifer Ziesing</u>, 1 Oak Tree Lane, expressed her concern regarding a neighboring property being rented out to a large number of Montclair State University students. She moved to her street because it is quiet and family-oriented. She doesn't want to see the road become part of the MSU dormitories.

<u>Fire Chief Jack Sweezy</u>, referred to Resolution [L] on this evening's agenda, and asked the Council to support this for the future of new homes. This is a positive for everyone and an important safety issue.

No one else having come forward to be heard, it was moved by Councilmember Vantuno, seconded by Councilmember Porter, that the meeting be and it was closed to the public.

The Council President declared the motion passed.

Council President FONTANA addressed the concerns regarding Oak Tree Lane and referred this to the Attorney. Mr. Northgrave said he doesn't believe the Township is in a position to issue a zoning violation because the residents of a house are college students. However, as the Police Chief has previously stated, if there is a problem or concern, the residents should report it to the Police Department so they are able to come out and assess the situation.

Chief Dmuchowski said they have had this issue in other areas of town. They work very well with MSU. He reiterated that the Police Department is there to help if there are complaints of noise, parking, etc. and also pointed out that the college can take sanctions against those students if necessary, which may be a faster process.

Council President FONTANA urged everyone to come out for the concerts in the park, adding that it is a nice event.

Mr. Cuccia explained that he is speaking with the Attorney and the Auditor regarding an amendment they can use to fund the changes that are requested in the Master Plan. They are also going to meet with the NJDOT to discuss the application for the transit village. They also have to discuss changes in the zoning ordinance.

The Council President declared the motion passed.

Keith Kazmark, Mayor of Woodland Park, said this ordinance will have a significant effect on the residents of Woodland Park if adopted. Council President Fontana previously stated that the Council would be meeting with representatives of Woodland Park to discuss this ordinance further before public hearing and adoption; however, he felt it was necessary to introduce the ordinance in the meantime. At that meeting, there were several representatives of Woodland Park present, asking that the ordinance be tabled, but it was not. At this time, he read a letter sent to Mr. Buglione, Woodland Park Borough Attorney, by Mr. Northgrave, indicating that this ordinance is consistent with the court's ruling and a meeting between the towns is not necessary. Mr. Kazmark disagreed with the statements made in this letter, reiterating that this would negatively impact the residents of Woodland Park. He was disappointed that Little Falls chose not to hold the meeting to discuss this ordinance. He explained that he also tried meeting with the Mayor when this ordinance was initially introduced to discuss this further and negotiate. There is a lack of communication. Although not required, the Little Falls Planning Board did not open a public hearing on this ordinance at its meeting before making comments and recommendations to the Council. He would like to know who made the decision not to meet with Woodland Park. At this time, Mr. Kazmark addressed all of his specific concerns with this ordinance.

<u>Albert Buglione</u>, Borough Attorney of Woodland Park, reiterated the concerns as stated by Mr. Kazmark. He asked that the Council consider holding off on the adoption of this ordinance until they can meet with Woodland Park to discuss this further.

<u>Tracy Kallert</u>, Councilmember of Woodland Park, also voiced her concerns and disapproval of the ordinance. She explained that the representatives of Woodland Park are here to represent their residents, who also have concerns regarding the ordinance.

Mr. Northgrave addressed members of the audience, and explained that this is a Little Falls Council Meeting and the Mayor has the right to consult with Counsel during this time.

<u>Sam Sheber</u>, Lackawanna Avenue, Woodland Park, asked who suggested this type of an ordinance, voicing his disapproval. He reiterated the concerns as stated by previous speakers and asked the Council not to approve the ordinance.

<u>George Pepe</u>, 632 Lackawanna Avenue, Woodland Park, provided pictures of his property and the subject property to the Council. He also addressed several areas of the ordinance, noting his dissatisfaction with many parts of it.

Mr. Kazmark, asked the Council to table this ordinance and meet with the representatives and residents of Woodland Park to negotiate before approving same.

No one further having come forward to be heard, it was moved by Councilmember Organisciak, seconded by Councilmember Porter, that the public hearing on Ordinance No. 1194 be and it was closed to the public.
