MAYOR/ADMINISTRATOR:

- RESOLUTION AUTHORIZING ADVERSTISEMENT FOR BIDS FOR FIRE ALARM SYSTEM FOR THE MUNICIPAL BUILDING COMPLEX - Mayor Damiano explained the fire alarm system needs updating and that this Resolution requests the Council's permission to go out to bid.
- 2. RESOLUTION AWARDING CONTRACT FOR MAIN STREET STREETSCAPE SECTION 4 PROJECT (MAPLE STREET TO PATERSON AVENUE) - The Mayor explained this Resolution is to continue the streetscape down Main Street. The Township has funding from Van Ness Avenue to Union Avenue, which will bring curb appeal to the Downtown with new curbs, streetlights, and signage. Additionally, the project is almost entirely funded by a grant from the NJDOT. Council President SGOBBA requested the Mayor provide the Council with the number of grants awarded for the streetscapes. The Mayor elaborated on the amount of monies the grant writers have obtained in grants compared to the fee charged for grant writing services.
