REGULAR MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, June 25, 2018

Council President Anthony Sgobba called the meeting to order at 6:30 p.m. with the following members present: Maria Cordonnier, Willam Liess, Tanya Seber, and Christopher Vancheri. Also present were Mayor James Damiano, Township Attorney Associate Joseph Friend, Township Administrator Charles Cuccia and Township Clerk Cynthia Kraus.

Absent: Township Engineer Paul Przybylinski.

Township Employees present: DPW Superintendent Phillip Simone, Police Chief Steven Post, Fire Chief Jack Sweezy, and Deputy Registrar Marlene Simone.

STATEMENT OF PUBLIC NOTICE: Take notice that adequate notice of this meeting has been provided in accordance with N.J.S.A. 10:4-8 and N.J.S.A. 10:4-10 as follows: A notice of the meeting was prominently posted on the bulletin board at the Municipal Building, located at 225 Main Street, Little Falls, N.J. on January 2, 2018. A copy of the notice was mailed to the North Jersey Herald and News and The Record on the same date. Additionally, a copy of the notice was filed in the office of the Township Clerk on said date.

SWEARING IN OF POLICE LIEUTENANT JAMES BRIGGS – At this time, Chief Post thanked the Mayor and Council for working with him on a vision for the Police Department. The Chief commented on the importance of the command structure of the Police Department and highlighted the responsibilities of the Lieutenant position. Mayor Damiano also commented that this is a big step as this municipality works toward a more balanced and proper table of organization. He commended Sargeant Briggs on his leadership skills and fit for the position. Mayor Damiano then performed the swearing in ceremony. Lieutenant Briggs thanked the Mayor, Administrator, Chief Post, the members of the Police Department, and his family for their support.

At this time, Council President SGOBBA announced that Joe G. Friend is sitting in for Counsel tonight and is duly qualified to represent the Township this evening.

COUNCIL MEMBER REPORTS

Councilmember VANCHERI announced the Transportation Committee will convene on June 27, 2018. Corporal Moncato has been invited to attend. The Flood Board will convene once a meeting schedule is established by the larger three town Flood Board. Councilmember VANCHERI thanked Mr. Simone, the Mayor and Council, for permitting the Boy Scouts to keep their storage container at the DPW yard, and allowing them to paint it on weekends.

Councilmember LIESS reported the Senior Advisory Board continues to plan activities for the Fall.

Councilmember CORDONNIER congratulated Lieutenant Briggs on his promotion and commended Chief Post on the police force he has developed for our Township. Councilmember CORDONNIER reported the Block Party was very successful and thanked the Little Falls Business Association, Police Department, DPW, and the ABC. Lastly, Councilmember CORDONNIER provided her comments on the separation of children from their family at the nation's borders.

Councilmember SEBER congratulated Lieutenant Briggs and noted it is nice to live in a community where you are proud of your police force. She announced that the 4th of July Street Fair is approaching and encouraged everyone to stop by the Municipal Alliance booth.

MAYOR'S REPORT

Mayor Damiano reported the Library was successful in obtaining the PSE&G Direct Install grant, which will cover approximately 70% of the cost of replacement of the HVAC system. The Mayor also congratulated Lieutenant Briggs on his promotion and thanked Ms. Shapiro for her dedication to organizing the summer concerts.

Mr. Korotkin requested clarification on Resolution E as to whether it was in reference to the Singac redevelopment plan dated July 21, 2017. Council President SGOBBA confirmed it was the same plan. In response to Mr. Korotkin's comment that the link on the Township website related to that report was no longer available, Mayor Damiano clarified that the link that disappeared regarded the area in the redevelopment study. The plan will be available for public viewing once the Planning Board sets their agenda. In reference to Resolution H, Mr. Korotkin requested clarification as to where the funds came from, how much money is in the Township's Open Space budget line, and more information on the sound improvements that are earmarked in the Resolution. Councilmember CORDONNIER responded that the funds are from the Little Falls Open Space Trust Fund. Mayor Damiano stated that Wilmore Park is utilized as a meeting place for various events and it is always a challenge to find a sound system for these occasions. Additionally, the sound systems will be mobile and purchased through the Co-op. Mr. Cuccia reported the balance of the Open Space fund is over \$400,000.

RESOLUTION APPROVING AND AUTHORIZING EXECUTION OF A SETTLEMENT AND MUTUAL RELEASE AGREEMENT WITH J.M.L., INC., D/B/A J&M TOWING, IN SETTLEMENT OF PENDING LITICATION

WHEREAS, J.M.L., Inc., d/b/a J&M Towing ("JML") is a corporation organized and authorized to do business in New Jersey, including work related to municipal towing; and

WHEREAS, pursuant to a Request for Proposals ("RFP"), the Township of Little Falls ("Township" or "Little Falls") had awarded JML a rotational towing license to undertaking rotational towing within the Township; and

WHEREAS, disputes subsequently arose between the Parties with respect to the scope and performance related to the subject towing license, and other issues pertaining thereto; and

WHEREAS, those disputes resulted in the commencement of litigation by JML, which is currently pending, on appellate remand, in the Superior Court of New Jersey, Passaic County, and captioned "J.M.L., Inc. d/b/a J&M Towing v. the Township of Little Falls, et al.", Docket No. PAS-L-4322-14 (all claims asserted thereunder, the "Litigation"); and
WHEREAS, after ensuing discovery, motion and appellate practice and a consequent remand of this matter, and further discussions between

WHEREAS, after ensuing discovery, motion and appellate practice and a consequent remand of this matter, and further discussions between the Parties respecting the subject matter of the Litigation, the Parties have agreed that it is in their respective, best interests to avoid unnecessary, uncertain and continued protracted litigation and its attendant cost, by reaching an accommodation and settlement of the disputes amongst them; and

WHEREAS, as a result, the Parties desire to resolve all claims and disputes amongst them, without any admission of law or fact against or in favor of any Party, by:

1. a) a release of any and all claims the Township has or could have brought against JML (hereafter the "Township Release"); and, b) the Township's payment to JML of the sum of Thirty-Two Thousand Five Hundred Dollars and No Cents (\$32,500.00); and,

2. A release, by JML, of any and all claims, including those asserted in the Litigation, that could have been asserted against the Township from the beginning of time until the date of the Settlement and Release (hereafter the "JML Release") (the Township Release, together with the JML Release, collectively set forth in the "Settlement Release" in substantially the form which accompanies this Resolution), without any admission of law or fact against or in favor of any Party; and

WHEREAS, subject to the foregoing and as set forth herein and in the Settlement and Mutual Release, the Parties have agreed to amicably resolve, settle and compromise all outstanding issues, disputes and differences they have or may have existing as of the date of the Settlement and Mutual Release, including those that are a part of the Litigation and the Recitals as set forth above and in the Settlement and Mutual Release (including without limit those which are the subject of the Litigation, and all of which are incorporated herein by reference as if

set forth at length herein), in the manner as set forth herein and in the Settlement and Mutual Release, all as authorized by formal action as required by law; and
WHEREAS, in order to effectuate this Settlement, and the resolution of the Litigation, the Mayor and Council are desirous of

executing the Settlement and Mutual Release in substantially the form appended hereto as Exhibit A, and authorizing the Township Attorney and/or special counsel for the Township, to execute a Stipulation of Dismissal as to the Litigation, along with any other necessary filings to effectuate that end.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF LITTLE FALLS IN THE COUNTY OF PASSAIC, as follows:

Section 1. That the Settlement of the Litigation be and hereby is approved on the terms and conditions set forth above, which are incorporated by reference, and which are also reflected within the Settlement and Mutual Release in the form substantially appended hereto as Exhibit A.

Section 2. The Mayor and any other Township officials as identified within the Settlement and Mutual Release, if any, be and hereby are authorized and directed to execute the Settlement and Release with JML, in order to effectuate the Settlement of the Litigation in accordance with the terms and conditions of the Settlement and Mutual Release, same being in substantially the form appended hereto as Exhibit

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq., as amended and supplemented (the "Redevelopment Law"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment and rehabilitation; and

WHEREAS, in accordance with the Redevelopment Law, the Township Council ("Council") of the Township of Little Falls ("Township"), on September 25, 2017 by Resolution No. [F] 17-09-25-#6, designated the Singac Industrial Zone, which consists of property identified on the Tax Maps of the Township of Little Falls as Block 77, Lots 1, 2, 2.01, 3, 4, 5, 6, 6.02, 7, 8, 8.01, 9, 17, 18, 20, and 20.01

("Zone") as an "area in need of redevelopment" and "an area in need of rehabilitation"; and

WHEREAS, in order to effectuate the designation of the Zone, a redevelopment plan must be prepared to set forth specific standards for the planning, development, redevelopment and rehabilitation of properties within the Zone for purposes of improving conditions of properties

WHEREAS, Jeffrey Janota, P.P. of H2M has been engaged to prepare a redevelopment plan for the Zone and same has been or is expected to be received by the Council on or before June 25, 2018; and

WHEREAS, the Local Housing and Redevelopment Law, N.J.S.A. 40A:12A-1 et seq. requires the Council to refer the redevelopment olan to the Township of Little Falls Planning Board ("Board") for a report pursuant to N.J.S.A. 40A:12A-7(e); and
