WORKSHOP MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, June 8, 2020

Council President Sgobba called the meeting to order at 7:00 p.m. with the following members present: Maria Cordonnier, Albert Kahwaty, Tanya Seber, and Christopher Vancheri. Also present were Mayor James Damiano, Township Attorney Joseph Wenzel, Township Administrator Charles Cuccia, and Township Clerk Cynthia Kraus.

Absent: None.

Township Employees present: Police Chief Steve Post.

SALUTE TO THE FLAG

STATEMENT OF PUBLIC NOTICE: Take notice that adequate notice of this meeting has been provided in accordance with N.J.S.A. 10:4-8 and N.J.S.A. 10:4-10 as follows: A notice of the meeting was prominently posted on the bulletin board at the Municipal Building, located at 225 Main Street, Little Falls, N.J. on January 9, 2020. A copy of the notice was faxed to the North Jersey Herald and News and The Record on the same date. Additionally, a copy of the notice was filed in the office of the Township Clerk on said date. This meeting is being conducted under the circumstances surrounding the COVID-19 health situation. No public will be allowed to attend the meeting in person. A Youtube link to view this meeting can be accessed on the Township website at www.lfnj.com. Electronic provisions have been established for the public to participate during the public comment portion of the meeting.

ROLL CALL – Council President Sgobba, Mayor Damiano and Township Administrator Charles Cuccia were present in person. Councilmember Maria Cordonnier, Councilmember Albert Kahwaty, Councilmember Tanya Seber, Councilmember Christopher Vancheri, Attorney Joseph Wenzel, Municipal Clerk Cynthia Kraus, and Police Chief Steve Post attended the meeting remotely.

At this time, Mayor Damiano made a statement in the connection to the death of George Floyd in Minneapolis.

PUBLIC COMMENT – ALL MATTERS

Anyone wishing to address the Township Council may do so by sending an email to CKRAUS@LFNJ.COM. The email must provide your name and address for the record. At this time there will be a ten-minute recess, which will allow the public to send comments and questions via email. At the end of the recess, the Meeting will reconvene and all proper emails will be read into the record. The Council President will determine if a response is needed and if so, shall direct said response. Once the process is complete, we will return to the regular order of business.

It was moved by Councilmember Cordonnier, seconded by Councilmember Kahwaty, that the meeting be and it was opened to the public.

The Council President declared the motion passed.

At this time, Council President SGOBBA announced there will be a ten-minute recess such that questions from the public can be emailed to the Clerk. The Council recessed at 7:10 PM and returned to session at 7:20 PM.

<u>Kevin Barry</u>,110 Island Avenue, thanked the Mayor, Council, and Police Chief for their statement regarding Mr. Floyd.

<u>Howard Lipoff</u>, 161 Main Street, Apt. F, expressed his thanks for the statement made regarding Mr. Floyd.

<u>Luis Fernandez</u> – 54 Harrison Street, questioned whether the Township has seen an increase in the second quarter delinquent taxes due to COVID19. Mayor Damiano referenced an analysis provided by the Tax Collector which demonstrated that as of the last date of the grace period of May 10, 2019 and June 1, 2020, the collection rate was higher this year. The Mayor stated there have been voids in the revenues the municipality receives, therefore the Township will have to be prudent with spending. Mr. Fernandez submitted a comment on Resolution E to which Council President SGOBBA explained the presence of this Agenda Item. Mr. Fernandez posed questions regarding Ordinance No. 1388 to which Mayor Damiano explained the rationale for Phases of the Streetscape project. The Mayor added that most of the money spent is through NJ DOT and similar grants. In response to Mr. Fernandez's last question as to when the public can attend a Meeting, Council President SGOBBA responded it is unknown at this time. Council President SGOBBA elaborated upon the Governor's directives and to need to protect the safety of the residents and public officials.

Renea Shapiro, Little Falls ABC, requested updates on the removal of dead wires on Main Street, Civic Center steps, redevelopment starts, the Paterson Avenue and Walgreen's property, Stevens Avenue and Main Street work, Stanley Street construction, a new MSU entranceway, pubic attendance at Council Meetings, \$700,000 grant project, Recreation Center air conditioning, concerts, and mail in ballots. Ms. Shapiro also queried whether Township marketplace applications, rates, and rules are on the Township website as well as the Township budget. In response, Mayor Damiano explained why there are not many options for the Township to remove the decommissioned wires and reviewed options for the Civic Center steps. The Mayor provided an update on redevelopment projects and

stated he had no information other than environmental work in progress regarding Stevens Avenue and Main Street. Council President SGOBBA provided a status update on Paterson Avenue. Mayor Damiano indicated the owner of the Walgreen's property had purchased an adjacent property but had no other information available. The Mayor reiterated previous updates on parking improvements and Stanley Street. Council President SGOBBA and Mayor Damiano discussed the aspects of the Planning Board application regarding the MSU accessway. Discussion regarding public attendance at Council Meetings was previously addressed. Mayor Damiano explained how to access the introduced and adopted budget on the Township website. Mr. Cuccia stated information regarding fees are listed on the Township website. Mrs. Kraus responded to Council President SGOBBA's query, stating applications and fees continue to be received from vendors and are all up to date. Councilmember SEBER added vendors can reach out to her if they have any questions. Mayor Damiano provided an update on the \$700,000 grant which is part of the Streetscape Plan. Mayor Damiano explained the change order on the Agenda tonight pertaining to the air condition at the Recreation Center and reviewed other considerations such as UV light, which could be sought under the CARES Act. Resumption of concerts will be in line with the Governor's directives. Councilmember CORDONNIER addressed the issue of mail-in ballots and participation in the 2020 Census.

Shannon Zurbruegg, 58 Hudson Street – Questioned whether Little Falls has considered a community citizen review panel for the Little Falls Police Department. Mayor Damiano responded the Township and Police Chief have taken the lead by going through a rigorous accreditation process that took place over a number of years. He referred to a voice mail he received and recommended residents read the accreditation process and information on the Township website, where he believed a lot of concerns would very well be answered because the standards of the Police Department are held to a much higher standard than other surrounding departments.

As no further emails were received for comment, it was moved by Councilmember Cordonnier, seconded by Councilmember Kahwaty, that the meeting be and it was closed to the public.

COUNCIL TOPICS FOR DISCUSSION

Councilmember CORDONNIER stated her support of the statement the Mayor read on behalf of the Council, Mayor and Police Department pertaining to Mr. Floyd.

Councilmember VANCHERI thanked the Mayor for reading the statement at the Meeting's opening. He thanked everyone who helped honor our veterans for Memorial Day through virtual means and highlighted various methods for residents to see the ceremony online. Councilmember VANCHERI discussed means to reach residents for their input on issues being considered by the Transportation Committee as Town Hall Style forums are prohibitive due to COVID19 restrictions.

Councilmember KAHWATY expressed his agreement with the statement read by the Mayor. Councilmember KAHWATY discussed changes at the Recreation Center and provided an update on litter clean up in the Township. He encouraged residents to check on anyone who might be in danger of domestic violence to let them know there is someone to reach out to.

Councilmember SEBER stated the Township has kicked off the Township run market. She thanked the Police Department, OEM, DPW and the Municipal Alliance for their help and encouraged residents to come out to the event.

Mayor Damiano provided a brief COVID19 update. In response to Council President SGOBBA, Mayor Damiano discussed his willingness to consider and work with restaurant owners to maximize outdoor space to provide outdoor dining.
