PLEASE TAKE NOTICE that in accordance with the provisions of the Open Public Meetings Act pursuant to N.J.S.A. 10:4-6 et. seq. you are hereby advised that the Township of Little Falls Planning Board has made the following changes to the regularly scheduled Planning Board meeting of Thursday, December 3, 2020. The meeting will begin at 7:00 p.m. The meeting will be held remotely, by means of communication equipment and services as permitted pursuant to N.J.S.A. 10:4-8b. Formal action may be taken at this meeting. The meeting will be limited to the following matters:

1. Christine and Pablo Gonzalez for property located at 31 Notchcroft Drive, Little Falls, New Jersey and identified on the Township Tax Map as Block 171, Lot 42. Variance relief in connection with construction of an addition to a single-family house.
2. Memorializing Resolution for Lou and Mindi Bekiri for property located at 130 Lincoln Avenue, Little Falls, New Jersey and identified on the Township Tax Map as Block 142, Lot 16.
3. The Planning Board may add other items to the Agenda for this meeting if deemed necessary including, but not limited to approval of Minutes and payment of bills.

The Board Chairman will give the members of the public an opportunity to make any statements at the conclusion of the public hearing process. Your questions will be acknowledged and read into the record and answered.
