**PLEASE TAKE NOTICE** that in accordance with the provisions of the Open Public Meetings Act pursuant to N.J.S.A. 10:4-6 et. seq. you are hereby advised that the Township of Little Falls Planning Board has made the following changes to the reorganization and regularly scheduled Planning Board meeting of Thursday, January 6, 2022. The meeting will begin at 7:00 p.m. The meeting will be held remotely, by means of communication equipment and services as permitted pursuant to N.J.S.A. 10:4-8b. Formal action may be taken at this meeting. The meeting will be limited to the following matters:

1. Reorganization meeting of the Planning Board – to begin at 7:00 P.M.

The Board Chairman will give the members of the public an opportunity to make any statements at the conclusion of the public hearing process. Your questions will be acknowledged and read into the record and answered.
