REGULAR MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, March 10, 2014

Council President Louis Fontana called the meeting to order at 7:30 p.m. with the following members present: Joseph Maceri, William Organisciak, Pamela Porter and John Vantuno. Also present were Mayor Darlene Post, Township Attorney William Northgrave, Township Engineer Dennis Lindsay, Municipal Clerk Cynthia Kraus and Township Administrator Joanne Bergin.

Absent: None

Township Employees present: Police Chief John Dmuchwoski, Fire Chief Jack Sweezy, DPW Superintendent Phillip Simone and Deputy Registrar Marlene Simone

Following the Salute to the Flag, the Statement of Public Notice was read.

STATEMENT OF PUBLIC NOTICE: Take notice that adequate notice of this meeting was provided in accordance with N.J.S.A. 10:4-8 and N.J.S.A. 10:4-10 as follows: A notice of the meeting was prominently posted on the bulletin board at the Municipal Building, located at 225 Main Street, Little Falls, N.J. on January 8, 2014; a copy of the notice was faxed to the North Jersey Herald and News and The Record on the same date; additionally, a copy of the notice was filed in the office of the Township Clerk on said date.

PUBLIC HEARING ON TOWNSHIP'S APPLICATION TO THE PASSAIC COUNTY OPEN SPACE AND FARMLAND PRESERVATION TRUST FUND FOR IMPROVEMENTS TO RAILROAD PARK

Mrs. Bergin said the purpose of this hearing is to obtain public comment regarding the Township's application to the Passaic County Open Space and Farmland Preservation Trust Fund for Improvements to Railroad Park. These improvements include dugouts, bleachers with railings, a half-moon backstop, new fencing and upgrades to the playground area. Interested parties are invited to contribute any comment on this application. The project is part of the Township's overall plans for improvements to parks and recreation using funds from the Passaic County Open Space Trust Fund. The Township made its first application to the trust fund in 2009 and received funds for new backstops and field improvements at the Paterson Avenue recreation complex. Since then, the Township has used its Open Space Committee to identify projects; this has proven to be successful so far. They expect to focus on Louis Street playground next year. She described the improvements in detail, noting that they address safety issues. Council President FONTANA clarified that this project mostly consists of safety improvements.

It was moved by Councilmember Vantuno, seconded by Councilmember Organisciak, that the public hearing be and it was opened.

REMARKS FROM CHAIR

Council President FONTANA informed that the Annual Easter Egg Hunt will be held at the Recreation Center on 4/19/14 from 10:00 a.m. until 12:00 p.m.; he encouraged all to come out for this. He read a letter of commendation,

which was received from NJAPE (New Jersey All People Equal), which is a new program at the Recreation Center. President FONTANA commended Mr. Pace.

Council President FONTANA informed that Administrator Joanne Bergin is leaving the Township. There have been a lot of questions raised as to what will happen next and who will fill the position. They decided that it would be best to split this spot to get the job done in the interim; Mr. Simone and Chief Dmuchowski will split the responsibilities as follows: Mr. Simone will be handling PEOSH and OSHA, Regional Flood Board member, Town Council assistant and liaison to the Mayor; Chief Dmuchowski will handle budget and Finance, Joint Insurance Fund Issues, Office of Legislative Services and human resources. Mr. Macones will be handling the Rent Leveling Board. Mrs. Bergin has agreed to stay as the FEMA Coordinator. She also agreed to handle some of the grant writing and the CRS Program.

Council President FONTANA read the following comments into the record: Joanne Bergin was a rare find. She is someone who genuinely cares about the town of Little Falls, our employees, and our residents. She works unbelievably hard and her work has always been outstanding. She honestly sees us all as her family. She is an answer person. When a problem occurs, she rallies the troops, gets the team together and comes up with the needed result. The town employees have stepped up in a big way to make our town the best that it can be. This is a credit to how Joanne manages the town. She has implemented positive, informative and calculated processes that have improved the way Little Falls resolves issues. Joanne has been outstanding at providing the facts, communicating to all stakeholders and analyzing most every situation. One great example is, prior to Joanne's involvement, preparing the budget was an ad hoc process. Now the budget process is informative and calculated and allows all involved to make the most educated decision possible. She works tirelessly for us all. A typical day for her ends after 7:00 p.m. during the week; plus, she works countless hours at home on the weekends too.

Little Falls has become nationally known for our FEMA work and successful grants, for which we have received millions of dollars, and that is completely because of Joanne's knowledge and writing abilities. Joanne is honest and fair and consistent in dealing with absolutely everything in town. She educates the Council to help us make the most informed decision we can and she is always positive while getting us through some very tough decisions. We simply will not be able to replace Joanne Bergin – it's that simple! We all want the very best for her and we wish her well. Joanne has been an exceptionally hard working and caring employee and manager, and I am very proud to call her my friend. We will all miss her dearly. I hope her next employer understands that they are getting a priceless gem and treats her as such. She will be severely missed by all of Little Falls.

COUNCIL MEMBER REPORTS

Councilmember ORGANISCIAK said he cannot thank Mrs. Bergin enough for all of the work she has done. He expressed his appreciation for all she has done and said she will be missed.

Councilmember VANTUNO thanked Mrs. Bergin for everything she has done, explaining that she has worked tirelessly to move this town forward. He agreed that she would be greatly missed.

Councilmember MACERI said he has had the pleasure of working with Mrs. Bergin, who he commended for all of her hard work as a public servant to the town. He voiced his appreciation for all she has done, noting that she will be missed.

Councilmember PORTER read her comments into the record as follows:

Joanne, you have been an amazing gift to Little Falls. Your passion for this town, your insistence on perfection, your knowledge and the wonderful way you have of making people feel comfortable were made evident with anyone that had any contact with you. Not only are you the best BA any town could ever ask for, you did your job with integrity and kindness every step of the way. I can't tell you how many people in town have expressed to me how much they love you. The amount of people you have touched is truly astounding. How many Business Administrators would take the time to visit residents and/or employees in the hospital – even on your days off and the fact that you travel so many miles each day? Zero; only you would do that. Little Falls is a better place because of you, Joanne, and all that you have done for this town. Your wisdom, many talents, negotiation and communication skills have helped each and every one of us in one way or another. You have been a rock to this Council, keeping us informed of everything we need to know – even on weekends. I know that I will feel a horrible emptiness inside when I walk into this building knowing that you are not here. I will miss that contagious laugh of yours so very much. We will all miss you in a way that words can't describe. You brought us sunshine, even when there wasn't any. There's always a spark of enthusiasm that only you can ignite when you enter a room.

Joanne, we will never be able to replace you in your work ethic or in our hearts. I feel very blessed to have worked with you and even more blessed to know that I have gained a lifelong friend – actually two, as I consider Liam a friend as well. Thank you for loving Little Falls and for all that you've done. I wish you all the best in your new position and know without a doubt that the people of your new town will quickly realize that you are the best! You are classic!

MAYOR'S REPORT

Mayor Post explained that she has worked with Mrs. Bergin for more than two years, adding that they have accomplished many things together. On behalf of the Township of Little Falls, she thanked Mrs. Bergin for her service.

ATTORNEY'S REPORT

Mr. Northgrave agreed that the Township was very blessed to have Mrs. Bergin, adding that she is very unique.

ADMINISTRATOR'S REPORT

Mrs. Bergin provided an update on PSE&G's Northeast Grid Reliability Project, and provided the following website where residents could find updated information on the project: www.pse&g.com/negrid.

Last week the Army Corps of Engineers and the NJDEP held a Passaic River main stream flood risk management meeting in Pequannock, where they discussed recommendations for solutions to the flood problem in the Passaic River Basin. She thanked Dorothy O'Haire for attending this meeting. There will be the following additional meetings, which she will also include on the website: 3/25/14, 3/27/14 and 4/3/14.

At this time, Mrs. Bergin provided explanations of each agenda item. She also gave a presentation regarding Resolution [K].

Mrs. Bergin presented a Power Point report on the budget at this time.

Resolution Authorizing Self Examination of the 2014 Municipal Budget – It was moved by Councilmember Organisciak, seconded by Councilmember Vantuno, that the Council approve the following:

RESOLUTION [A] 14-03-10 - #1

RE: Self Examination of Budget

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5 the Township of Little Falls has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial Officer has determined that the Township meets the necessary conditions to participate in the program for the 2014 budget year.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Little Falls, that the 2014 annual budget be examined in accordance with N.J.A.C. 5:30-7.6a & b and based upon the Chief Financial Officer's certification. The governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, if applicable, the amounts have been calculated pursuant to law and appropriated as such in the budget.
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes
- 2. That the provisions relating to limitation on increases of appropriations pursuance to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at 40A:4-45.3 et seq. are fully met. (Complies with the "CAP" law).
- 3. That the budget is in such form, arrangement and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
- 4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated;
 - b. Items of appropriations are properly set forth
- c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced, publicly advertised, and adopted in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED, that a copy of this resolution be forwarded to the Director of the Division of Local Government Services

<u>Phyllis Dillon</u>, Ryker Avenue, explained that she had initially planned to write a letter to the Council, but she believes this next topic deserves more attention than that. She reminded of the horrible winter they had this year, and pointed out what a magnificent job Mr. Simone and the entire DPW did to make sure the snow and ice was cleared from roads and sidewalks. She explained that Mr. Simone helped to clear snow from the entrance to her driveway so she could get out. She thanked him and the entire DPW staff for their hard work. She also wished Mrs. Bergin luck in her future endeavors.

<u>Joe Bottazzi</u>, formerly 66 William Street, came back to say goodbye and thank Mrs. Bergin, adding that she is the best employee this town has ever had. He explained that he purchased his home 24 years ago in the flood zone, and although flood mitigation is a vicious circle, Mrs. Bergin got the job done; there were many obstacles. If it wasn't for her, many would be in the same situation right now. He thanked her and wished her well.

<u>Mike Corbosiero</u>, 2 Louis Street, said Mrs. Bergin was definitely a worker of the people. He is happy to hear that she will be staying on part-time. He is proud of all of the coordination the town has had during inactive periods to keep improving. He thanked Mrs. Bergin for all of the work she has done and wished her luck.

Louis Fernandez, Harrison Street, said Mrs. Bergin will be missed by all and wished her luck.

Brian Reynolds, Notch Road, said Mrs. Bergin is amazing and thanked her for inspiring this town to do things.

<u>Dorothy O'Haire</u>, Turnberry Road, said she attended the meeting with the Army Corps of Engineers last week; the impression she got is that they are back to the tunnel. They have not made a definite decision. After the meeting, she addressed the Kernel regarding the status of Beattie's Dam. They are not planning to fix the dam at all. She advised everyone to attend one of these meetings at some point. She can't imagine where the state is getting the money for this tunnel. The next day she was with the Army Corp regarding the Peckman River; it looks like 2019 is when they will commence. The Regional Flood Board applied for a \$150,000 grant from the state; they received the grant. They are working to make this go a long way.

No one further having come forward to be heard, it was moved by Councilmember Vantuno, seconded by Councilmember Porter, that the meeting be and it was closed to the public.

The Council President declared the motion passed.

Council President FONTANA thanked Mrs. O'Haire for the update she provided.

Mrs. Bergin said she cannot get her head around saying goodbye. It feels like a lifetime ago that she attended grant training and sat next to John Agostinelli who was running for Mayor in Little Falls. He wanted the Township to be more aggressive in pursuing grants and she was a grant writer. When Mr. Agostinelli lost the election, she expected her role to fade away; however, shortly after, she received a call from Mayor Mike DeFrancisci. Everyone's hopes and dreams for the Township really inspired her and she wanted to be a part of this. From this point, the Township went full force applying for grants and lobbying for funds to help the residents. Any success she had was because of the leaders on the dais. Then came Hurricane Irene and Mayor DeFrancisci forced her to go the flood area with him to talk to the residents. Mayor DeFrancisci taught her to recognize her commitment to people in good times and in bad and to be there for them no matter what. This motivated her to do whatever she could to help these residents. She has been told that her passion for this town is remarkable. She hopes she has served everyone well. She was recently asked about what she considers to be her professional strength and her professional weakness, and it was on in the same. She comes in every day and tries to do the best she can; one thing that sets her apart from a lot of her colleagues is that this job has never been just a job to her. She wants to get things done to benefit the town, she takes things on her plate instead of outsourcing to save money, she tries to shield the employees from the bad parts of working for Municipal Government, Everything she does is with 100 percent of her heart. Every employee who works for this town or who has worked for this town during her time has given something to the tax payers. She commended many of the employees for their hard work and professionalism. She also commended the Mayor and Council members for being public officials of the Township, nothing that they contribute hours of their time to the town. She thanked the Township professionals for all of their hard work as well. She commended the Fire and Police Departments for their contributions to the Township, noting how valuable they all are. The people in this town have touched her heart and she hopes she has given something in return.

Council President FONTANA glossed over the responsibilities of the Administrator's position. He explained that it is a big deal for Mr. Simone and Chief Dmuchowski to take on these duties, adding that they are stepping up in a big way.
