WORKSHOP MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, March 13, 2023

Council President Sgobba called the meeting to order at 7:00 p.m. with the following members present: Christine Hablitz, Michael Murphy, Jayna Patel, and Christopher Vancheri. Also present were Mayor James Damiano, Township Attorney Richard Hawkins, Township Administrator Charles Cuccia, Assistant Administrator Vincent Quatrone, Municipal Clerk Cynthia Kraus

Absent: Deputy Clerk Melissa DePiro.

Township Employees present: Police Chief Bryan Prall.

SALUTE TO THE FLAG

STATEMENT OF PUBLIC NOTICE: Take notice that adequate notice of this meeting has been provided in accordance with N.J.S.A. 10:4-8 and N.J.S.A. 10:4-10 as follows: A notice of the meeting was prominently posted on the bulletin board at the Municipal Building, located at 225 Main Street, Little Falls, N.J. on December 27, 2022. A copy of the notice was mailed to the North Jersey Herald and News and The Record on the same date. Additionally, a copy of the notice was filed in the office of the Township Clerk on said date. Electronic provisions have been established for the public to participate during the public comment portion of the meeting.

PROCLAMATION RECOGNIZING WOMEN'S HISTORY MONTH – Mayor Damiano read the Proclamation recognizing March 2023 as Women's History Month in the Township of Little Falls.

NATIONAL NUTRITION MONTH PROCLAMATION – At this time, Mayor Damiano read the Proclamation recognizing the month of March 2023 as National Nutrition Month in the Township of Little Falls.

RECOGNIZING LADY HORNETS TRAVEL SOFTBALL TEAM – Mayor Damiano recognized members of the Lady Hornets Travel 12U Softball Team on their successful season.

RECOGNIZING PASSAIC VALLEY YOUTH SOFTBALL LEAGUE CHAMPIONS – Mayor Damiano then recognized the members of the Passaic Valley 3rd/4th grade and 7th/8th grade softball teams on their league championship.

PUBLIC HEARING ON TOWNSHIP'S APPLICATION TO THE PASSAIC COUNTY OPEN SPACE AND FARMLAND PRESERVATION TRUST FUND FOR IMPROVEMENTS TO WILMORE ROAD PARK

Mayor Damiano provided history on the submission of successful grant applications to Passaic County for an Open Space and Farmland Trust Fund grant, highlighting the Township has obtained a \$200,000 grant for each year of 2021 and 2022 for Wilmore Road Park Improvements. The intention of the past two years grant has focused on improvements to the park itself including the park and playground. This year's application for the 2023 application is to replace the unsightly port-a-john with the installation of a permanent bathroom at Wilmore Road Park.

It was moved by Councilmember Hablitz, seconded by Councilmember Patel to open the public hearing on the Township's application to the Passaic County Open Space and Farmland Preservation Trust Fund for improvements to Wilmore Road Park be and it was opened to the public.

The Council President declared the motion passed.

<u>Patricia Toomey</u>- Commented on a certified letter pertaining to the project Mr. Cuccia explained when dealing with a park, notification is to be given to the surrounding area around the entire park.

<u>Karen Coussoulis</u> – questioned whether a rendering of the improvement was available for the public to view. Council President Sgobba stated that upon finalization the information would be on the website. Mayor Damiano added that while the project in Little Falls has not been designed at this time, an image of one that has been designed in another town could be shared. In response to Ms. Coussoulis, the Mayor stated the location of the improvement would be in the current area of the port-a-john.

<u>Scott Horoho</u> – Wilmore Road, requested information regarding traffic disruptions and the duration of the project. Mayor Damiano anticipated most of the work would be substantially off the roadway for this project and further reviewed improvements to the park itself. Discussion further ensued regarding 24-hour access, electronic locking mechanisms, annual cost to maintain, number of stalls, unisex vs gender specific and whether resident input would be sought upon grant award.

<u>David Salvatore</u> – Commented on bathroom maintenance and litter in the park. Mayor Damiano reviewed the cost of the improvements and the grants received in the past to offset cost. In response to Mr. Salvatore's queries the Mayor explained the purpose of the public hearing was just to approve the grant application to the County. The Mayor then provided estimated project costs per Mr. Salvatore's request.

<u>Resident #1</u> – Inquired about parking, maintenance, and the expansion of Eagle Rescue Squad. The resident was informed the bathroom will be maintained as necessary. The resident also discussed parking concerns and issues with transients at the NJ transit train station and recommended a time lock and parking ordinance for the park. The Mayor responded to the resident's parking concerns and stated the reference to the railroad station is property of NJ Transit. In response to Council President SGOBBA, the resident stated his opposition to the bathroom improvement. Regarding the Eagle Rescue Squad expansion, Mayor Damiano stated there is an intention for the Township to construct a building to house the ambulances for the operation of the 24/365 EMS. The building would be built on Company No. 1 property.

<u>Arnold Korotkin</u> – In reply to Mr. Korotin, the permanent facility would be handicapped accessible. Council President SGOBBA then responded to Mr. Korotkin's query regarding a subsequent hearing and availability of project details for the public.

<u>Robert Doeg -</u>168 Wilmore Road, stated his support of the grant and commented on litter. In response to Mr. Doeg's question regarding the opportunity for the public to have input on the park, Councilmember Hablitz explained the role of the Open Space Committee and requested Mr. Doeg provide names of those residents who request involvement. Mayor Damiano then responded to Mr. Doeg's statements regarding a timetable on construction, and whether Hurricane Ida relief funds could be applied. Council President SGOBBA discussed the issue of litter and the removal of trees. Mayor Damiano further elaborated on the removal of trees.

<u>David Salvatore</u>- Discussed removal of trees. Mayor Damiano responded to Mr. Salvatore noting that the trees were hollowed out by beetles.

<u>Greg Shark</u> – Expressed concern about the size of the restroom improvement, encouraged the restroom to be closed after park hours, and questioned whether the grant could also be allocated towards the playground restoration. Mr. Sharked expressed his support for the bathroom. Mayor Damiano clarified that the County in the past has allowed funds to be pivoted if possible. Council President SGOBBA stated the bathroom would be regulated to events and open for those events such as ABC concerts in the park. In response to restroom size, Mayor Damiano explained no more than 2 stalls would be necessary.

<u>Gene Reda</u> – Stated his support of the application for the grant and the bathroom improvement. Mr. Reda made comments regarding protection of the property, vandalism and littering, and a timeline for improvements. Mayor Damiano stated the intention of installing cameras in the park when improvements are made. Also, as part of the overall park improvements, he believes next spring is a reasonable timeframe to have that park up and running assuming there are not additional supply chain issues. In response to Mr. Reda's request for a status on the foot bridge, Mayor Damiano provided an update he received from the County Engineer, noting it has gone out to bid.

<u>Karen Coussoulis</u> – Commented on the foot bridge to which Mr. Cuccia explained since it is a county program, the Township is waiting as well. Council President SGOBBA added that as information comes to the Township it will be shared with residents.

<u>Tricia Toomey</u>- Expressed she is in favor of the bathroom and questioned placement of the bathroom improvement. Mr. Cuccia stated it will sit on the same site as the existing park.

<u>Joe Vasta</u> – Commented there is not enough information available to vote to which Council President SGOBBA reiterated the purpose of the hearing tonight. The Mayor then responded to the request for cost information. Mr. Vasta then stated if the bathroom is a reasonable size, he supports the bathroom improvement.

<u>Joseph Koterba</u> – Third Ave – Expressed concerns about vandalism and suggested the bathroom be shut down in winter months. He stated his support if the structure is smaller. Council President SGOBBA responded to concerns of safety, vandalism and water issues noting they will be examined.

<u>Al Kahwaty</u> –Stated his support of an upgrade to the bathrooms.

<u>Ken Hart</u>- Wilmore Road – Expressed concern regarding the bathroom taking room away from the playground area. Mr. Cuccia explained the improvement will be in the fence line so the other equipment would have to be configured against it. Council President SGOBBA addressed the concern of vandalism.

Councilmember HABLITZ and Mr. Cuccia elaborated on the placement of the bathroom. Mr. Cuccia stated there is no change to the bike path. Mayor Damiano added the new playground is to be installed where the current playground equipment is. The bathroom would be installed just outside the current playground footprint. Councilmember MURPHY discussed his support once the renderings are obtained and the size is reasonable.

<u>Greg Shark</u> – In response to Mr. Shark, Council President SGOBBA stated information regarding the design of the project, such as images, would be on the Township website when available.

No one having come forward to be heard, it was moved by Councilmember Murphy, seconded by Councilmember Hablitz, that the meeting be and it was closed to the public.

MAYOR'S BUDGET PRESENTATION

Mayor Damiano provided an overview of the 2023 Municipal Budget which included highlights of the municipal appropriations, reserve for uncollected taxes, debt service, budget revenue, and the amount to be raised by taxes. The Mayor announced the budget will be introduced at the March 27th Meeting and a public hearing and adoption is slated for April 24th.

Per Council President SGOBBA's request, Mr. Cuccia explained that the Fund Balance is the amount of money the Township retains after the results of operations on a regular basis.

ITEMS TO BE DISCUSSED:

MAYOR/ADMINISTRATOR:

- 1. RESOLUTION AUTHORIZING TAX APPEAL SETTLEMENTS ON SEVERAL PROPERTIES -Mayor Damiano explained the routine nature of this Resolution as a result of tax appeals. In response to Council President SGOBBA, Mayor Damiano explained the landowners have the right to go back three years after filing. Landowners that did go for the appeal cannot appeal for another three years. The Mayor confirmed the amount of the appeals per the request of Council President SGOBBA and noted the amount of taxes are substantial and that is why the amounts are significant. Lastly, the Mayor reviewed the settlement with MSU noting it was a substantial and significant settlement.
- 2. RESOLUTION AUTHORIZING APPLICATION TO THE PASSAIC COUNTY OPEN SPACE AND FARMLAND PRESERVATION TRUST FUND FOR IMPROVEMENTS TO WILMORE ROAD PARK - Mayor Damiano reviewed this resolution highlighting that most residents heard by the Council tonight were in favor of the application being submitted to Passaic County with the understanding some additional input is necessary to determine the size and location.
- 3. RESOLUTION AUTHORIZING THE SALE AT PUBLIC AUCTION OF THE TOWNSHIP'S PERSONAL PROPERTY - Mayor Damiano stated the Township has a 2011 Ford F450 4x4 Pickup Truck that is no longer usable by the Township and will be put up to auction.
- 4. ORDINANCE NO. 1449 - AMENDING CODE CHAPTER 71 - BIKE RODEO FEES - The Mayor explained the Bike Rodeo requires that if there are donors, an ordinance must be passed such that the Township can accept gold, silver and bronze donations at \$500, \$250 and \$150.
- 5. ORDINANCE NO. 1450 PARKING PROHIBITIONS ON MUNICIPAL AND BOARD OF EDUCATION PROPERTY - The Mayor explained the history of the ordinance to allow the Police to have enforcement authority to have vehicles removed from lots, including the PNC lot which the Township had recently acquired.
- 6. ORDINANCE NO. 1451 PARKING TIME LIMITED ON CERTAIN STREETS Mayor Damiano discussed items #6,7,8 & 9 in conjunction with one another, providing depictions to describe the areas encompassed by the Ordinances.
- ORDINANCE NO. 1452 PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS 7.
- ORDINANCE NO. 1453 AMENDING CODE CHAPTER 7- HANDICAPPED PARKING Mayor 8. Damiano described this Ordinance involves placement of a handicap parking space on the most eastern spot of the north parking spaces on Main Street between Stevens Avenue and Center Avenue, which would provide the ability to park closer to the crosswalk and curb cut out.
- ORDINANCE NO. 1454 AMENDING CODE CHAPTER 7 LOADING ZONE Mayor Damiano Described how this Ordinance would include the addition of a loading zone most west on the northern side of Main Street. In response to Councilmember VANCHERI, the Mayor explained the double yellow line will be moved further south closer to Stevens Avenue and moving the stop bar further would make turns for buses easier. Additionally, the bus stop in front of Valley would remain. Councilmember MURPHY discussed his experience with the intersection and commented that the removal of parking spaces and modifications to the area is warranted in that area in this situation. In response to Councilmember HABLITZ, the Mayor stated space is fitted for a commercial vehicle and will be marked accordingly.

The next Friends of the Library Meeting will host an open house for new members on March 21st. Lastly, applications are being accepted for the upcoming Farmers Market.

Councilmember VANCHERI provided a Transportation Committee update which was joined by Commissioner John Bartlett to discuss the Route 3/46 construction project. He reported the project should be completed by this November. Councilmember VANCHERI further announced preparations are being made for the Autism Awareness month flag raising on April 1st, Town Hall outdoor lighting next week will represent the start of Ramadan, and plans for Memorial Day weekend are in progress.

Council President SGOBBA highlighted the upcoming St. Patrick's Day event sponsored by the Senior Advisory Board. Council President SGOBBA announced a workshop discussing ankle and foot pathologies will occur on March 31st.
