Council President Anthony Sgobba called the meeting to order at 7:00 p.m. with the following members present: Maria Cordonnier, William Liess, and Chris Vancheri. Also present were Mayor James Damiano, Township Attorney Joseph Wenzel, Township Engineer Dennis Lindsay, Township Administrator Charles Cuccia and Township Clerk Cynthia Kraus.

Following the Salute to the Flag, the Statement of Public Notice was read.

INTRODUCTION AND CONVERSATION WITH CANDIDATES TO FILL COUNCIL VACANCY

At this time Council President SGOBBA requested Mr. Radcliffe, 239 Long Hill Road, introduce the prospective candidates for the Council vacancy.

Mr. Radcliffe introduced former Councilmember Mercedes Gonzalez. Mercedes Gonzalez, 47 Jacobus Avenue, responded to Councilmember CORDONNIER's query regarding transparency and second public comment. She stated her absence from Council was correlated to personal health issues as well as taking care of her mother who recently passed away. In response to Councilmember VANCHERI, Mrs. Gonzales responded she offered teamwork, participation, and cooperation.

Mr. Radcliffe introduced Mike Murphy, who provided his background. Councilmember VANCHERI asked what he could contribute to the Council. Mr. Murphy, 21 Mountaintop Terrace, described his membership on the LFPD and the PCRO Committee. Councilmember VANCHERI and Council President SGOBBA questioned whether Mr. Murphy's dedication to the Fire Department would interfere with his service to the Council. Mr. Murphy provided assurance that his time management skills, coupled with the availability of other dedicated volunteer firefighters, would enable him to fulfill the requirements of Councilmember.

Mr. Radcliffe was asked to answer questions on behalf of the third candidate, Marc Benitez, who was out of the country on job-related business. Mr. Radcliffe noted Mr. Benitez travels once a quarter for two weeks. In response to Councilmember VANCHERI's question regarding what Mr. Benitez would contribute to the Council, Mr. Radcliffe stated Mr. Benitez has been a resident since 2011 and could bring a fresh perspective. To answer Councilmember CORDONNIER's query regarding transparency, Mr. Radcliffe stated Mr. Benitez would take the new procedure as a positive.

Councilmember SGOBBA explained the Councilmember seat is for an unexpired term until 12/31/17. Council President SGOBBA opened nominations to fill the Council vacancy. It was moved by Councilmember Cordonnier, seconded by Councilmember Vancheri, to nominate Marc Benitez to fill the Councilmember vacancy. No other nominations were made.

Council Ad-Hoc Committees:

<u>Technology Committee</u> Community Representatives (1) Mike Votko

COUNCIL MEMBER REPORTS

Councilmember VANCHERI reported on the progress of the Wildlife Committee. He met with the DPW to discuss signage and with Clifton Animal Control to discuss initiatives regarding the deer population. Additionally, the

abundance of geese at parks, particularly Duva field, was broached. Among the options proposed to ward off the geese were volunteer dog walkers and a sonic goose repellent system. The latter, provides a humane method to make the area uninhabitable to geese by generating a customizable audio. Lastly, a wasp problem occurring during the summer months at Duva field will be addressed with the DPW.

Councilmember VANCHERI announced the Technology Committee has been collaborating with a new vendor to develop a user friendly, attractive website that may also provide the feature to pay taxes online. He also declared the Passaic County Flood Advisory Board convened, and will invite individuals with prior flood experience to future meetings to glean knowledge and obtain best practice methods. Councilmember VANCHERI hoped to present proposals from all three Committees in the next few months.

Councilmember CORDONNIER stated the Transportation Committee will convene on Thursday, March 30, 2017. The Committee is working on a proposal focusing on street devices to make streets safer. This Thursday's topic will focus on crosswalks. The Open Space Committee has focused on installing streetlights in Memorial Park, in addition to upgrading the garbage cans in the center of town and in the park. Councilmember CORDONNIER expressed that while the Grant Committee does not convene every month, the members are constantly working on finding innovative grants. She referenced one such grant Committee member Arnold Korotkin found with Best Buy to provide laptops for an after school or library summer program.

Councilmember LIESS stated the Senior Advisory Board has been discussing collaborative efforts with Montclair State University which are slated to commence in April. All events will be advertised to give residents adequate notice.

MAYOR'S REPORT

Mayor Damiano read a thank you card received by the Mayor and Council from Anthony Englehardt for the all support he received while going through treatment.

At this time, Council President SGOBBA summoned a motion and second to approve Resolutions A and B.

 - a. All estimates of revenue are reasonable, accurate, and correctly stated;

 - c. In itemization, form, arrangement, and content the budget will permit the exercise of the comptroller function within the municipality.

The budget and associated amendments have been introduced, publicly advertised, and adopted in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of <u>N.J.S.A.</u> 40A:4-5 shall not prevent such certification.

<u>Donald Radcliffe</u>, 239 Long Hill Road, stated his understanding that the new ambulance service was a profit center, yet it has been budgeted as a deficit. Mayor Damiano explained the former ambulance service cost the Township between \$70,000-\$80,000 to fund supplies and various required equipment. Additionally, with the new service, the Township did not have a full calendar year worth of lag time between when the first bill went out and the when the bill got paid. Rather than estimate a break even or revenue generator in the first budget including a full calendar year of ambulance services, the budget was formulated using the current data to avoid a potential shortfall at the end of the year. Nonetheless, the Mayor anticipated the revenues to be higher than budgeted.

The Council President declared the motion passed.

Council President SGOBBA requested Mr. Cuccia expound upon the meaning of a cap bank. Mr. Cuccia explained that each year the Township is required to calculate how much appropriations can increase based upon the statutory requirements. The unused amount of money of the limit of appropriations goes into the bank to be used for the following year. The funds are held for two years, and falls off in the third year, therefore the most recent two years create the cap bank.

It was moved by Councilmember Cordonnier, seconded by Councilmember Vancheri, that the Ordinance No. 1277 be and it was adopted.

<u>Roland Dey</u>-58 Main Street, representing the American Legion, requested the Parade Committee commence planning as soon as possible. He notified the Council that the band has increased its price, therefore he requested the increase be reflected in and approved within the budget.

Council President SGOBBA requested all the finances associated with the parade be discussed with the Parade Committee and presented to the Council as a whole. At this time, Mayor Damiano appointed Chris Vancheri as the liaison for the Parade Committee. Council President SGOBBA requested Mr. Dey bring forth the expenses the Committee would like to have approved for the next Council Workshop meeting.

<u>Renea Shapiro</u>, Little Falls ABC, requested clarification of the recycling requirements for businesses and residents, specifically whether compliance measures exist for the recycling program.

Mr. Simone stated businesses and residents are required to recycle under State statute, under County regulations, and under the Township Code Book. Every year businesses must file a recycling report with the DPW office, which is compiled and forwarded to State. In return, the Township receives a recycling tonnage grant. Additionally, the DPW secretary has sent questionnaires and letters to businesses regarding recycling on an ongoing basis. Mr. Simone declared the Township has a very aggressive recycling program. Additionally, though some residents may not put recycling for collection outside their house, Mr. Simone stated they do bring it down to the recycling center. If a business is not recycling the DPW addresses the situation. The recourse for residents is to fine them but they are normally advised as to proper procedures by the DPW.

Ms. Shapiro questioned if there was a program to help senior residents clear the snow.

Council President SGOBBA stated a volunteer program might be a possibility which he will discuss with the Mayor. He requested Ms. Shapiro supply data on the amount of residents in need.

Ms. Shapiro raised the issue of snow removal hampered by cars parked in the municipal lot behind the stores. Mayor Damiano responded that he has discussed some possibilities with Mr. Simone to require residents to park in designated areas during the snowstorm, and then remove them 24 hours after snowfall concluded to enable DPW cleanup. The Mayor confirmed this issue is under review and may require changes in ordinance.

Lastly, Ms. Shapiro invited everyone to the Town Tasting on Tuesday night hosted by the ABC.

Councilmember CORDONNIER stated she has had discussions with Ms. Shapiro regarding issues with seniors and parking in the municipal lot behind the stores. She expressed the importance of addressing these issues. Council President SGOBBA asked Mr. Liess to bring forth the topic of clearing snow to the next Senior Advisory Committee. Councilmember VANCHERI suggested using social media to get the word out when someone needs help plowing or shoveling. Council President SGOBBA stated the Council will look into this.

<u>Gene Kulick</u>, 74 Grove Street, stated that, in the past, the County was called to help out people who needed shoveling. In addition, Mr. Kulick asked how much reimbursement the Township received for recycling.

Mr. Simone itemized the recyclables the Township received reimbursement for, including newspaper, cardboard, and aluminum. Mr. Simone to provide more specific reimbursement information at the next Meeting.

Mr. Kulick discussed parking at the Library and recommended the Old Police station be knocked down to allow for more parking.

Lucille Clifford, 159 Main Street, stated parking near the Library from 8AM-4PM is not available. She attributed the lack of parking to the relocation of the Police Station.

<u>Marie Sgobba</u>, 6 Greenbriar Road, stated her experience with insufficient parking near the Library and the Civic Center was similar to those expressed.

At this time Council President SGOBBA commended Chief Post on the helpful behavior of one of his officers, who after the last snowfall, assisted getting a car that was illegally parked up the road.

No one further having come forward to be heard, it was moved by Councilmember Cordonnier, seconded by Councilmember Vancheri, that the meeting be and it was closed to the public.

In that decision, the New Jersey Supreme Court transferred primary jurisdiction over affordable housing matters from the New Jersey Council on Affordable Housing ("COAH") to the New Jersey Superior Courts, and established a transitional process for municipalities, like the Township of Little Falls, to file declaratory judgment actions seeking to declare their Housing Element and Fair Share Plans ("HEFSP") as being constitutionally compliant and to seek the judicial equivalent of substantive certification, which has been deemed by the Court to be a Judgment of Compliance and Repose and accompanying protection as provided under the Fair Housing Act of 1985; and

WHEREAS, on July 7, 2015, in accordance with the Supreme Court's decision, the Township filed a declaratory judgment action that is captioned, In the Matter of the Application of the Township of Little Falls, , a municipal Corporation of the State of New Jersey , Docket No. PAS-L-2438-15; and

WHEREAS, in that filing, the Township also sought a determination from the Superior Court regarding the Township's future use and disposition of the Township's Affordable Housing Trust Funds, as directed by the New Jersey Appellate Division in the case, In Re Failure of the Council on Affordable Housing to Adopt Trust Fund Commitment Regulations, Docket Nos. A-5257-11T4 and A-0122-13T3.; and

WHEREAS, the Township agreed by prior Resolution, to enter into a Settlement Agreement with the Fair Share Housing Center, which was executed by the Parties in December, 2016 and requested that the Superior Court, Passaic County, find that the Settlement Agreement, and the Township's approach to meeting the Township's Prior Round and Third Round Mount Laurel obligations, as detailed therein, are fair to the interests of lower-income New Jersey households and entitle the Township to protection from Mount Laurel litigation for a period of ten (10) years from the Order entered by the Court approving that Agreement; and

WHEREAS, by Order issued by the Court on December 22, 2016, Judge Brogan approved the Settlement Agreement and approved the December 2016 HEFSP on the grounds that they are fair to the interests of the Region's low and moderate income households and is in accordance with the criteria set forth in East/West Venture v Borough of Fort Lee, 286 N.J. Super. 311 (App. Div. 1996); and

WHEREAS, the Court's approval of the HEFSP was subject to satisfaction of certain actions by the Township and the Planning Board;
