Monday, March 9, 2020

Council President Anthony Sgobba called the meeting to order at 7:00 p.m. with the following members present: Maria Cordonnier, Albert Kahwaty, Tanya Seber, and Chris Vancheri. Also present were Township Attorney Joe Wenzel, Township Engineer Tom Lemanowicz, Township Administrator Charles Cuccia, Municipal Clerk Cynthia Kraus, and Deputy Clerk Melissa DePiro.

Absent: Mayor James Damiano and DPW Superintendent Phillip Simone.

Township Employees present: Police Chief Steve Post, Fire Chief Jack Sweezy, and Director of Recreation John Pace.

He also stated one of the handicapped parking spots on Main Street has a telephone pole that blocks the passenger from exiting the vehicle. Mr. Cuccia indicated street sweeping is scheduled by Mr. Simone. Council President SGOBBA stated the parking spot of concern will be inspected and the Council will follow-up.

ITEMS TO BE DISCUSSED: MAYOR/ADMINISTRATOR:

In the Mayor's absence, Mr. Cuccia reported the Township website has an advisory on the coronavirus under the Health Department. Everyone was encouraged to review it.

- 1. FOOD ESTABLISHMENT ORDINANCE AMENDMENT Mr. Cuccia explained the ordinance has been enhanced to include additional definitions and handling of temporary events for food service. Mr. Cuccia stated it is requested that it be introduced tonight.
- 2. PUBLIC AUCTION OF VEHICLES/EQUIPMENT Mr. Cuccia explained that there is a surplus of equipment and therefore there a request was made to go out for auction.
- 3. EMS BILLING ORDINACE UPDATE Mr. Cuccia elaborated the ordinance update will increase fees in line with an increase in costs. Councilmember CORDONNIER requested clarification on charges for residents versus non-residents. Mr. Cuccia stated everyone is billed. There is no balance billing for residents.
- 4. RETURN OF ESCROW RESOLUTION Mr. Cuccia explained this resolution pertains to 44 Main Street. The Township is now settling the final bills to the various engineers to make sure the building was completed as intended.
- 5. BOND ORDINANCE FOR REFUNDING TAX APPEALS Mr. Cuccia recalled the history of the tax appeal and need to introduce a bond ordinance for a recent tax appeal refund. Mr. Cuccia then provided a detailed explanation of the specific case and procedural process. In response to Councilmember KAHWATY, Mr. Cuccia elaborated on how the bond payments impact the taxpayer.
