- 1. RESOLUTION ESTABLISHING ELECTRONIC TAX PAYMENTS POLICY Mayor Damiano stated this Resolution updates the policy to allow residents to pay their taxes online and establishes a procedure when there are insufficient funds or incorrect information is provided.
- 2. FEE ORDINANCE AMENDMENT RECREATION PROGRAM FEES Mayor Damiano explained the Resolution will generate revenue while creating more structure for the use of all the recreation spaces in the Township. Councilmember VANCHERI thanked John Pace and Tyler Passero for their work on the Resolution.
- 3. ORDINANCE AMENDING CHAPTER 126 (LITTERING) The Mayor indicated this Resolution addresses the delivery of papers such as the Passaic Valley Today in an effort to eliminate unwanted paper in driveways and storm drains. Councilmember VANCHERI thanked the Mayor for the Resolution. Mr. Wenzel clarified that it does not affect door-to-door door dropping.
- 4. RESOLUTIONS AUTHORIZING CDBG APPLICATIONS -Mayor Damiano stated there are two separate CDBG (Community Development Block Grant) applications to Passaic County. The Township uses CDBG grants for road improvements. The streets applied for this year include Cherry Street, Mozart Avenue as well as Stinson Place. The Mayor reviewed the application of CDBG grants and how projects are identified.

#### 136. XI. Consistency, Severability and Repealer

(A) If any provision or portion of a provision of this ordinance is held to be unconstitutional, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the ordinance shall not be invalidated.

(B) All ordinances or parts of ordinances, which are inconsistent with any provisions of this ordinance, are hereby repealed as to the extent of such inconsistencies.

(C) No provision of this ordinance shall be construed to impair any common law or statutory cause of action, or legal remedy there from, of any person for injury or damage arising from any violation of this ordinance or from other law.

NOW, THEREFORE, BE IT ORDAINED by the Municipal Council of the Township of Little Falls, Passaic County, State of New Jersey, as follows:

The aforementioned recitals are incorporated herein as though fully set forth at length.

The Municipal Council hereby amends Chapter 71 of the Code entitled Fees of the Code of the Township of Little Falls.

- It is the intent of the Municipal Council to incorporate the additions and/or supplements contained in this Ordinance in to the Code. All of the remaining provisions in Chapter 71 of the Code entitled Fees of the Code shall remain unchanged and have full force and 3. legal effect. All other ordinances enacted and inconsistent herewith are hereby modified pursuant to the terms of this Ordinance.
- If any section, paragraph, subdivision, clause, sentence, phrase or provision of this Ordinance is declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.
- A copy of this Ordinance shall be available for public inspection at the offices of the Township Clerk.

  This Ordinance shall take effect after twenty (20) days of its final passage by the Municipal Council, upon approval by the Mayor and publication as required by law.

#### TOWNSHIP OF LITTLE FALLS ORDINANCE NO. 1401

AN ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS, IN THE COUNTY OF PASSAIC, STATE OF NEW JERSEY, TO AMEND CHAPTER 126 (LITTERING) OF THE CODE OF THE TOWNSHIP OF LITTLE FALLS

WHEREAS, unsolicited materials can become the cause of rubbish strewn upon the streets and sidewalks of the Township resulting in not only a poor appearance but also result in clogging stormwater inlets placing persons and property in danger of flooding,

WHEREAS, it is necessary to update and amend the Municipal Code to address this concern; and WHEREAS, the Township Council has found it proper to amend the language of the Code accordance therewith;

NOW THEREFORE BE IT RESOLVED by the Township Council of the Township of Little Falls, that Chapter 126, Littering, of the Code of the Township of Little Falls, is hereby amended and supplemented as follows: §216-15 UNSOLICITED MATERIALS

on shall east or place or cause to be co nt, handbill, circular or paper on any public street, on any vestibules or yards, upon porches of any dwelling house or other buildings, or into any vehicle while on the public highways or on private property within the Township, except that this section shall not apply to newspapers and addressed envelopes delivered to subscribers and addresses. Advertisements, handbills, circulars and papers may be distributed in the Township, provided that they are securely placed at each dwelling so as not to be blown away by the wind.

Definitions. As used herein, the following terms shall have the meanings indicated:

PRINTED MATTER: Any and all of the following: circulars, handbills, notices, cards, newspapers, magazines, pamphlets and leaflets. UNSOLICITED DISTRIBUTION: Free distribution not previously requested by the person to whom distribution is intended.

The following standards for the unsolicited distribution of printed matter and product samples, other than newspapers, are hereby established in the Township of Little Falls:

(1) No printed matter or product samples shall be placed, thrown or discarded by any person upon any public street, road, avenue, park, or other public place or upon the lawn, driveway or in the yard appurtenant to any residence or other building located therein or upon any field or other open space within the Township.

- (2) No printed matter or product sample shall be distributed or caused to be distributed by any person at any residence or other building unless such printed matter or product sample shall be delivered into the possession of some person there offering to receive same placed in a slot or receptacle provided on the premises for the receipt of same or be placed within five feet of a door or entranceway of such residence or other building.
- (3) No person shall distribute or cause to be distributed any printed matter or product sample upon the premises of any residence or other building known to be vacant by the person distributing or causing to be distributed such printed matter or product samples.
- Notwithstanding the foregoing restrictions of Subsection B, the delivery of unsolicited newspapers shall be subject to the following restrictions:
- (1) No delivery shall be made to any residence where notice has been given by the owner or occupant to the publisher of such newspaper to cease delivery to the specific site. Where no such notice to cease delivery has been given, deliveries shall be made in the following manner:
  - (a) With respect to those residences where public sidewalks exist, delivery shall be made beyond a line created by the interior line of the sidewalk extended through the entire frontage of the property.
  - (b) With respect to those residences which do not have public sidewalks, delivery shall be effected by delivery of the newspaper beyond the edge of the pavement of the street abutting the front property line.
- (2) In the case of garden-apartment-type structures with common areas, delivery, when permitted, shall be prohibited in the parking any streets or on any private access driveways.
- (3) In the case of distribution of an unsolicited newspaper, the newspaper shall include within its pages a notice setting forth the telephone number and address where a recipient may contact the newspaper to resolve any distribution questions or problems. The notice shall be a minimum 10 point type in size and shall appear in each edition of the newspaper. This telephone number or address so published shall be the means by which notices for the cessation of delivery can be made by the recipient to the publisher.
- (4) There shall be no intentional delivery whatsoever of any such unsolicited printed matter to premises after the owner or occupant of which premises has notified the publisher or the delivery person or, in the case of printed matter referred to in Subsection C(3) hereof, after the owner or tenant of the premises has notified that person indicated in the printed matter to be the person having authority to cease further delivery of the same at the address or telephone number so indicated, that such delivery shall cease or be suspended for a stated period of time, or in violation of the provisions of this Subsection C.
- This section shall not apply to the distribution of printed matter or product samples that shall have been previously ordered or requested by the owner, tenant or occupant of the premises where such distribution is made or to the distribution of printed matter or samples of merchandise by mail.
- No person shall throw, cast or distribute or cause to be thrown, cast or distributed any printed matter or product sample upon any stoop, porch, patio, stairs or in any vestibule or hall of any residence or other building in such a manner or in such position that the same may be blown, carried or deposited by wind or otherwise in or upon any street or public place or into any yard or onto any open portion of any residence or other building.

  NOW, THEREFORE, BE IT FURTHER ORDAINED that:

- Ordinances, resolutions and regulations or parts of ordinances, resolutions and regulations inconsistent herewith are hereby repealed to the extent of such inconsistency; and
- If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by a court of competent jurisdiction, such a decision shall not affect the remaining portion of the Ordinance; and Except as hereby amended, the Code of the Township of Little Falls shall remain in full force and effect.
- This Ordinance shall take effect twenty days after final passage and publication in accordance with law.

#### COUNCIL TOPICS FOR DISCUSSION

Councilmember VANCHERI announced a list of addresses for consideration of stop signs have been reviewed with the Police Chief and were forwarded to the Mayor for review. Councilmember VANCHERI then thanked Chief Post for addressing a resident's concern regarding speeding. Councilmember VANCHERI provided an update on Memorial Day plans. He then discussed a call with the COO and General Manager of the NJ Jackals to discuss the return of Little Falls Night at a Jackals game sometime in July, 2021. Councilmember VANCHERI thanked Mr. Pace and Mr. Passero for their effort to get the spring programs up and running. In honor of Women's History Month, he recognized Councilmember Hablitz and Councilmember Seber as well as several leaders in the community such as Freeholder Sandi Lazzara, County Clerk Danielle Ireland-Imhof, State Senator Kristin Corrado, and Congresswoman Mikie Sherrill.

Councilmember KAHWATY thanked Mr. Barry and Ms. Schumacher for their comments and the information they provided. He recognized all of the women in the past year who have done so much to keep our society and families going. Councilmember KAHWATY stated more flyers about how to help with domestic violence have been placed throughout the Town. He also expressed his gratitude for the Littering Ordinance. Councilmember KAHWATY announced PVHS is seeking donations for Operation Graduation and provided information for the fundraising tricky tray on April 22, 2021.

Councilmember SEBER commented on International Women's Day. The Open Space Committee met and is hoping to meet in person to conduct a site tour of parks and other areas in April.

Councilmember HABLITZ thanked the Mayor and Council for acknowledging the diversity and accomplishments of our community. She commented on International Women's Day and her pride to be able to serve the community. The Library is convening their Board of Trustee meeting this Thursday via ZOOM. During the month of March, the Library is sponsoring a food drive in conjunction with the Woodland Park and Totowa libraries and the office of Senator Corrado to benefit St. Agnes food pantry. Councilmember HABLITZ added that the Library continues to conduct their activities virtually.

Council President SGOBBA announced the Senior Advisory Committee is planning an outdoor concert in the Ciivc Center parking lot in May. More activities are being planned and details will be forthcoming. Council President SGOBBA toured the Township with Clean Streets Coordinator Ron Stell to review focus areas to reduce litter. Council President SGOBBA thanked Mrs. Kraus, Mrs. DePiro, and Mr. Cuccia for assisting with tonight's Meeting and acknowledged the presence of Chief Post and former Mayor Sam Seber.

There being no further business to come before the meeting, it was moved by Councilmember Kahwaty, seconded by Councilmember Seber, that the meeting be and it was adjourned at 7:54 p.m.
