Council President Anthony Sgobba called the meeting to order at 7:00 p.m. with the following members present: Christine Hablitz, Michael Murphy, and Christopher Vancheri. Also present were Mayor James Damiano, Township Attorney Joseph Wenzel, Township Administrator Charles Cuccia, Assistant Administrator Vincent Quatrone, and Deputy Clerk Melissa DePiro.

ITEMS TO BE DISCUSSED:

MAYOR/ADMINISTRATOR: At this time, Mayor Damiano complimented the DPW on recent additions to the downtown streetscape including banners for the Hometown Heroes project and decorative wreaths. The Mayor then highlighted the November 25th Holiday Light parade route and emphasized the need to be aware of road closures. Mayor Damiano announced the Township has received a grant from the NJDOT in the amount of \$644,000 for continuation of the Streetscape program. The Mayor added decorative holiday banners have also been ordered and will be added to the decorative light poles.

- 1. COUNCIL TOPICS FOR DISCUSSION

Councilmember MURPHY provided a progress report on the Township calendar. He then discussed development of an Ordinance in collaboration with Chief Prall to address mass gatherings to ensure both safety and adequate resources are available. In response to Council President SGOBBA's inquiry, Councilmember MURPHY explained calendars are expected to be mailed in January and will include 13 months. In response to Councilmember VANCHERI's query, there will be extra copies at Town Hall and a pdf available on the website as well.

Councilmember HABLITZ reviewed recent Library events and highlighted upcoming events including the New York Speaker Series on November 14th, and the second meeting of the Garden Club on November 20th. Councilmember HABLITZ discussed a grant the Township received for 5,000 daffodils and 10 new trees and thanked all those who helped obtain the grant and perform the planting.

Councilmember VANCHERI reviewed the annual Veteran's Day services led by American Legion Post 108 and discussed the Hometown Heroes program. Councilmember VANCHERI provided an update on the Transportation Committee regarding the location of the speed humps on Houston Road, and noted the Engineers are reviewing potential locations for speed humps throughout the Township.

Council President SGOBBA reviewed the Hometown Hero program noting those individuals who currently have a silhouette will be replaced with a photo should one be obtained. The second phase of the program will include those who have been discharged and retired from the services, and will begin in the spring as those applications come through.

Police Chief Prall reported results of the application for the DWI enforcement grant are pending; nonetheless, there will be increased DWI patrols leading up to the holidays regardless of whether the grant is received. Chief Prall noted DWI enforcement has increased in the Department for this year. Lastly, Chief Prall described the PBA and Police Department participation in the No Shave November Campaign which will be carried through December.
