Mayor Damiano announced the Municipal Building is lit in pink tonight in honor of Breast Cancer awareness.

FIRE PREVENTIONWEEK PROCLAMATION – Mayor Damiano read the Proclamation recognizing October 8-14, 2023 as Fire Prevention Awareness Week in the Township of Little Falls, and thanked the Fire Department for their quick response to a recent fire on October 14<sup>th</sup>.

NATIONAL FIRST RESPONDER'S DAY PROCLAMATION – Lastly, Mayor Damiano read the National First Responder's Day Proclamation which recognized October 28, 2023 as National Responder's Day in the Township of Little Falls.

ANNUAL REVIEW OF 35 STEVENS AVENUE BUILDING BY LITTLE FALLS HISTORICAL SOCIETY — John Veteri, Little Falls Historical Society, introduced members of the Historical Society, and provided updates on: funding and grants, design planning and permitting, construction completed, as well as construction in progress and under contract. Mr. Veteri announced the Historical Society was a recipient of a grant from the NJ Historic Trust. Mr. Veteri then requested a one-year extension of the agreement signed with the Township. Council President SGOBBA stated the Council would consider the request. Councilmember MURPHY and Councilmember PATEL indicated they had no objection to the extension. Mayor Damiano further commented on the restoration of the building.

DISCUSSION OF BEST PRACTICES INVENTORY – Mr. Cuccia reported on the annual requirement to complete the Best Practices Inventory. Mr. Cuccia reviewed the major areas of the Best Practices and the Township's score of 40.5 which resulted in no State funding withheld from the Township. Mayor Damiano thanked those who contributed to the scoring and noted the importance of Best Practices in enabling funding to accomplish capital projects throughout the Township.

Councilmember MURPHY recalled the Domestic Violence Awareness flag raising and noted Town Hall was illuminated in purple to raise awareness. Councilmember MURPHY noted the Committee's presence at the PBA

Oktoberfest and the Farmers Market. He also met with the County Prosecutors Office to plan an event regarding Safe Haven which would include two separate events, one for students and one for parents. Councilmember MURPHY added that a program for seniors is also being explored.

Councilmember VANCHERI reported on his meeting with Commissioner Bartlett and provided an update on the Route 46/Route 3 project which has a completion date of November 8, 2023. Additionally, the Transportation Committee will be meeting with Houston Road residents to discuss speed humps. Councilmember VANCHERI highlighted this weekend's past events and upcoming town-wide events and encouraged residents to check out the Recreation Center's program of activities.

Councilmember PATEL discussed methods to address concerns of Covid-19 and flu in the schools as well as the quality of air. Flu vaccination Clinics will be held at the Clifton Health Department on October 19<sup>th</sup>, October 24<sup>th</sup>, and November 14<sup>th</sup> and in Little Falls on October 30<sup>th</sup>. Lastly, Councilmember PATEL announced there will be an Operation Graduation 2024 fundraiser on November 5<sup>th</sup>.

Council President SGOBBA announced October 22<sup>nd</sup> is First Reformed Church's 200<sup>th</sup> anniversary. He also reported the Harvest Moon dance was attended by 75 senior citizens and was a success. Council President SGOBBA then provided a progress report on the Hometown Heroes program honoring deceased veterans killed in action
