2. <u>Julie Jones</u> – 111 Francisco Avenue, Little Falls, NJ. Block 230.02, Lot 51. Request for "c" or bulk variance relief to permit the installation of an in-ground swimming pool on the premises located at 111 Francisco Avenue, Little Falls, NJ.

John Veteri, Jr., Esq., attorney for the applicant, came before the Board to state that the applicant is requesting to install an in-ground swimming pool on her property which currently contains a single-family dwelling. Several photos were introduced into evidence showing a fence to enclose the pool, various equipment being used for the pool, and the report of Mr. Lemanowicz dated October 24, 2019. Mr. Veteri stated that there is a 40ft. wide easement for the water supply which occupies the majority of the rear yard of the property, and therefore, the applicant is limited as to where the in-ground pool can be installed. He stated that the pool will be 10 ft. by 14ft and built in-ground, and the pool will be enclosed by a 5ft. high aluminum decorative fence. He stated that the applicant is requesting a "c" variance because the pool is setback 6ft. from the dwelling (15ft. is required). He also stated that he finds no negative detriment to the neighboring properties. One member of the Board asked if the pool was too close to the back door and if someone can trip and fall into the pool. Mr. Veteri replied that it would not be possible as there is a deck surrounding the pool and a fence.

This portion of the meeting was opened to the public. Mr. Andrew Baggot, indicated that he has a concern if someone would be able to jump from the 2nd floor of the residence into the pool since it will be so close to the setback. No others coming forward, this portion of the meeting was closed to the public.

Mr. Greco motioned, seconded by Mr. Gaita to approve this application as presented.
