REGULAR MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Monday, September 22, 2014

Council President Louis Fontana called the meeting to order at 7:30 p.m. with the following members present: Joseph Maceri, and William Organisciak. Also present were Mayor Darlene Post, Township Attorney William Northgrave, Township Engineer Dennis Lindsay, Municipal Clerk Cynthia Kraus and Township Administrator Charles Cuccia

Absent: John Vantuno and Pamela Porter

Township Employees present: DPW Superintendent Phillip Simone and Deputy Registrar Marlene Simone

Following the Salute to the Flag, the Statement of Public Notice was read.

STATEMENT OF PUBLIC NOTICE: Take notice that adequate notice of this meeting was provided in accordance with N.J.S.A. 10:4-8 and N.J.S.A. 10:4-10 as follows: A notice of the meeting was prominently posted on the bulletin board at the Municipal Building, located at 225 Main Street, Little Falls, N.J. on January 8, 2014; a copy of the notice was faxed to the North Jersey Herald and News and The Record on the same date; additionally, a copy of the notice was filed in the office of the Township Clerk on said date.

APPROVAL OF MINUTES

It was moved by Councilmember Organisciak, seconded by Councilmember Maceri, that the Minutes of the Regular meeting of April 7, 2014 and the Special meeting of April 14, 2014 be and they were approved.

The Council President declared the motion passed.

REMARKS FROM CHAIR

Council President FONTANA informed that Little Falls Day would be held on 10/11/14 at MSU, adding that there would be a softball game between the MSU students and the Fire Department. He also reported that the soccer season started this week and the football season is into its second week. He encouraged everyone to come out for the annual Halloween Bash at the Recreation Center on 10/25/14.

At this time, Council President FONTANA read a letter he received from a resident recognizing Prall for his efforts during a recent call.

COUNCIL MEMBER REPORTS

Council President FONTANA gave a report in Councilmember Porter's absence. He thanked all who helped to organize the 9/11 ceremony. He also thanked Pencilworks for hosting a wonderful even for the Senior Citizens last Wednesday. He reported that the Harvest Moon Dinner Dance would be held on 10/24/14, and informed that the Municipal Alliance would be hosting a dance on 10/10/14 for the fifth and sixth graders.

Councilmember MACERI reported that the Regional Flood Board met last Thursday and appointed a new Chairman. He thanked Mr. Pace, the Recreation Department and the LFAC for helping out with opening day for soccer. He also thanked Mr. Simone and the DPW for having the fields in pristine condition.

Councilmember ORGANISCAIK reminded that the Little Falls Business Association would be holding its Fall Festival on 9/28/14 at the Morris Canal Preserve.

MAYOR'S REPORT

Mayor Post informed that the NJDEP would be holding a presentation on 9/29/14 at the Civic Center regarding the buyout of qualified properties affected by flooding. She also informed that the Mayor's Cup was held this past Saturday in Woodland Park. She congratulated the squads from each town on their wins. She also informed that PSE&G will be attending the Council meeting on 10/6/14. She explained that there are new trash receptacles on Main Street, which have been purchased from Clean Communities. She wished everyone a Happy Rosh Hashanah and a Happy Yom Kippur.

ATTORNEY'S REPORT

Mr. Northgrave had nothing to report.

ADMINISTRATOR'S REPORT

Mr. Cuccia informed that the quarterly reports were filed today for the FEMA program.

PUBLIC PORTION

It was moved by Councilmember Maceri, seconded by Councilmember Organisciak, that the meeting be and it was opened to the public.

The Council President declared the motion passed.

Ron Mullen, 94 Jacobus Avenue, voiced concern regarding the issue of speeding on his street, and said speed bumps should be installed. He would like the town to follow up with this.

<u>Karen DiSliva</u>, 92 and 92A Island Avenue, voiced her frustration that she was placed in the FEMA buyout program instead of the FEMA elevation program by the previous administration. She would like to know where her elevation paperwork is and how this situation will be fixed.

<u>Lauren Bell Mitchell</u>, 15 Hemlock Road, asked who is the owner of Hemlock Road, noting that there has been some confusion as to whether it is the town or the Church. She explained that the road is barely passable and asked who is responsible for maintenance and paving.

<u>Victor Nowak</u>, Stephan Place, voiced concern regarding careless driving and speeding on his street.

<u>Bob Dombrowski</u>, 49 Parkway, thanked Mr. Simone and the DPW for the job they did at Surkosky Park with the lighting and the painting. He asked for clarification regarding the age limit to ride the Senior Citizen bus. He also asked for the status of the paid ambulance.

Arnold Korotkin, 181 Long Hill Road, requested that PSE&G notice of road work be included in an email blast at least a week in advance of the work. He asked if the Best Practices Report has been submitted to the State and the Council for review. He was pleased to see the Township moving along with the bus stop locations, and asked whether this has been signed off on. He reminded that October is Domestic Violence Awareness month, and asked if the town has anything planned.

<u>Louis Fernandez</u>, Harrison Street, asked for the amount of the settlement between the Township and the contractor for the new Justice Complex.

<u>Dorothy O'Haire</u>, Turnberry Road, thanked the Fire Department for responding to a call at her house recently for a carbon monoxide detector alarm.

No one further having come forward to be heard, it was moved by Councilmember Maceri, seconded by Councilmember Organisciak, that the meeting be and it was closed to the public.

The Council President declared the motion passed.

In response to Council President Fontana, Mr. Cuccia informed that the Police Chief has been out to Jacobus Avenue. They plan to do another car count when school is in session, as the last one did not reach 3,000 cars. Mr. Lindsay said they will continue to look into different options for the speeding on Jacobus Avenue. Councilmember MACERI pointed out that the road is used as a through street to traffic. Councilmember ORGANISCIAK suggested installing signage on the street. Mr. Lindsay said there are many options they can review.

Council President FONTANA explained to Mrs. DaSilva that Blue Acres is asking for the Township's help with buyouts; the Township is not soliciting buyouts. Mr. Cuccia explained that the properties that were included in the grants were very specific and were all approved by resolution. He asked Mrs. DaSilva to provide him with any paperwork she may have.

Mr. Simone explained that the dirt part of the road on Hemlock belongs to the church. The Township does not own it and is not responsible for maintenance.

In response to Council President Fontana, Mr. Lindsay explained that this is a legal issue that must be reviewed.

Council President FONTANA explained to Mr. Nowak that the town is going to try to find a solution for the speeding on all of the streets being brought to their attention.

Council President FONTANA thanked Mr. Simone and the DPW for cleaning up Surkorsky Park.

Mr. Cuccia said he would look into the age for riding the senior bus.

Regarding the status of the paid ambulance, Mr. Cuccia said he hopes to present some information at the next Workshop meeting.

Mr. Simone explained that PSE&G can only provide a work schedule one day in advance, as it depends on their progress.

Mr. Cuccia explained that he is preparing the Best Practices Report, which will be presented to the Mayor and Council at a public meeting and sent to the State before the deadline on 10/17/14.

Mr. Simone informed that the paperwork for the bus shelters has been signed by the Mayor and sent to the County for their approval. However, the Council still needs to act on the ordinance tonight, which will also be sent to the County, who will present it to the Freeholder Board for approval. Following that process, it gets sent back to NJ Transit. NJ Transit will then contact the Township about installation.

Regarding the settlement of the Justice Complex, Mrs. London explained that there is approximately \$300,000 left over that was not paid out to the contractor; the settlement will be that the Township will be able to maintain these funds.

Council President FONTANA said he would pass Mrs. O'Haire's comments along to the Fire Chief.

Councilmember MACERI said nothing has been planned yet for the Domestic Violence vigil, but they are discussing this.
