REGULAR MEETING OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF LITTLE FALLS WAS HELD THIS EVENING IN THE MUNICIPAL BUILDING

Tuesday, September 26, 2023

Councilmember Christoper Vancheri called the meeting to order at 7:00 p.m. with the following members present: Christine Hablitz, Michael Murphy, and Jayna Patel. Also present were Mayor James Damiano, Township Attorney Joseph Wenzel, Township Administrator Charles Cuccia, Assistant Township Administrator Vincent Quatrone, and Municipal Clerk Cynthia Kraus.

Absent: Council President Anthony Sgobba and Deputy Clerk Melissa DePiro.

Township Employees present: Police Chief Bryan Prall.

SALUTE TO THE FLAG – Following the Salute to the Flag all were asked to stand in a moment of silence to recognize the passing of Councilmember Murphy's grandfather.

STATEMENT OF PUBLIC NOTICE: Take notice that adequate notice of this meeting has been provided in accordance with N.J.S.A. 10:4-8 and N.J.S.A. 10:4-10 as follows: A notice of the meeting was prominently posted on the bulletin board at the Municipal Building, located at 225 Main Street, Little Falls, N.J. on January 5, 2023. The Council President declared the motion passed.

MAYOR'S REPORT

Mayor Damiano provided an update on the Streetscape program streetlights installed by PSE&G, which are awaiting connection to electricity. Mayor Damiano referred to Ordinance Nos. 1471, 1472, & 1473 scheduled for introduction tonight, and noted they are largely funded by grants. The Mayor described the Streetscape program sections included in the aforementioned Ordinances which were Maple Avenue to Van Ness Avenue, Stevens Avenue from Main Street to Walnut Street, and Union Avenue from Main Street to Walnut Street.

NATIONAL SUICIDE PREVENTION MONTH PROCLAMATION – At this time Mayor Damiano read the Proclamation recognizing September 2023 as National Suicide Prevention Awareness Month in the Township of Little Falls. In conjunction with the Proclamation, Mayor Damiano noted his discussion with Mr. Quatrone to proceed with the installation of Stigma Free signs at all the entrances to the municipality.

HISPANIC HERITAGE MONTH PROCLAMATION – Mayor Damiano read the Proclamation recognizing September 15, 2023 through October 15, 2023 as Hispanic Heritage Month in the Township of Little Falls.

ITALIAN AMERICAN HERITAGE MONTH PROCLAMATION – Mayor Damiano then read the Proclamation recognizing October 2023 as Italian American Heritage Month in the Township of Little Falls and invited everyone to the flag raising ceremony on October 2, 2023 at 6:00 P.M. at the Municipal Building.

DOMESTIC VIOLENCE AWARENESS MONTH PROCLAMATION – Lastly, Mayor Damiano read the Proclamation recognizing October 2023 as Domestic Violence Awareness Month in the Township of Little Falls.

Mayor Damiano reported on the Master Plan Meeting on September 19th, which was sparsely attended. The Mayor urged residents to attend the next meeting to be held on October 23rd. The Mayor also reported there has been no further update since his last report on Verizon regarding service-related issues but encouraged residents to call in as well. Mayor Damiano reviewed the Library's new home delivery program and also discussed the installation of LED stop signs at the intersections of Cedar Grove Road and Main Street, and First Avenue and Wilmore Road.

Councilmember MURPHY thanked everyone for their condolences. Councilmember MURPHY reported there will be a flag raising in October for Domestic Violence Prevention Awareness as well as a presentation at PVHS. Councilmember MURPHY reported four members will be added to the Committee and will be voted on tonight's Agenda. Lastly, Councilmember MURPHY provided an update on the Township Calendar.

Councilmember HABLITZ discussed the Library's delivery service program and reported on upcoming Library events including a Wellness Fair on September 28th. Councilmember HABLITZ announced this Sunday's Farmers Market will recognize Breast Cancer Awareness, and upcoming October Farmers Market events include a doggie costume contest, pumpkin painting, and trick-or-treating. Councilmember HABLITZ then reported on the

upcoming Town-wide Yard Sale this weekend as well as the Spooky Sprint 5K event on October 22nd. Lastly, Councilmember HABLITZ recalled the success of the Little Falls Biz Fall Festival.

Councilmember PATEL announced the Clifton Health Department will be at the Health and Wellness Fair held at the Library. Additionally, the Clifton Health Department, in collaboration with Inner Healing Counseling, will hold a free mental health screening on October 6th. The Flu Clinic will be held on October 19th at Clifton City Hall and on October 30th at the Township's Municipal Building. Lastly, the Public Health Committee has been working to ensure that public health information on the Clifton website is also available to Little Falls residents.

Councilmember VANCHERI reminded residents the Harvest Moon Dinner Dance will be on October 13th. Councilmember VANCHERI discussed the Traffic Seminar held last week and noted another event will be planned in the future. He encouraged everyone to attend the Italian Heritage American month flag raising on October 2nd, the St. John's Church Picnic this weekend, and the PBA's annual Oktoberfest next weekend. Councilmember VANCHERI then read into the record the four members that will be added to the membership of the Domestic Violence Prevention Committee.

BOND ORDINANCE NO. 1471

BOND ORDINANCE TO AUTHORIZE THE UNDERTAKING OF STREETSCAPE IMPROVEMENTS AT MAIN STREET (FROM MAPLE STREET TO VAN NESS AVENUE) IN, BY AND FOR THE TOWNSHIP OF LITTLE FALLS, IN THE COUNTY OF PASSAIC, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$1,050,000 TO PAY THE COST THEREOF, TO APPROPRIATE A STATE GRANT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

BE IT ORDAINED by the Township Council of the Township of Little Falls, in the County of Passaic, New Jersey, as follows:

Section 1. The Township of Little Falls, in the County of Passaic, New Jersey (the "Township"), is hereby authorized to undertake streetscape improvements at Main Street (from Maple Street to Van Ness Avenue) in, by and for the Township. Said improvements shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$1,050,000 is hereby appropriated to the payment of the cost of making the improvements described in Section I hereof. Said sum so appropriated shall be met from the proceeds of the sale of the bonds authorized and the State grant appropriated by this ordinance. No down payment is required pursuant to the provisions of N.J.S.A. 40A:2-11(c) because this ordinance involves a project to be funded by a State grant. Said improvements shall be made as general improvements and no part of the cost thereof shall be assessed against property specially benefitted.

Section 3.
