The Little Falls Fire Department responded to a total of 688 alarms and Eagle Rescue Squad responded to a total of 1315 EMS calls for assistance. 713 of these EMS calls were from Nov 1, 2015-May 14, 2016 during the period of time where this service was completely volunteer. 602 calls were handled between May 15 and Oct 31 2016 during the opening period for the new paid EMS service.

A total of 2003 emergency calls were handled through the Little Falls Fire Alarm dispatch in addition to the many non emergency business calls for the fire department. The volume of calls handled by the fire alarm dispatch center reaffirms the need to continue this vital service within our department in our continued efforts to save lives, protect property and provide an organized Emergency Incident Command system.

During 2016 the Township of Little Falls experienced the following incidents where the Fire Department worked for an extended time period to mitigate the emergency:

Houston Rd Fall victim from cliff November 29, 2015

47 Van Pelt Place Structure fire April 26, 2016

As the Chief of the Fire Department, I am extremely proud and honored to be working with our officers and our members through all of these incidents. The above emergencies are highlighted as the major events throughout the year however our membership is prepared and rise to the occasion whenever called upon. Department line officers held monthly meetings throughout the year to discuss general operations, policies and procedures and future development within the department.

CAPITAL IMPROVEMENTS 2017

- Secure funding for the replacement of Engine #4 at a cost of \$700,000. Engine #4 is beginning its 26th year of service.
- Secure funding for the replacement of two (2) Township Ambulance units 842 & 843, \$375,000. We are currently reviewing options for joint purchase along with The Paterson Fire Dept. We will establish a working committee comprised of members from Eagle Hose Co #1 for review, discussions and execution of this purchase.
- Rescue One (Truck) has completed 16 years of service. In 2019, this apparatus will be due for replacement. Accruals for this purchase to begin in 2017 at a rate of \$75,000 per year.
- The LFFD dispatch purchase of C.A.D system along with two Z-Tron work dispatch stations and a Digitizer \$78,000.
- Proposing the construction of a 50' x 45' Morton structure located at the Township DPW site to be used for fire department equipment storage, meeting room and indoor training facility. The cost for this project is estimated at \$48,500.

ACCOMPLISHMENTS 2016

- Implementation of The Little Falls Fire Department Emergency Medical Service went effect on May 15, 2016.
- LOSAP contribution has been increased from \$1250.00 to \$1350.00 for qualifying members.
- Enterprise Fire Co #2 received a 2016 Seagrave Pumper at a cost of \$650,000. This apparatus was ordered in November of 2015 and was delivered in October 2016. We are awaiting the remainder of the equipment scheduled to be delivered mid-December and should be in service by January of 2017 as the new Engine #2. Thank you to the members of the engine committee for all of your time and effort spent in designing this apparatus to meet the various needs of both basic and essential firefighting within our community. Members are: Ed Pomponio, John L Conti, James DiMaria, Ron Stell, Joe Casillo and Frank Conti.
- The yearly clothing allowance has been increased to \$400.00 for qualifying members for 2016.
- Air-packs / Cylinders and Fill Station (SCBA) has been replaced at an approx. cost of \$545,000. All equipment was received in December 2015. Fill station training has been completed and members within the department are now certified as needed.
- Continued to work with New Jersey American Water Company for upgrading water supply throughout the Township of Little Falls.
 - Relining of water mains is scheduled for 2017 on Ridge, Lincoln, First, Second,
 Third, Fourth Avenues, Wilmore Rd., Prospect, Stanley, Crane, Frances and Elm
 Streets and Park Lane.
 - Extending a 16" water main east on Main St. from Paterson Avenue to Browertown Rd.
- Successful completion of the Firefighter One Course offered at Passaic County Public Safety Academy by five (5) of our members.
- Engine, Ladder Truck and Rescue training was conducted on Company and Department levels to enhance effective and safe fire ground procedures.

- The RAPID ENTRY SYSTEM, (Knox Box) program has continued to expand on a commercial and residential level. We have increased our participation in this program. This program is a vital role in rapid entry and ensuring the safety for both our firefighters and the residents of the Township of Little Falls.
- As part of Operation Graduation; a joint demonstration with The Little Falls Police and
 Fire Departments along with the NJ State Police North Star, Medi-Vac helicopter was
 held on Hopson Avenue for Passaic Valley High School senior students. The
 demonstration consisted of a reenactment of a severe traffic accident as a result of drunk
 driving. The students observed the exercise and were reminded of the dangers of
 drinking and driving.
- Continued the work to address the radio communications system. This includes portable, mobile and base stations located at the various fire companies. We completed the final phase with the installation of new antennas on the cell tower of Great Notch Co #4. A final receiver site is set to be activated at University Hall, Montclair State University in the Spring of 2017.
- I would like to thank Michael Burke and the Annual Dinner Committee for their efforts in the expansion and planning of this event.

GOALS / OBJECTIVES 2017

- Replacement of Engine #4 secure funding and obtain final approval
- Replacement of Ambulance Units 842 and 843.
- Remodeling and upgrading Fire Alarm Dispatch room.
- Begin Accruals for Rescue One replacement in 2019
- Continue with further improvement of water supply with NJ American Water.
- Continue to review and improve our ISO records for training & equipment, call volume, General Orders and preplan procedures.
- Develop a recruitment program in conjunction with Passaic Valley High School
- 2017 training classes will consist of the following:
 - Fire Alarm Operations- Dispatch class
 - Truck training program
 - Blood-borne Pathogen (offered from Clifton Health Dept)
 - Water rescue/Vehicle Extrication training
 - Drafting Drill and Pump Operations
 - Officers Training Class
 - The following classes will be offered by LFFD training officer James Hearney:
 - Right To Know
 - Hazmat Awareness
 - Fire ground Safety Class (in conjunction with a Safety Officers Class)
 - Board of Fire Officers meetings will be held for the review and recommended revisions to Township ordinances involving the Little Falls Fire Division.
 Implement Standard Operating Procedures.

- Enrollment of four (4) new members of The Little Falls Fire Department in the Firefighter One classes offered at Passaic County Public Safety/Fire Academy to begin January 2017.
- Continue working with our Mayor, Business Administrator and Town Council members on matters pertaining to the Fire Department budget, expenditures and capital improvements.
- Continue to work closely with the Fire Official, Fire Inspectors and Building Inspector to insure code enforcement for the safety and well being of our residents and firefighters.
- Continue to maintain full compliance of all OSHA and PEOSH standards and regulations.

In closing I would like to thank all the officers and the members of The Little Falls Fire Department for their commitment and dedication this past year. 2016 was another busy year in which demands were placed on both the department members and their families.

Please accept the following as the 2016 yearend report for the Township of Little Falls Municipal Fire Alarm System.

Various fire alarm system maintenance tasks were performed throughout the year. These tasks included repainting and refurbishing street boxes, transferring our lines to new poles Public Service has placed throughout the town, and performing regular voltage monitoring of all three circuits.

The fire alarm crew has begun transferring the fire alarm wire along a string of 22 new poles on Long Hill Rd between Notch Rd and Lower Notch Rd. The two pull boxes along that route were transferred this year. The pull box on the corner of Clove Rd and Long Hill Rd was also transferred to a new pole.

The Digitize System 3505 alarm monitoring computer is need of replacement. I am proud to report that there were no reported outages in the Fire Alarm system during the 2016 fire year.
