The Little Falls Fire Department responded to a total of 572 alarms and the Little Falls Fire Department EMS responded to a total of 1559 medical emergency calls for assistance.

A total of 2131 emergency calls were handled through the Little Falls Fire Alarm dispatch in addition to the non-emergency business calls for the fire department. The volume of calls handled by fire alarm dispatch increased over 30% from the call volume in 2017.

Little Falls Fire Department Dispatch plays a vital role in FIRE/EMS emergencies locally and within Passaic County. In 2019 we are looking to expand and improve the operations in working with The Passaic County Mutual Aid Association to secure dispatch opportunities within the County. This also reaffirms the need to continue this vital service within our department in our continued efforts to save lives, protect property and provide an organized Emergency Incident Command system.

During 2018 the Township of Little Falls experienced the following incidents where the Fire Department worked for an extended time period to mitigate the emergency:

As always, I continue to be extremely proud and honored to be working with our officers and our members through all the emergencies Fire/EMS related when called upon.

The above emergencies are the highlighted events that occurred throughout the year however our membership stands prepared and rises to the occasion whenever called upon.

CAPITAL IMPROVEMENTS 2019

- Secure funding for the replacement of Engine #4 at a cost of \$715,000. Engine #4 is beginning its 28th year of service.
- Rescue One (Truck) has completed 18 years of service. In 2021, this apparatus will be due for replacement. Accruals for this purchase should have begun in 2017 at a rate of \$85,000 per year.
- The LFFD dispatch purchase of C.A.D system along with two Z-Tron work dispatch stations and a Digitizer, Console Electronics, Radio Rack. \$205,704.00
- Remodeling of Fire Headquarters Dispatch located at 17 Paterson Ave. \$7,500.00
- Firehouse Subs Grant for a New Emergency One Connector Boat. Township of Little Falls Costs. \$10,000.00
- Ladder #4 has completed 10 years of service and should be replaced in 2022. Accruals for this purchase to begin in 2018 at a rate of \$60,000 per year.

In the year 2019 The Little Falls Fire Department will continue working with Millenium Strategies pursuing the opportunity of grants for the Township of Little Falls. If we are successful in acquiring the grants, this would be of great assistance to the Township in offsetting costs for the equipment and programs we are looking to have in place for 2019/2020.

ACCOMPLISHMENTS 2018

- Secured funding for the replacement of two (2) Township Ambulance units 842 & 843, at a cost of \$386,000.00. We reviewed all options and agreed to a joint purchase along with The Paterson Fire Department with a substantial savings to the Township of Little Falls. These Ambulance Units 842 and 843 went into service on April 21, 2018
- Proposed and secured funding for the construction of a 50' x 50' Morton structure located at the Township DPW site to be used for fire department equipment storage, meeting room and indoor training facility. The cost for this project is estimated at \$70,000. At this time this project has been put on hold for the location as the DEP is looking to study for a flood tunnel off the Peckman River which would travel underground through the center of this new facility for The Little Falls Fire Department. New locations are being reviewed for requests pertaining to the construction of the building.
- We have continued to provide a yearly clothing allowance in the amount of \$450.00 for qualifying members for 2018.
- Secured additional funding for each individual company for offset rising costs for rent, insurance and maintenance of the firehouses and Chief's vehicles.
- Continued to work with New Jersey American Water Company for upgrading water supply throughout the Township of Little Falls.
- Engine, Ladder Truck and Rescue training was conducted on Company levels to enhance effective and safe fire ground training and procedures.
- The RAPID ENTRY SYSTEM, (Knox Box) program has continued to expand on a commercial and residential level. We have increased our participation in this program. This program is a vital role in rapid entry and ensuring the safety for both our firefighters and the residents of the Township of Little Falls.
- Forcible Door Simulator was put in service at Eagle Hose Co. # 1 where all four (4) companies have trained on forcible entry /door crusher. Outside training from Firefighter University was obtained and improve the skills for the membership of our department.

- Successful completion of the Firefighter One Course offered at Passaic County Public Safety Academy by three (3) of our members.
- Successful completion of Two (2) EMT's within The Little Falls Fire Department.
- Obtained a \$1,000.00 grant from New Jersey American Water Co for the Purchase of Firefighter Gloves.
- The installation of a new radio receiver site on the rooftop of University Hall @
 Montclair State University. The project had taken much more time to complete than
 anticipated. I would like to thank Dan Stratthaus and Asst. Chief Jeff Altonjy for their
 efforts in improving and solidifying our radio communications within our Township.
- Secured funding and purchased a new Chief Vehicle replacing a 2011 Chevrolet Tahoe.

GOALS / OBJECTIVES 2019

- Replacement of Engine #4 Secure funding and obtain final approval with a budget of \$715,000.00. Apparatus to be ordered by March 31, 2019 to maintain the pricing of this apparatus without manufacturers increases. We will also look to use The Houston/Galveston Coop purchasing plan for this acquisition.
- Remodeling and upgrading Fire Alarm Dispatch room.
- Continue to follow-up on Accruals for Rescue One and Ladder #4 replacement in 2019
- Continue with further improvement of water supply with NJ American Water.
 - o Relining of water mains is scheduled for 2019 on Ridge, Lincoln, First, Second, Third, Fourth Avenues, Wilmore Rd., Prospect, Stanley, Crane, Frances and Elm Streets and Park Lane.
 - o Extending a 16" water main east on Main St. from Paterson Avenue to Browertown Rd is scheduled at this time for 2019

Continue to review and improve our ISO records for training & equipment, call volume, General Orders and preplan procedures.

- Develop a recruitment program in conjunction with Passaic Valley High School and The Little Falls Boy Scouts and for residents within The Township of Little Falls starting in January 2019
- 2019 training classes will consist of the following:
 - Officers Training Class
 - Fire Alarm Operations- Dispatch class with 911/EMD
 - Engine and Truck training program
 - Blood-borne Pathogen (offered from Clifton Health Dept)
 - Water rescue/Vehicle Extrication training
 - Drafting Drill and Pump Operations
 - Active Shooter Training for F/F and EMT's
 - Forcible Entry

As 2019 marks the 115th Anniversary for The Little Falls Fire Department, I would ask President Michael Burke to establish a committee for the event of celebrating this milestone within the Township of Little Falls for our membership and residents.

Board of Fire Officers meetings will be held for the review and recommended revisions to Township ordinances involving the Little Falls Fire Division. President Burke will be establishing a bi-law committee to review and propose recommended revisions to existing bi-laws.

Enrollment of five (5) new members of The Little Falls Fire Department in the Firefighter One class offered at Passaic County Public Safety/Fire Academy in January 2019. Enrollment of two (2) members for Firefighter 2 Class beginning in February 2019. Enrollment of Two (2) members for the summer 2019 EMT Program. Enrollment of One (1) member for Fire Inspectors Class in January 2019 program Enrollment of One (1) Officer for Training Officer T/O position to be assigned to training division within our Department along with Asst. Chief Chris Meletta and Captain Jim Hearney.

Continue working with our Mayor, Business Administrator and Town Council members on matters pertaining to the Fire Department budget, expenditures and capital improvements including the future construction and development projects throughout the township.

Following up on the Parking Ordinance referencing Main St. from Center Ave to Stevens Ave going east for no parking. This Ordinance change is in its second reading. It will be re-assuring to know the flow of traffic at this location will be much improved upon approval of this ordinance.

Continue to maintain full compliance of all OSHA and PEOSH standards and regulations.

In June 2018, the Passaic Valley Elks of Totowa acknowledged and recognized Ronnie Cordero of Eagle Hose Co. # 1 as Firefighter of the Year for The Little Falls Fire Department. As we are approaching the three (3) year mark of The Little Falls Fire Department EMS, the dedication and commitment exemplified by all our EMT's is well recognized and very much appreciated. Choosing one (1) EMT to be honored last year was very difficult. In closing I would like to thank all the officers and the members of The Little Falls Fire Department for their commitment and dedication this past year. 2018 was another busy year in which demands were placed on both the department members and their families.

Your commitment is always well recognized and very much appreciated.

This evening concludes the completion of Twelve (12th) years and my fourth (4th) term as your Department Chief. Over the past years I have strived to improve our department and hopefully have consistently met your expectations. It is truly a privilege and an honor to serve with the members of The Little Falls Fire Department and I hope to have shown the level of leadership and dedication for the office of Chief.

I would like to recognize and thank the members of Singac Fire Co. # 3 for their continued support and for nominating me for the position as Chief of The Little Falls Fire Department here this evening.

Enclosed you will find a proposed budget for The Little Falls Fire Department Emergency Medical Services program for the Fire Year 2019.

In 2018, this EMS program has answered 1559 Emergency Medical requests. In April of 2018, The Township Council passed an amendment to the EMS Ordinance in receiving a set figure of \$250.00 for any and all RMA's (Refused Medical Attention). This amendment has offset the labor cost to The Township of Little Falls for our EMT's on duty daily.

The EMS program has also provided medical coverage for community events and assisted in mutual aid. This program has been a success in health and welfare and medical awareness for residents and guests within our township and bordering towns when called upon.

We have also been able to hire new certified EMT's as we are replacing EMT's which left our program. Our EMS program has covered the Passaic Valley High School Events throughout the year as requested and has been compensated for the events.

Dear Chief Sweezy,

Please accept the following as the 2018 yearend report for the Township of Little Falls Municipal Fire Alarm System.

Various fire alarm system maintenance tasks were performed throughout the year. These tasks included performing regular voltage monitoring of all three circuits and transferring our lines to new poles Public Service has placed throughout the town.

There have been a series of new poles installed by Public Service on Long Hill Rd and Ridge Rd. We have completed a major repair at the intersection of Long Hill Rd and Ridge Rd, and completed pole transfers on Ridge Rd including street box 86 on the corner of Francisco Ave and Ridge Rd. We hope to have our lines transferred to the remaining poles on Long Hill Rd in the upcoming months.

We have worked with NJ DOT and State contracted vendors for relocation of Fire Alarm wires underground as required in the Clove Rd, Rt. 46 road construction project.

The Digitize System 3505 alarm monitoring computer in Fire Headquarters is need of replacement.

The Little Falls Fire Department responded to the above locations to mitigate, fire/water/utility emergencies, as well as emergency evacuations for residents and guests. A total of 32 people and 23 pets were evacuated from many residences during this event.

Unfortunately, the 4.75 inches of rain within 1 hour was the cause of the flooding throughout the Township of Little Falls and emergency personnel was handling these emergencies within their company district, until waters subsided enough to navigate the roads to support each crew working an emergency.

Mutual Aid from Wayne Fire Co. # 1 and #2, Fairfield Fire Department were called in with 5 Ton emergency equipment to assist our Department in water rescues in the Jackson Park area. The Little Falls DPW assisted as well in water rescues and evacuations.

At this time, I would like to thank the members of The Little Falls Fire Department, Little Falls EMS, Little Falls DPW. Sgt. Gianduso, of Little Falls OEM, as well as The Little Falls Police Department, Wayne Fire Co.'s #1 and #2, along with Fairfield Fire Department for their efforts in assisting the residents of Little Falls affected by this storm. It's very reassuring to know how the mutual aid towns are there when called upon, with an affective task completed, with no loss of life, or any injuries.

Sunday, August 12, 2018, The Little Falls Fire Department pump details commenced at 14:00 hrs. and were completed at 21:00 hrs. Twenty (20) members of the Department assisted in pump details in this time frame. Unfortunately, 5 homes were unable to be pumped out, due the structural integrity of the home.

4 Gas pumps, 5 Electric pumps, 3 generators, extension cords, hose, 3 equipment trailers

Once again, I would like to extend my thanks and gratitude to the members of The Little Falls Fire Department assisting with pump details on this day, in order for our residents to have a better assessment of the damage to their homes which this storm created for many.
