# LITTLE FALLS FIRE DEPARTMENT

Little Falls Fire Dept. Fire Alarm Maintenance Report 2015

The Little Falls Fire Department responded to a total of 790 alarms and Eagle Rescue Squad responded to a total of 1393 EMS calls for assistance. A total of 2183 emergency calls were handled through the Little Falls Fire Alarm dispatch in addition to the many non emergency business calls for the fire department. The volume of calls handled by the fire alarm dispatch center reaffirms the need to continue this vital service within our department in our continued efforts to save lives, protect property and provide an organized Emergency Incident Command system.

During 2015 the Township of Little Falls experienced the following incidents where the Fire Department worked for an extended time period to mitigate the emergency:

As the Chief of the Fire Department, I am extremely proud and honored to be working with our officers and our members through all of these incidents. The above emergencies are highlighted as the major events throughout the year however our membership is prepared and rise to the occasion whenever called upon. Department line officers held monthly meetings throughout the year to discuss general operations, policies and procedures and future development within the department.

## CAPITAL IMPROVEMENTS 2016

- Secure funding for the replacement of Engine #4 at a cost of \$650,000. Engine #4 is beginning its 25th year of service.
- Secure funding for the replacement of two (2) Township Ambulance units 842 & 843, \$296,000. By purchasing both ambulances we can secure a 8-12% discount for the township.
- Implementation start-up costs of \$95,000 for The Little Falls Fire Department of Emergency Medical Service to begin in 2016.
- Rescue One (Truck) has completed 16 years of service. In 2019, this apparatus will be due for replacement. Accruals for this purchase to begin in 2016 at a rate of \$75,000 per year.
- LOSAP contribution is being requested to increase from \$1250.00 to \$1350.00 for qualifying members. This contribution has not been increased since 2008.
- The LFFD dispatch purchase of C.A.D system along with two Z-Tron work dispatch stations and a Digitizer - \$78,000.

*This equipment is used for current radio communications and future growth in shared services with neighboring towns. LFFD plays a major role in southern zone dispatch in Passaic County.*

- Proposing the construction of a 50' x 45' Morton structure located at the Township DPW site to be used for fire department equipment storage, meeting room and indoor training facility. The cost for this project is estimated at \$48,500.00

## ACCOMPLISHMENTS 2015

- We have secured the replacement of Engine #2 at a cost of \$650,000. This apparatus was ordered in November of 2015 and will be delivered and in service for September 2016.
- We have received final approval for ordinance # 1230 for the implementation of The Little Falls Fire Department of Emergency Medical Service to begin in 2016.

*Little Falls dispatches an average of 4 ambulance calls per day within the township and we are in grave need for a resolution due to lack of daytime volunteers. This service will guarantee daily coverage with an average response time of 3-5 minutes. We are extremely grateful to those who shared in this major accomplishment for our Township.*

- The yearly clothing allowance has been increased to \$350.00 for qualifying members for 2015.
- Air-packs / Cylinders and Fill Station (SCBA) has been replaced at an approx. cost of \$545,000. The Little Falls Fire Department will be receiving Scott X-3 Air-packs after review and discussion with the Board of Fire Officers.
- Continued to work with New Jersey American Water Company for upgrading water supply throughout the Township of Little Falls. Hydrants on Long Hill Road have already been replaced; this project will continue in 2016.  
The water main has been replaced on Morningside Circle and Jacobus Ave.
- Successful completion of the Firefighter One Course offered at Passaic County Public Safety Academy by three (3) of our members.
- Engine, Ladder Truck and Rescue training was conducted on Company and Department levels to enhance effective and safe fire ground procedures. Department drills also included the utilization of instructors from outside the department. In addition an Officers Training Class was held in January 2015.



- The Township of Little Falls Workmen's Comprehensive Policy for our Firefighters has been reviewed with an increase of benefits to the membership in the event of injury. Special thank you to our Mayor Darlene Conti, Business Administrator Chuck Cuccia and Township Council for recognizing and improving the coverage for our membership. Frank Covelli of Professional Insurance Association will be reviewing the program for our membership in January 2016.
- The second phase of TEEX training was held at Montclair State University in the form of a simulated drill in March of 2015. The following agencies participated in this training exercise:

This drill was sponsored by NJ Transit and covered Jurisdictional Crisis Incident Management - ICP. I would like to thank all of the attendees who have spent time away from their personal lives to attend this drill in preparing for a large scale mass casualty incident. I would also like to thank Frank Iurato and the staff of the NJ Transit Police for including the members of LFFD for this specialized training. This has been the most advanced level of ICS training that any first responder could ask for in setting the stage for a large scale incident.

- The RAPID ENTRY SYSTEM, (Knox Box) program has continued to expand on a commercial and residential level. We have increased our participation in this program. This program is a vital role in rapid entry and ensuring the safety for both our firefighters and the residents of the Township of Little Falls.
- As part of Operation Graduation; a joint demonstration with The Little Falls Police and Fire Departments along with the NJ State Police North Star, Medi-Vac helicopter was held on Hopson Avenue for Passaic Valley High School senior students. The demonstration consisted of a reenactment of a severe traffic accident as a result of drunk driving. The students observed the exercise and were reminded of the dangers of drinking and driving.
- Continued the work to address the radio communications system. This includes portable, mobile and base stations located at the various fire companies. We completed

the final phase with the installation of new antennas on the cell tower of Great Notch Co #4. All electrical work with back-up generator power has been completed at the radio shed. Radio equipment has been reprogrammed and assigned accordingly. The overall goal was to implement an effective radio system for Fire/EMS and Police. I would like to extend a special thanks to Dan Stratthaus, Jeff Altonjy and Michael Bolchune for their efforts as well as the members of the department who assisted in the study and analysis contributing to the successful completion of this project.

- Department President Michael Burke in an ongoing effort to help public awareness for The Little Falls Fire Department participated in the following activities:

I would like to take this opportunity to thank President Michael Burke and the Executive Committee in establishing the Little Falls Firefighters Association along with the membership. Meetings were held throughout the year to complete bi-law procedures and the completion of this project with all records to be stored at Town Hall, 225 Main St. 2<sup>nd</sup> Floor.

Lastly I would like to thank Michael Burke and the Annual Dinner Committee for their efforts in the expansion and planning of this event.

## **GOALS / OBJECTIVES      2016**

- Replacement of Engine #4 - approval of final bond ordinance
- Replacement of Ambulance Units 842 and 843.
- Remodeling and upgrading Fire Alarm Dispatch room.
- Implementation of The Little Falls Fire Dept. of Emergency Services
- Begin Accruals for Rescue One replacement in 2019
- Look to increase contributions for Lo-sap.
- Continue training within our department on the homes being demolished by past flooding. This training provides safe fireground procedures at the time of an emergency.
- Continue with further improvement of water supply with NJ American Water. NJ American water will be replacing and standardizing all fire hydrants throughout the township.

Improve water supply on Lincoln, First, Second and Third Avenues with a relining program being offered by New Jersey American Water Co.

- Continue to review and improve our ISO records for training & equipment, call volume, General Orders and preplan procedures.
- 2016 training classes will consist of the following:
  - Fire Alarm Operations- Dispatch class
  - Truck training program

- Blood-borne Pathogen (offered from Clifton Health Dept)
- Water rescue/Vehicle Extrication training
- Drafting Drill and Pump Operations
- Officers Training Class

The following classes will be offered by LFFD training officer James Hearney:

- Right To Know
- Hazmat Awareness
- Fire ground Safety Class (in conjunction with a Safety Officers Class)
- Board of Fire Officers meetings will be held for the review and recommended revisions to Township ordinances involving the Little Falls Fire Division. Implement Standard Operating Procedures.
- Enrollment of eight (8) new members of The Little Falls Fire Department in the Firefighter One classes offered at Passaic County Public Safety/Fire Academy to begin in January 2016. The enrollment of three (3) members of LFFD to the Firefighter Two class in January 2016.
- Continue working with our Mayor, Business Administrator and Town Council members on matters pertaining to the Fire Department budget, expenditures and capital improvements.
- Continue to work closely with the Fire Official, Fire Inspectors and Building Inspector to insure code enforcement for the safety and well being of our residents and firefighters.
- Continue our efforts in changing our Township status from Fire Division to Fire Department. This change would allow the Council to become more involved in helping us achieve our goals.
- Continue to maintain full compliance of all OSHA and PEOSH standards and regulations.



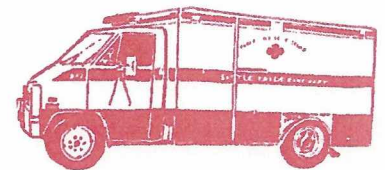

## 1. Summary of Ambulance and Fire Services

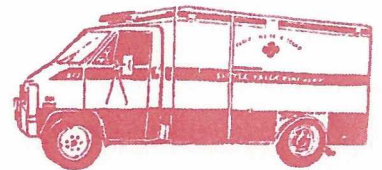
A Total of ambulance requests were 1393 and 790 fire calls made during the 2015 fire year. Our company responded to a vast number of emergencies. We responded to motor vehicle accidents, roll overs, vehicle entrapments, gas emergencies, elevator entrapments, a wide range of medical emergencies, lift assists, medical transports, trauma incidents, fire standbys, mutual aid calls to our neighboring communities and 1 immobilization to Morris county . With all of our responsibilities, we also cover the Passaic Valley High School Home Football games along with Totowa and West Paterson. Our members take pride in the service that we provide to the community. An aspect of our company that stands out is that we have the opportunity to cover some pretty awesome events. We were also asked to assist Montclair State University EMS with their annual concerts. The events I mentioned are just some of the perks to being a part of this company. I am encouraging the residents of Little Falls to come down to the firehouse and see what we are about. We are here to help our neighbors. In order to maintain our great service, we need more members. Eagle Rescue Squad is actively seeking new volunteers. You will have the opportunity to make a difference in someone's life. Company 1 might be the right opportunity for you. I would also like to point out to anyone who may be interested in the medical field; the experiences you gain here will be with you throughout your entire career.

Capt. Brian Mistrette and the members of co. # 1 have been working with Chief Jack Sweezy on the paid Little Falls Ems program. As a team we have come far with this program and are looking to have this service in place for the 2016 year.

2. Eagle Rescue Squad has put on 4 new members this year. Of our 7 new members, 4 already had obtained their EMT certification. 5 of our members are currently enrolled in the fire class and should be

graduating this year. Our members continue to obtain and maintain their EMT and CPR certifications as per the New Jersey Department of Health and Senior Services. Many of our members have also attended outside classes to maintain their certifications and further their education. Some of our members went on to acquire their firefighter 1, firefighter 2, or other advanced certification.

### 3. Recommendations

My biggest recommendation for the 2016 fire year is that Eagle Rescue Squad continue to recruit new members. The 7 new members that were put on this past year are already making an instant impact on improving our service. Along with our new members, Company 1 is also improving with the assistance from other Department members helping out at the Squad and driving. I am recommending that more members of the Fire Department continue to show interest and get involved with the squad. If our company can keep building the roster, especially with residents from within the Township of Little Falls, and get the help from members on other companies, our service will continue to advance.

Additionally, our ambulances are due to be replaced. Both were serviced earlier this year. The rigs are now eight years old and they are really showing their wear and tear. By preparing to replace the ambulances, the Township will save money in the cost of repairs as well as the down time for aging equipment in the future.

5. Acknowledgements, Capt. Brian Mistrette and the members of co. #1 would like to extend our great thanks to the Little Falls Police Department. The police Department do a significant role on Ems calls as first responders with out there held co.1 would have a much harder job to do when showing up on calls.

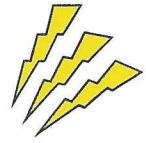

Please accept the following as the 2015 yearend report for the Township of Little Falls Municipal Fire Alarm System.

Various fire alarm system maintenance tasks were performed throughout the year. These tasks included repainting and refurbishing street boxes, transferring our lines to new poles Public Service has placed throughout the town, and performing regular voltage monitoring of all three circuits.

New C-Wire has been acquired and will be scheduled to be installed on Long Hill Rd and Cedar Grove Rd. Public Service has placed approximately 22 new poles along Long Hill Rd in between Notch Rd and Lower Notch Rd. The fire alarm crew will transfer our lines to the new poles in the upcoming months. Two pull boxes will also need to be transferred.

The Digitize System 3505 alarm monitoring computer is need of replacement. Attached to this report is further information regarding its replacement. I am very proud to report that Little Falls Municipal Fire Alarm system was fully operational 365 days of the 2015 fire year.
